## STATEMENT OF CHANGES IN ACTIVITIES and SOURCES OF FINANCING \*

The City of Warrenton budget, approved by the budget committee, shows an overall total increase in requirements from the prior year of \$5,604,206. This is due to increases in capital outlay, transfers, contingency and ending fund balance in the amount of \$5,871,546 with a reduction in personnel service, materials and services and debt service in the amount of \$267,340, resulting in a total net change from the prior year of \$5,604,206. The City can spend \$9,309,523 in capital outlay on equipment an city projects such as a police vehichle, fire engine, fire scba, dredging, street improvements, the Hammond water line and other water improvements, sewer pump station upgrades, and recyling center upgrades. A copy of the Capital Improvement Program summarizing the details of these projects can be obtained at the city's website (ci.warrenton.or.us). FTEs decreased by 1 due to elimination of a marina position. Wages allow for 1% cola increase. Debt service payments have decreased by \$50.02 No increases are proposed for water, sewer, or storm water rates in the approved budget
