Wait! Don't plant those seeds yet

If you receive unexpected seeds in the mail from an unknown source, do not to plant them, the Oregon Department of Agriculture warns.

"We are aware of reports of people getting seeds in the mail from China, often labeled as jewelry, that they did not order," an agency press release states. "Unsolicited seeds could be invasive, introduce diseases to local plants, or be harmful to livestock."

The seeds have been shipped nationwide and ODA is coordinating with federal authorities in responding to the problem.

If you receive a shipment that is suspicious, do not open it. If you already have, place the entire package in a plastic bag, seal it and send it to the Oregon Department of Agriculture, Plant Protection and Conservation Area, 635 Capitol St. N.E., Suite 100, Salem, OR 97301.
