liams had made an issue of Poe's wife's support of Black Lives Matter.

Opponent Berry accused him on Facebook of removing signs and cheating to win. He also blamed the county for interfering in the election by making his campfire wood sales an issue.

"They accused me of all kinds of misdeeds and bad stuff," Poe said. "Every time there was a challenge, whether with the signs or in the interviews, I dealt with it. I spent time with the writeups and voter pamphlets. My wife was an English major, so she helped me a lot."

Poe's top issues are Warrenton's growth rate, infrastructure and finances, city government transparency. and citizen involvement.

He plans to listen a lot after taking his seat on the board and form good relationships before pushing any agenda items.

"Already I have good relationships with all those people," he said of the commissioners. "I'm

going to try to gain their respect rather than push anybody's buttons the wrong way. I've been around some pretty rough people working on boats my whole life. I'm not intimidated, but I know how to keep my head down."

Poe will have to give up his seat on the Urban Renewal Advisory Board, but he'll continue as a commissioner to work with the Hammond Marina Task Force and the city's finance committee.

Clatsop County had an impressive 79 percent voter turnout. While most of the ballots had been counted Wednesday, county elections workers have until Nov. 12 to sort out ballots with missing or nonmatching signatures and other issues.

Election results must be certified by Nov. 23.

#### OTHER COUNTY RACES

In Astoria, Tom Brownson had won 54 percent of the votes against challenger Floyd Holcom in Ward 2. Lisa Morley and Thomas Hilton were just two votes apart Wednesday for the Ward 4 seat.

In Gearhart's contested races, Reita Fackerell had a 61 percent lead over challenger Bob Shortman for Position 2. Dan Jesse received 65 percent of the vote against Jack Zimmerman for Position 4.

In Seaside, David Posalski was winning the Ward 4 seat over challengers Kathy Kleczek and Adam Wood.

#### STATE RACES

Tillamook Mayor Suzanne Weber won the state House of Representatives District 32 seat vacated

by Tiffiny Mitchell.

It was a hard-fought win for the Republican, with plenty of partisan spending on both

"While it didn't go our way, I am humbled and honored by the immense support I have received throughout this campaign," wrote Democrat Debbie Boothe-Schmidt of Warrenton on her campaign's Facebook page. "Congratulations Suzanne Weber for becoming our new state representative."

In other statewide races, State Treasurer Tobias Read and Attorney General Ellen Rosenblum, both Democrats, will hold on to their posts. Democrat Shemia Fagan will become the new Secretary of State.

A state measure to increase taxes on cigarettes, cigars, e-cigarettes and vaping devices was approved. Also approved were measures to use psilocybin for medical treatment, and marijuana taxes for addiction recovery programs.

#### FEDERAL RACES

Democrat Incumbent Jeff Merkley will retain his seat in the U.S. Senate after receiving 58 percent of the vote against Republican challenger Jo Rae Perkins.

Democrat Incumbent Suzanne Bonamici received 65 percent of the vote against Republican competitor Christopher Christensen for a fifth term in the House of Representatives for 1st District.
