Interim health director a face from the past

A familiar face is stepping into the top post at the Clatsop County Public Health Department.

Margo Lalich has been tapped to serve as interim director of the department following the departure of Michael McNickle, who is leaving to head the health department in Gray's Harbor County, Wash.

She begins the job March 1. She previously served with Clatsop County Public Health for 15 years beginning in 1998, when she joined as a public health nurse. She coordinated public health programs including the county's HIV/ AIDS case management, immunization, WIC, and other

services.

Next, she served as the lead public health preparedness coordinator. And in 2009, she was selected as Public Health director and held that position until 2013.

In addition to her work with Clatsop

County, Lalich also worked as a nurse for Providence Seaside Hospital from 1992 to 2002. Following her tenure with Clatsop County, she served as director of health services for the Multnomah Educational Service District until 2017, and most recently held a contract position as executive director of Hawai'i Keiki,

a program developed by the University of Hawaii School of Nursing and Dental Hygiene.

Lalich also served as a humanitarian response nurse for Medical Teams International of Port-

land and did tours in Africa, Asia and Europe.

"Cannon Beach and Clatsop County are home to me," she said. "I look forward to supporting public health and working with community partners to ensure a smooth transition while continuing an effective response to the pandemic."

The county plans to launch a search for a permanent replacement for McNickle shortly. The Public Health Department has a staff of 25 and an annual budget of \$4.1 million.

It provides a range of services including maternal and child health, immunizations, reproductive health, communicable disease response and environmental health.

The department has led the local COVID-19 pandemic response with case investigations, contact tracing and testing, and is working in partnership with Columbia Memorial Hospital and Providence Seaside Hospital on vaccine distribution.

The third and fourth crew members, one pulled from the water and one who'd climbed onto the jetty rocks, were treated at Adventist Health Tillamook Hospital.

Friends of both men who died have set up separate Go-FundMe pages to raise money for the families.

As of Wednesday, \$56,000 had been raised for Angie Chase and sons Zach, Cord, Bowen and Brayden. About \$12,000 had been raised for Zappone's partner, Darby Workman.

Chase had been a fisherman since he was a teenager and ran Chase & Sons Home Improvement, a local construction company.
