ing," according to an Astoria Police press release. "The same male suspect was seen on video footage at both of the restaurants he entered."

The next morning, a burglar alarm went off at Warrenton Liquor Store at 4:07 a.m.

"An officer arrived shortly thereafter to find the break-in and other break-ins," Workman said.

Businesses reporting damage were El Catrin Restaurant, Kiosco Mexicano 2 grocery, Harbor Street Cigarettes, and Warrenton Liquor

Store.

Later that morning, break-ins were reported at Uptown Café and O'Reilly's Auto Parts.

All of the cases remain under investigation; Workman did not have a list or dollar amount for the Warrenton burglaries Wednesday afternoon.
