He'd also like to see a code enforcement officer, but not in place of a sworn police officer.

"I envision a code compliance position that would handle nuisance complaints, parking complaints, camping complaints, animal complaints, (and) non-building inspector code violations," he wrote.

He'd like to see the position shared by the police and building and planning departments.

Engbretson suggested every city department share the costs of both the human resources manager and the code compliance officer.

Other goals at the mid-year mark include aggressively pursuing new revenue opportunities, improved communications, and finishing unfinished projects.

• New revenue: The fee structure for fire permits, some police services, camping and marina use, and false-alarm calls have been revised. A permit fee for RV use in the city is in the works. Commissioner Rick Newton suggested fees for rental inspections and home occupancy permits be reviewed next.

In addition to fees, the parks advisory committee

came up with some revenue ideas such as the sponsorship of benches, and the Public Works Department is working with local jurisdictions to make improvements at the treatment plant so it can charge other agencies to treat organic materials such as porta-potty and septic waste.

More public-private partnerships at the city's two marinas could also bring in funds.

- Improved communication with the public: Warrenton Community Library has taken large steps through social media, the fire chief held a webinar on burn restrictions, various city departments will be writing articles for The Columbia Press, and future city newsletters and fliers will provide information on city projects, rent increases, and maintenance.
- Unfinished projects: Two long-awaited projects are under way -- the Hammond waterline and sidewalks from downtown to Warrenton High School.

Man with rifle shot by deputy

A sheriff's deputy is on paid administrative leave after shooting an armed man who threatened officers, according to the Lincoln County Sheriff's Office.
