# COVID boosters offered by county

Clatsop County now offers booster doses of the Pfizer vaccine to eligible individuals. The shots are authorized for those 65 and older, those 50-64 with underlying medical conditions, and those living in long-term care facilities.

Also authorized are those 18 to 64 with underlying medical conditions who are at higher risk of exposure to COVID-19 due to where they live or work.

Currently only people who have received the Pfizer vaccine are eligible.
