Local art groups win small awards

Seven local organizations are recipients of small grants issued by the Oregon Arts Commission for 2022.

More than 100 organizations statewide received \$2,178, slightly more than twice the amount awarded in 2021.

The local groups are Astoria Arts and Movement Center, Astoria Visual Arts, Cascadia Concert Opera, North Coast Chorale, Partners for the PAC, Tolovana Arts Colony in Cannon Beach, and Hoffman Center for the Arts in Manzanita.

Small grants often make

a large difference in ensuring arts access for Oregonians, especially in rural areas, according to the commission.

Small Operating Grants are designed to provide support to arts organizations with budgets under \$150,000.

Eligibility is limited to nonprofit organizations.

The Arts Commission is supported with general funds appropriated by the Oregon legislature and with federal funds from the National Endowment for the Arts as well as funds from the Oregon Cultural Trust.
