

of Cannon Beach, ensuring plenty of emergency coverage in north and south parts of the county.

The vehicle remains the property of the Oregon Office of Emergency Management, but will be insured by the city, and housed and maintained by the Warrenton Fire Department. The city must share the vehicle with other areas in times of emergency.

"We're on hook to maintain and use it," Alsbury said. "We will be able to use it for

whatever we want ... just as long as that vehicle is available when the state calls and says the vehicle is needed in Florence or wherever."

The high axles allow access to areas that are difficult to reach with current fire and police emergency vehicles.

The wild areas between the beach and Ridge Road are especially vulnerable, Alsbury said.

"It seems like every year we're drier and drier. I want to bolster the city's defenses on that issue so we have all the correct and appropriate tools." department

picked up the vehicle last week and took it on some test runs along the beach and through Strawberry Knoll, an unapproved beach access off De-

"In any size of tsunami, the majority of the city -- including dozens of residential neighborhoods -- will be inundated with water," Police Chief Mathew Workman wrote in the grant request submitted before Alsbury became fire chief. "This type of vehicle will allow us to perform rescue operations in those areas."

During an earthquake, thousands of trees and utility poles could topple, preventing standard-axle vehicles from getting to some areas to perform rescue operations, Workman wrote.

Warrenton has been applying for grants "like crazy," Alsbury said.

Another wildland vehicle is sought through the Federal Emergency Management Agency and the department has applied for a SAFER (Staffing for Adequate Fire and Emergency Response) grant that would be used to hire a fire marshal to help with business safety inspections and more.
