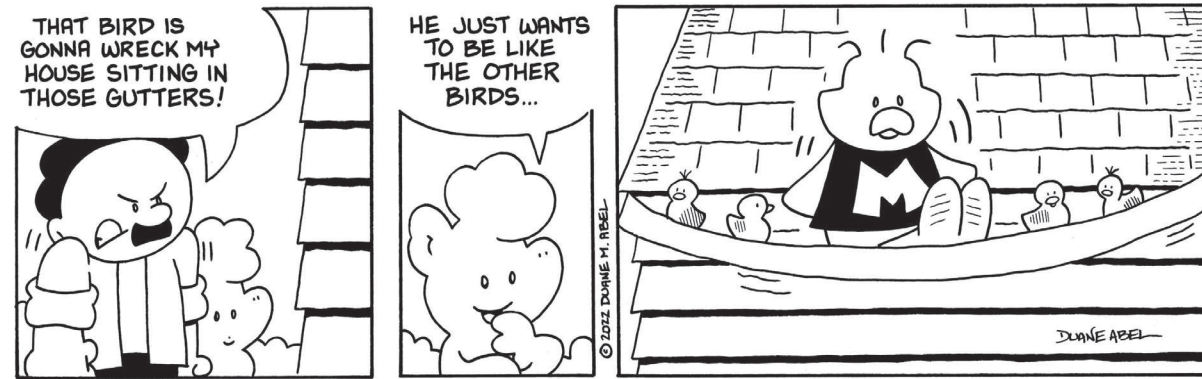

Oregon is getting ready to welcome athletes, coaches, and fans from across the globe during this summer's World

Athletics Championships.
