The 4th was cool and cloudy. Everyone pronounced it a fine day for a general good time and seemed to act accordingly.

The Wines mine on the head of Jump off Joe creek was sold last week to a party of Portland capitalists who intend opening the same at once.

Wm. Naucke of Kerbyville, ships his goods from San Francisco, via Yaquina Bay. He says he gets them a shade cheaper from San Francisco by that route than he can from Portland.

Ennis & Simmons, near Waldo, made more cut last year than they expected to. They have put in sixty-four boxes of twelve feet each. This claim, when fully developed, will be a gigantic affair as compared to the sluice box era of the past.

Work on J. W. Howard & Co.'s new brick is nearing completion. This building is built of brick made at home, and all the material used is home production is a credit to our little town and bespeaks the public spirit and enterprise of the firm.

The service on the daily stage line as far as Waldo seems to be good enough for summer travel, but the attempt to carry it from Waldo to Smith River Postoffice, a distance of 52 miles without change of animals, will undoubtedly prove a failure.

Mrs. A. N. Jones, postmistress at Wilderville in company with Mrs. P. Haskill of the same place, and Mrs. Bowen of San Francisco, sister of Mrs. Haskill, called at the COURIER office Wednesday. We appreciate the kind attention of those noted ladies.

Albert Smith, the young man who had his arm broken while skating at the rink several weeks ago, is improving rapidly, and will soon be able to be at his post of duty again as screw turner for the S. P. D. & L. Co.'s mill. Al says walking is slower, but much safer and cheaper than skating.

The ball at Kerbyville on the 5th was a pleasant affair. Mrs. Ryder gave an excellent supper. Near forty tickets were sold. The writer had the pleasure of holding ticket No. 20, getting value received for all it cost. Further mention of our trip through the southern and western portion of the country will be deferred until next week.

The most attractive feature of the exercises on the 4th, was the Liberty car, drawn by four white horses and beautifully decorated with gay ribbons, flowers and the bright and happy faces of thirty-eight little girls, who represented the thirty-eight states of the Union, presided over by the goddess of liberty holding aloft the Stars and Stripes.

It is reported that school superintendent, A. J. Chapman, of this county died at Kerbyville Tuesday morning. Mr. Chapman was elected school superintendent at the late election—having held that office the past two years—and was about to be sworn into office again. He has been as good a superintendent as the county ever had, and we regret the counties loss in his death.

We have examined the timbers for both the Applegate and Rogue river bridges. The timber for the Applegate bridge is the finest we have seen in the country, while that for the bridge at this place is far above average in quality. Excepting a very few pieces it is an excellent lot of timber. The contractor authorized commissioner Payne to put a cross on any stick he did not want.

F. A. Davis of Grave creek, was in attendance at the county court on Tuesday last, and made his final return as administrator of the Neagle estate. It will be remembered that old man Neagle, a poor defenseless old man, was murdered several years ago in his bed at Grave creek, and his store burned. Whoever committed the foul deed made good their escape. The crime is still shrouded in mystery.

On Friday, July 2d, just as the clock struck two, the soul of Finley Sneed passed out of the body upon its flight into eternity. Mr. Sneed was seventy-six years of age at the time of his death, was a resident of Murtle creek, Douglas county, and uncle of Geo. Neel of Grant's Pass, at whose house he died. Mr. Sneed had been in feeble health for a long time, and his death was not a surprise to his friends and relatives.

We have just heard that Pat McMahon of Jacksonville, died at that place a few days ago, and was buried on the 4th inst. It is said his spirit passed away as soon as he had concluded all the services on his many mail contracts. It is also reported that while the funeral procession bearing Mr. McMahon was passing the residence of Ad. Helms the spirit of that gentleman also fled to "that bourne from whence no traveler returns."

Work was begun on the Rogue river bridge on the 6th and will be pushed through as rapidly as the iron frame work can be received. In a few days work will also be begun on the Applegate bridge. These bridges will be a vast benefit and convenience to the county, and our worthy representatives Messrs. Miller and Porter, deserve great credit for the passage of the bill making the appropriation. Let us not forget the estimate nor forget the valuable services rendered by our public servants.

On Sunday Is at Gold Hill, Jackson county, Mr. B. W. Riggs and Miss E. L. Ramage, residents of this place, were united in the holy bonds of matrimony. Mr. Riggs is a skillful young mechanic, and holds a responsible position in the S. P. D. & L. Co.'s factory. Miss Ramage is the daughter of our fellow townsmen, M. M. Ramage, and is one of the favorites in the society of our little city. Wess, old boy, the COURIER offers its congratulations and wishes you and your fair lady a long life of happiness. On Monday the 5th inst., the following newly elected officers of this county were sworn in, and at once assumed the duties of their respective offices: County Judge, Volney Colvig; County Clerk, C. K. Chanslor; Sheriff, T. G. Patterson; County Commissioners, J. M. Payne, S. Messenger; Treasurer, J. W. Howard; Surveyor, W. N. Saunders. The people could not have elected a better corps of officers to manage the public affairs of Josephine county than the gentlemen above named. They are well qualified to transact the responsible duties of their offices. So let us, the people of the county, extend to them our hearty co-operation, and instead of putting stumbling blocks in their way, let us give them a helping hand. The trials of a public servant are not sufficiently appreciated by the people. This hard to please every one. The COURIER says to them all God-speed, and may flowers of success instead of the thorns of dissatisfaction and failure strew their pathway.

The "ramrod" of the COURIER had the pleasure of a seat in one of the wagons which left Waldo last Sunday the 4th, for a private picnic on the banks of the golden Illinois river. There were twenty of us all told who enjoyed swinging, fishing,

picking berries, eating dead chicken and gossiping about our neighbors. The yeas and nays decided that we should deliver the oration, so resting our elbow on the ground about an inch from a great pie, two big cakes, a bottle of pickles, and two bits worth of candy, we unbuttoned our collar, and spoke as follows: "Fellow citizens, ladies and gentlemen—In the course of human events it becomes our duty to address you on this auspicious and suspicious occasion. This hundred and tenth anniversary of American independence reminds us that our brave ancestors are entitled to much praise at our hands to-day. They fought the battles of the revolution; they settled up and civilized the 38 great states of this union; they swept westward, conquering and killing Indians, until none are left. All this was accomplished, and these great battles were fought with slings, flintlock muskets and plow shears, while we propose to fight greater battles here to-day with roast chicken, custard pie, fruit cake and molasses candy.

The celebration of American independence passed off pleasantly to all those who spent the day in this little city. Clouds overspread the sky during the day, and in the forenoon enough rain fell to lay the top dust. The atmosphere was cool and invigorating. All nature seemed to conspire to make the day enjoyable. The procession started from the Music hall at 10:30 o'clock, led by the liberty car, drawn by four white horses gayly decorated with flags and ribbons and driven with great equestrian skill by Fred Wall. The car was filled, not like the Trojan horse, with armed men, but with thirty eight beautiful little girls, representing the thirty-eight states of the Union, and presided over by the goddess of liberty, who held aloft the Union flag. No more beautiful sight could be found than this car, as it passed through the streets, flags and gay ribbons flying in the air, and loaded with its precious freight of innocence. Marshalls J. C. Moss and R. R. Morris marched the procession down Fifth street, down Main, and back to Sixth to the grounds, where it disbanded. The band took its place on the right of the stand and the boys seemed to try to over-capt themselves, for they rendered we think some of the best music we have yet heard from them. The next on the programme the children sang in a charmingly clear and artless manner the "Star Spangled Banner."

Rev. J. A. Freasure next offered prayer. Hon. A. A. Porter then introduced to the audience, Prof. H. L. Benson, who read the declaration of independence in a clear ringing voice, which was heard to the very limits of the large crowd of upturned faces. Mr. Porter then introduced Judge Brower, the orator of the day, who addressed the audience in an able speech of an hour's length upon the duties of an American citizen, after which there was music by the band: a song by the school children, the benediction by Mr. Freasure, and the large crowd dispersed to the miscellaneous pleasures of the day: some to swinging, some to skate, some to dance, and some paired off, to walk in the cool shadow of the murmuring pines, with light steps and happy hearts. In the evening the band boys gave a minstrel show in the Music hall, which was packed to overflowing. The boys gave what would have been a very interesting entertainment had the crowd kept order and given them the proper attention, but the evening was warm, and the large crowd of young people were eager for the giddy mazes of the dance.

At last the hall was cleared, the band struck up a lively tune and a hundred hearts beat more lightly and a hundred pairs of feet kept time to the inspiring music. After several hours dancing J. B. Hutch, the accommodating proprietor of the Central hotel, served an elegant lunch which refreshed the dancers, giving them new life and energy. Not until the early morn was tinged with the rosy hues of the rising sun, did the revelers seek the peace and quiet of their beds, to dream of the many pleasures of the preceding day. Thus ended one of the pleasantest days in the history of our town. All seemed to enter into the spirit of the occasion with a full determination to have a good time, and if there were any who did not enjoy the day it must have been their own fault.

The band boys deserve great credit for their management. The festivities of the day were gotten up and conducted by them under many disadvantages. The celebration was a success and will long be remembered by those who were fortunate enough to attend. The boys have every reason to feel well satisfied with the result of the day's festivities, and Grant's Pass every reason to feel proud of her band boys. Still They Come.

Subscriptions are pouring into the coffers of the COURIER at a pleasing rate. From Althouse.

(Continued from last week.)

The next company below the Ghiradelli Bros. is Peter Klyne and James Thompson. They are hard at work cleaning up, but as they have not informed us how their ground is panning out this season, I can only surmise by their smiling faces that they are making wages. Johnny Ghiradelli is working just below the Kline Co. on the bar, with what success I do not know, but I see that he has a nice garden and his visits look first rate. Joseph Trimble is still at work on his old claim cleaning up before giving possession to the new company. Nels Johnson is at work on his old point since the water gave out at Waldo. There is a company of Chinamen at work on the right hand fork, and it does seem strange that this part of Althouse creek has no charms for the white miners, but so it was in the early days, they followed the coarse gold up about two miles and then it suddenly gave out. Few if any white men have worked to any extent since that time. The gold must be in the hills or on a high bar, it could not have given out so suddenly otherwise. On Peter Hansen's old claim there are two companies of Chinamen at work on the upper bar and one in the main creek. This place has been worked over and over, and still they appear to find pay. We now come to James Turnbull, who is still pushing his tunnel ahead. There is some good pay in this claim, but the tunnel is either too low, or the bed rock too high to permit him to get the full quantity of pay gravel, much of which he has to leave over head. Henry Drew's is the next and adjoining claim to Turnbull's. Drew does not enjoy very good health, in fact he is like a good many other old miners, worked down almost to the bedrock, therefore he has to husband his strength and work short hours; nevertheless he manages to take out some very pretty dust. On the east side of the creek just below Drew's is McLaughlan's claim, worked with a ditch and ground-sluice. I do not know how this claim pays, but as the gentleman seems to be enjoying good health, and is supplied with the good things of this life, and does not complain, I presume he is all O. K. We now come to the Hansen and Elman claim at the mouth of the run. This company are busy cleaning up, and they will be very lucky if they get through before the water gives out, but their prospects are favorable. The Felt & Co.'s claim is dry. Felt is still quite unwell. Barnett is over on Indian creek. The old man on Red point is bringing in a ditch to the mouth of his tunnel shute. The Chinamen at what was once Brown Town have about worked the whole place out, and what was once the prettiest spot on the creek, is now a rocky unsightly desert. One more mill and the last house of the once lively village of Brown Town will pass away. This is the last mining camp on the creek. Caesar diggings and Walker gulch are dried up for the season; some of the men are out prospecting, while others are working in the harvest fields in the valley. On Sucker creek McLaughlan and Crabtree are drifting on the east side of the right hand fork, with favorable pay. The California boys, R. Crosby and Jas. Doyle, are pushing their breast ahead with fair success. I have not seen James Turner for some time, but hear that he is enjoying good health and is prospecting a good piece of ground. Jos. Nixon is hard at work on his old claim, with what success, I am unable to say.

Across the mountain Barnett, Dickey, Richardson, Davis, Speese and Snore are taking advantage of the water and pushing the dirt off at a lively rate. Wippolot and partner, Jewell, are cleaning up with favorable results. The past winter and spring has not been all of a success to our miners, yet they are hopeful for the future, and many of them are already making preparations for the winter of 87—better luck next time is the word. Try, try again; onward and upward is the watchword of financial success in every occupation or calling in life. PROSPECTOR.
