EDITORIAL NOTES AND NEWS. The California legislature is said to be a very extravagant one.

There is a bare probability that Idaho Territory may be annexed to Oregon.

What do you think of a bill declaring the first Saturday in June a public holiday to be known as "Labor Day"? Its author ought to be greased, loaded into a smooth bored cannon and shot against the side of the house.

The citizens of Linkville and surrounding country, are agitating a wagon road down the Klamath river to the line of the railroad. About \$1500 have been raised for that purpose. We prefer to see Southern Oregon retain this trade.

Governor Penoyer vetoed the Portland water and bridge bills. The Senate passed the bridge bill over the Governor's veto, but the House refused to do so. The Oregonian claims that the people of Portland are very indignant toward the Governor, on account of the interposition.

Sullivan, it will be remembered, in his recent fight with one Cardiff in Minnesota received a blow which broke his arm. The arm having been set palm down had to be re-broken and reset a few days ago which caused his beefship to faint. Verily he struck a regular Cardiff giant.

We find upon examining the list of bills hanging upon the hooks in our office which have been introduced in the legislature at its present session that there is but one opportunity left for a bill. So far no bill has been introduced regulating snake bites. Watts come nearer to it than any of the members. Everything else has been regulated, why don't they regulate that? Delays are dangerous.

The many meritorious bills introduced by Miller and the promptness with which he meets hard work in the legislature, and his good standing as a member of that intelligent body, is a compliment to him. Our exchanges give him a front rank as a legislator. His Republican constituency in Grants Pass ought to sustain him. Come now, gentlemen, be reasonable, and admit the facts.

On Sunday, Jan. 30, Prof. T. S. Baldwin made a balloon ascension from Golden Gate Park, San Francisco. The crank went up 1000 feet. To the side of the balloon was a canvas parachute to which was attached a trapeze bar. This machine by inflation was to let the Prof. down to earth again easy enough to not crack him any worse. When 1000 feet high he grasped the bar and lit out. Women below screamed and the Prof. fell on a fence and broke several pickets. That is enough to make any fence owner scream.

The special holiday-in-June bill and the bill prohibiting the removal of books from the State library, are two real dude flowers. The holiday is on Saturday and it doesn't say a word about bug juice on that day. Is that "flung in"? So far as the books are concerned, there will have to be another act passed, requiring that all the contents of the books be printed on the outside cover, so that dudes can walk up to the shelves and by turning the books over with their canes, be enabled to know their contents without touching them. Provided this does not occur on the public holiday in June.

The Drain Echo, in a column and a half editorial on the Normal school question, among other things, says: "If a location in the extreme south is desired, Medford or Jacksonville would certainly be preferable, while Grants Pass would be far more central and better in every way than either of them."

Yes, Grants Pass is far enough south to locate a district Normal school, and our people would be most happy to have it located here. Our school has met with such marked success and rapid progress, that we are entitled to enter as a contestant for a Normal school, being fully assured that no better location could be found for it.

When one notes the filth throughout the business portion of Grants Pass, the defective drainage and consequent stagnation of water and takes into consideration the disease breeding tendencies of these two agencies he must surely be alarmed for the safety of the town. We have daily communication with all portions of the world, hence may at any time, and without a moments warning, have diphtheria, small-pox, or typhoid fever introduced in our midst to mow their swaths of death through our ranks, breaking up our schools and putting an indefinite end to all manner of society. There is filth enough in our town to breed bacteria in sufficient numbers to kill every child in the town and it is safe to say that an introduction of that dread disease, diphtheria, is all that is required which, once in the town would not leave it for a term of many years. Some of our reasons for wanting to incorporate the town are based upon this feature of the question: We know that something must be done to eradicate the town of its filth or there is going to be a harvest of doctor bills, misery and death in this little city one year of which would cost money enough to run the incorporate government, sick bills and all for ten years. Nor is this all. Our city is full of rickety stove pipes that threaten to burn it up in an hour which would not be allowed under a city government. We have no confidence whatever in private enterprise to correct all these evils. They may have been prevented with less private enterprise than would be necessary to correct them.

So far as the terms of the charter are concerned, we have preferred a charter with as few objections as possible, and one that would subserve the best interests of all but we clearly see the urgent necessity to incorporate and we are in favor of it first, last, and all the time.

A citizen of Ashland who went to Salem to examine the proposed charter for that city writes to the Tidings as follows: The charter as proposed provides that the council without the consent of the legal voters, could appropriate to the use of the city any water ditch, water right or privilege within the city, and could lease, sell or dispose of any of said property for the benefit of the city. The council, without the consent of the legal voters, could borrow money on the faith of the city, or loan the credit thereof, or both, for purely municipal purposes. They could, also without such consent, borrow such money to the extent of \$25,000.00. When the council desired to borrow money for the purpose of supplying the city with water, they could do so to the extent of \$20,000.00, provided an ordinance to that effect was first submitted to the voters and by them approved. But there is not, in said charter any provision prohibiting the council from borrowing money upon the faith and credit of the city to the extent of \$25,000.00 for any other purpose except the single one of supplying the city with water, nor is there any provision whereby the city council is prohibited from diverting the money so borrowed to any purpose to which they in their wisdom might see fit to divert it.

In comparing this proposition to the proposed Grants Pass charter, comment is unnecessary. Discussing bills introduced in the California legislature, reducing interest, the Chronicle wisely says: "Ever since California has been a State, the law of interest has been in effect what it now is under the code; that is, parties may agree in writing for the payment of any rate of interest, and it shall be allowed according to the terms of the agreement. There has never been any serious objection to this law, nor can there be. Hiring money is like hiring anything else. The man who wants it will get it as cheap as he can, and the man who has it will hire it as dear as he can. Land and houses and horses and ships are hired on that plan, and there is no reason why money should be treated any differently."

On the 14th Mrs. Leonard by invitation addressed the House urging the passage of the bill relating to dower rights. She could not be heard in the large assembly hall and the bill was again defeated.

Mossbackism is the bane of Oregon. It seems to be in the air, to be diffused like the germs of zymotic disease in the atmosphere, ready to seize upon any and all exposed to it, and at times, to develop into a pestilence, an epidemic of stubborn opposition to advancement in any direction. The constant cry is that "it will not pay" to do here what is done elsewhere; that "it can't be done"; that we must "send East" for this thing and that thing. So accustomed are we to this, that, ordinarily, we pay little heed to it.

BRIEF MENTION.

Hare's confiscating swamp land bill passed the House. Ere long San Francisco will absorb all the trade south of Roseburg. Portland favors the proposed O. R. & N. lease to the Union Pacific. Thomas A. Eddison, the great inventor is said to be dying of lung disease. The bill appropriating \$400,000 for the equipment of militia has become a law. The Daily Oregonian was 27 years old Feb. 3d. The West Shore is in its 13th year. The Dennison Paper Company of Mechanics Falls, Maine, has suspended. Liabilities, \$450,000. An iron bridge is to be immediately built across the Columbia river at Pasco, W. T. to cost \$1,000,000. Secretary Manning has resigned, his resignation to take effect upon the appointment and qualification of his successor. The Columbia River Paper Co. writes this office that their paper mills recently burned at LaCamas, W. T., will be rebuilt, and in operation about July 1st, 1887. Mr. C. Parker of California, says the Enterprise, proposes to erect two or three large size Parker patent quicksilver retorts at the Bonanza quicksilver mines near Oakland, Oregon, as soon as the weather will admit. A great ice gorge five miles long and 15 or 20 feet thick, exists at Lyons, Mich. The river runs through the middle of the streets. Stores have been flooded and the goods frozen in ice. Merchants can not reach their stores. Losses heavy. The Post says that in reply to an inquiry by Deputy Eymern in the landtag, as to whether war was probable, Bismark said: "You know quite as much as I do. We live in a state of peace, but look at the French preparations at building barracks, the position of Gen. Boulanger, the constant outcry of the French patriot league during sixteen years. Then consider what we have to fear from France."

St. Paul special dispatches to the Inter-Ocean, dated the 14th, say that the storm in Montana is assuming a serious phase. The thermometer ranges from 40 to 60° below zero. Snow is 8 feet deep on the level, while on the mountains it is so deep that great avalanches covering people, stock and all, are imminent. Travel is not possible except on snow shoes. It also says, should another protracted storm occur, it is believed that hundreds will succumb to its terrors. As it is, more people have frozen to death this winter than for twenty-five years.
