ORDINANCE NO. 1. An Ordinance Relating to Regulating and Licensing Bar Rooms.

BE IT ORDAINED by the Common Council of the Town of Grants Pass: SECTION 1. That it shall not be lawful for any person or persons to keep any Bar Room or drinking shop where spirits, malt or vinous liquors are kept and sold in quantities less than one gallon, within the corporate limits of the town of Grants Pass, unless such person or persons shall have first obtained a license in the manner hereinafter provided.

SECTION 2. Any person or persons applying for a license to keep a Bar Room where spirits, malt or vinous liquors are sold in quantities less than one gallon, shall pay to the Town of Grants Pass a fee of five dollars, and shall also pay to the Town of Grants Pass a fee of five dollars for each and every day said stove pipe, flue or chimney is used without the required repairs as above stated.

SECTION 3. In case any person shall be convicted in using such chimney, flue or stove pipe after being notified as above required by the Committee, without making the repairs ordered, the Committee shall cause the said repairs to be made, and the expense of such repairs and costs of suit may be collected by action brought before the Recorder.

SECTION 4. Any person or persons violating this Ordinance, or any provision thereof, on conviction thereof before the Recorder, shall be fined not less than five dollars nor more than twenty dollars for each offense, or imprisonment not to exceed ten days.

ORDINANCE NO. 2. An Ordinance Relating to Licensing Peddlers, Hawkers, Drags, Auctioneers, Shows and Exhibitions.

BE IT ORDAINED by the Common Council of the Town of Grants Pass: SECTION 1. That it shall not be lawful for any person or persons to hawk, or peddle any goods, wares or merchandise within the corporate limits of the town of Grants Pass, unless such person or persons shall have first obtained a license in the manner hereinafter provided.

SECTION 2. It shall not be lawful for any person or persons to hawk, or peddle any goods, wares or merchandise, at public sale, within the corporate limits of the town of Grants Pass, unless such person or persons shall have first obtained a license in the manner hereinafter provided.

SECTION 3. It shall not be lawful for any person or persons to exhibit within the corporate limits of the town of Grants Pass, any circus, caravan, side show, theatrical or other exhibition, show or concert, for the purpose of profit or gain, except shows concerts or any other entertainment given by the citizens of Grants Pass, or for a charitable or religious purpose, unless such person or persons shall have first obtained a license in the manner hereinafter provided.

SECTION 4. It shall not be lawful for any person or persons to exhibit within the corporate limits of the town of Grants Pass, any circus, caravan, side show, theatrical or other exhibition, show or concert, for the purpose of profit or gain, except shows concerts or any other entertainment given by the citizens of Grants Pass, or for a charitable or religious purpose, unless such person or persons shall have first obtained a license in the manner hereinafter provided.

SECTION 5. Any person or persons applying for a license as required by this Ordinance, shall pay to the Town Treasurer, the amount due for such license, and take a receipt therefor specifying the amount paid, the business intended to be pursued, and the length of time for which such license is to be issued.

SECTION 6. The presentation of such receipt to the Recorder, shall issue a license in accordance with the terms thereof.

SECTION 7. Every person applying for a license under the provisions of this Ordinance, shall pay to the Town Treasurer, the following sums, to-wit: For a license to peddle or hawk one or more days, Ten Dollars per day. For a license to run Drags or Express wagons for each Day or Express wagon, Ten Dollars per wagon.

For a license to act as Auctioneer, per day, Two Dollars. For a license to exhibit any Circus or Caravan, Twenty-five Dollars, for each side show, Five Dollars, for each theatrical or other exhibition, show or concert, Five Dollars.

SECTION 8. If any person or persons shall violate any of the provisions of this Ordinance, or engage in any business mentioned, or keep or exhibit any thing above mentioned, without first having obtained the license required, he shall, on conviction therefor before the Recorder, be fined not less than Five Dollars, nor more than Fifty Dollars, or be imprisoned not more than Twenty days.

ORDINANCE NO. 4. An Ordinance Relating to Chimneys and Flues.

BE IT ORDAINED by the Common Council of the Town of Grants Pass: SECTION 1. That every chimney or flue that may hereafter be built within the corporate limits of the town of Grants Pass, shall be built of good quality of brick or stone at least six inches in thickness, the bottom to be laid in good lime mortar plastered on the inside, and where passing through or near wood work, plastered on the outside. They shall be well secured and extend at least two feet below the ceiling of the room wherein the fire is to be made, where the same may be constructed on the side wall. Every stove pipe or flue passing through a ceiling or partition, shall be protected by a tin cylinder so as to be at least one inch from any wood work. Nostove pipes shall pass through the side wall, window or roof of any building except by the permission of the Committee on Fire and Water, which shall be given in writing. No stove pipe shall stand within eighteen inches of any wooden or cloth wall unless such wall is fully protected by tin or zinc plates. All stoves shall be protected by tin, zinc or brick, placed beneath the same to protect the floor.

SECTION 2. The Committee on Fire and Water shall at any time have the right to enter and examine any building within the town limits to discover violations of this ordinance, or to decide whether flues or chimneys heretofore built are sufficient by law and secure, or whether there be any stove pipes or pipes passing through any side walls, window or roof contrary to Sec. 1 of this ordinance, and if in the judgment of said Committee any chimney or flue shall be deemed unsafe, or if any stove pipe or pipes be found passing through any side wall, window or roof, it shall be the duty of the said Committee to immediately notify the owner, occupant or agent of the premises of that fact and order that the same be immediately repaired or removed. If the party or parties so interested and notified refuse or neglect to make the required alterations or removals, they shall in addition to the fine imposed for the violation of this ordinance, pay a further sum of one dollar per day for each and every day said stove pipe, flue or chimney is used without the required repairs as above stated.

SECTION 3. In case any person shall be convicted in using such chimney, flue or stove pipe after being notified as above required by the Committee, without making the repairs ordered, the Committee shall cause the said repairs to be made, and the expense of such repairs and costs of suit may be collected by action brought before the Recorder.

SECTION 4. Any person or persons violating this Ordinance, or any provision thereof, on conviction thereof before the Recorder, shall be fined not less than five dollars nor more than twenty dollars for each offense, or imprisonment not to exceed ten days.
