The big reel for the gold dredge Josephine arrived and was loaded on a wagon and started Wednesday for Waldo.

Rev. Skidmore of Oakland, was here Sunday attending the funeral services of Mrs. Booth. He occupied the pulpit at the Presbyterian church in the evening.

An unmounted gun passed through here on Monday morning's freight train. It was a monster, occupying the whole of a flat car. It is said to be intended for east defence at Astoria.

Alpheus Love, of Kansas City, who has been here for some time visiting with his brother, J. T. Love, left Monday morning on his return. He goes to California, where he will visit another brother, and afterwards will return to the East.

Attorneys Smith and Stewart went to Jacksonville, Monday, where the case of Levi H. Ferry vs the city of Grants Pass was argued before Judge Hanna. The plaintiff requested additional time to submit a brief, after which a decision will be rendered.

Mr. Horace Mann, formerly of Cottage Grove, has assumed control and management of the South Oregon Eye at Medford. Mr. Mann is well recommended as an experienced and capable newspaper man. He will enlarge the paper to eight pages and the name will be changed to the Medford Enquirer.

Mr. Anderson is another of the Southern Oregon pioneers who has passed away. He was one of Josephine county's best known and respected citizens. He has been in poor health for a long time, and has never recovered from injuries received in a runaway accident about a year and a half ago.

The supreme court rendered an important decision Monday in the case of First National Bank of Southern Oregon vs Lawrence Leonard and Mary E. Leonard. The question involved was the liability of a married woman who executes a mortgage, with her husband, containing a covenant to pay the debt, but does not sign the note. The supreme court had heretofore held that the wife was not liable, except to the extent of her dower interest in the land mortgaged, but this decision reverses the former ones and holds that the wife under the liberal laws of Oregon is liable upon her contracts as a single woman would be. In the circuit court the decision was in favor of Mrs. Leonard, and the bank appealed. The bank was represented by Robert G. Smith and the defendants by A. S. Hammond of Medford.

C. L. Johnson, lately of Colorado, has taken a two years bond and lease on the Lost Flat mine in Galice district, and intends to leave for that section in a few days, where he will proceed to develop that property. Some of the richest ore that Josephine county has produced has come from this place. When it was first discovered the ore was packed out on mules and shipped to Ashland, netting the owners a very large profit, and it had since been very profitably worked by means of an arrastra. Mr. Johnson intends to do thorough development work and to show it up as a mine of superlative excellence. There is just as rich ore there as ever came out of it and that is saying a good deal, for some of it carries thousands of dollars to the ton. Mr. Johnson sent a sample of the ore to Cripple Creek where it caused a good deal of comment in that region of famed richness. It was a piece about an inch square and about half an inch thick containing about six dollars worth of gold. Just how much that would be per ton, is a matter for some computation.

I. F. Toby, superintendent of the Oregon Children's Home society at Portland was in Grants Pass last week, and took two motherless children back with him to Portland, where good homes had been secured for them. This is a sample of the work which this society is doing all over the state.

Hammel and DeVarilla, who have a lease on the Sugar Pine mine at Galice, have recently struck the pay chute of that ledge which has been sought for by several miners without success. This ledge has produced richly in the past, and this finding of the pay chute in the lower tunnel will open another body of rich ore.

A. W. Sibley came down this week from the quartz mine near Jacksonville, where he has been working recently. He and his partner, Mr. Breeden, are developing a very promising quartz ledge in this section, and have sunk to a depth 90 feet, showing up a large body of high grade ore. The prospects are very encouraging, and Messrs Sibley and Breeden feel confident that they have a permanent quartz proposition of unusual excellence, and they are administering the treatment which is badly needed by many other promising ledges in this country, that of thorough development.

### Should be Enforced.

The S. P. depot officials report that the nuisance of boys jumping on moving freight cars is becoming serious. On Tuesday, Johnny Treflen escaped by only an inch from being crushed beneath the wheels of a car. There is an ordinance thoroughly covering this matter, but has not been enforced of late. The depot men say the boys must go behind the bars if they don't stop it.

### Election in Ashland.

A special election was held in Ashland Monday, called by the city council, to vote upon the question of licensing saloons. Quite an active canvass has been made against the issuance of licenses by the Anti-Saloon League. The weather was fair and pleasant, and a large vote was polled, resulting in a victory for license by a majority of 9 in a total vote of 511. The vote follows:

Under the city ordinance calling the election, the saloon license is placed at \$400 per annum.

### Joaquin Miller Coming.

The people of Grants Pass will, on February 21, have an opportunity to see and listen to the famous poet of the Sierras, Joaquin Miller, who will be here on that date on his lecturing tour. Miller is a world wide famous man, and belongs to his greatest, to Oregon. Many competent critics place Miller in the very front ranks of American poets, and it is certain that some of his poems are not surpassed in beauty by those of any other poet. The first part of his lecture is on "Lessons Not Found in Books," with readings from his poems. The second part, is on "Our Arctic Empire" in which the poet appears in the garb of an Arctic explorer. His lecture is varied and never tiresome, and full of interest to every one. Apart from his entertaining talk, the personality of the man is sufficient to insure him a large audience.

### Prohibition Convention.

The chairman and secretary of the Prohibition county central committee, have called a county convention to be held at Grants Pass on February 14th, at 7:30 P. M., for the purpose of placing a county ticket in the field. The convention will be held in the court house. E. O. Miller of Portland, field secretary of the Prohibition state executive committee, who is at present working in Jackson county, will be here at that time.

### Death of Mrs. Booth.

Mrs. Mary Booth, wife of Rev. Robt. Booth, of our city, passed away on Thursday last, at the residence of her son, J. H. Booth, in Roseburg, after an illness of about two days. Her husband and two daughters, Mrs. Keyes and Mrs. Victor Peterson, were with her at the time of her death. J. H. Booth, at whose home she died, was absent at the time in California, where his wife is seriously ill.

Mrs. Booth was taken ill on Tuesday, and a physician was called, who pronounced it pneumonia, but complications developed and the suddenness of her death was due to heart failure.

The remains were brought to this city on Friday evening's train, and the funeral services were held at the Newman M. E. church on Sunday morning at 11 o'clock. The church was filled to overflowing by those who had come to pay their last respects, and the ministers of the different churches and several visiting ministers participated in the funeral exercises.

The remains were taken for interment to the Masonic cemetery, whither they were attended by a large procession. Mrs. Booth was one of the pioneers of our state, having come here "across the plains" in 1852, and was one of that class of pioneers who have left such a deep impress of intelligence, ability and good citizenship in our state and have exerted a grand influence on its future destinies.
