

CRUSADE AGAINST HOUSE FLY

The crusade against the pestiferous house fly is going on in other cities and it's time that Grants Pass people took up the war of extermination and thereby prevent many cases of sickness which occur in the families of this city. Investigation will show that the fly is a dangerous insect, because he inoculates some of the most terrible diseases which occur among human beings. The city council will be well to take some steps leading to the making of a strong effort to fight the house fly in his favorite breeding places, such as filthy, back yards and insect stables, and in a hundred other places this work of extermination should be inaugurated.

No man in Grants Pass will appreciate the importance of such an effort more than our Mayor, Dr. J.

C. Smith. His profession gives him a knowledge of the evil and we hope that he will suggest to the council that something be done at once to rid the community of the house fly. The Ladies' Auxiliary has become interested in this warfare and the city council can well afford to come to the rescue at this particular time.

The campaign against the house fly has been taken up by some morning picture film companies and pictures showing typical breeding places of flies and how these insects carry tuberculosis germs is shown in a realistic manner which can not fail to impress even the most careless person who may be in the audience. That the fly is a carrier of disease is conceded by the highest authorities and there is almost wholesale danger to public health everywhere in a manner which permits flies to carry to a sick and prone they have collected elsewhere. Every woman should not only keep her home free from flies, but she should demand that her butcher and grocer keep the food she buys protected from flies and dust. Instead of displaying it openly on the sidewalk or counter, in New Orleans posters have been placed on the billboards warning against the fly as a disease spreader.

ENEMIES OF THE PEOPLE

The "hull and trust," a \$100,000,000 corporation, has been formed in New York with the avowed purpose of raising the price on all kinds of sanitary examined devices from 10 to 15 per cent. The new corporation also proposes to drive the manufacturers

of the small jobbers out of business. Sixteen manufacturing companies are in the deal and control 85 per cent of the total output. Thirty-two New York dealers have signed to buy from the "trust." Three hundred and thirty-seven jobbers throughout the United States were invited to "come in" while the water was warm. Of this number 110 signed to buy exclusively from the new corporation.

If there are no laws in the United States to control these enemies of the people it is high time that congress took the matter in hand so as to give protection to those who buy the manufactured articles in question. It remains to be seen if a \$100,000,000 corporation has the power to rob right and left without some legal check which can be interposed for the protection of its victims. We believe that there are already laws sufficient to stop these public robbers if enforced. Ex-President Roosevelt and President Taft have shown that the laws are sufficient when enforced to meet all emergencies and they should be invoked in this case.

THE IRRIGATION CONTRACT

We publish in this issue the full text of the contract between the Josephine County Irrigation and Power company and the Rogue River Irrigation and Power company. This contract is an important one as it interests a large number of people in this valley. Irrigation must for all time be the corner stone upon which we must build our future prosperity and therefore we must insist in securing water for the 30,000 acres of irrigable land which constitutes the real wealth in this section. Every land owner in the county whose property will come under these proposed ditches should carefully read this contract and be prepared to act promptly when opportunity is offered for securing water for his land. If the Rogue River Irrigation and Power company are to succeed in developing here a great irrigation enterprise they must have the help of those who own the broad acres which constitute our great agricultural wealth.

OUR NEW FISH WARDEN

The appointment of Edward Clanton, of this city, as master fish warden, is a credit to the appointing power for the very good reason that he has served faithfully in the position of deputy fish warden of the second district, having on all occasions been true to the best interests of the state. Mr. Clanton is one of our best citizens and the fact that his appointment gives satisfaction throughout his entire district is evidence of his fitness for the office to which he has been promoted. The position of master fish warden is an important one and it goes without saying that Mr. Clanton will honor the office.

WHERE WAY WILL HE GO?

The return of ex-President Roosevelt to this country after fifteen months absence will mark a new era in politics. The leading newspapers of the country are looking to Oregon to talk on political matters with the colored, but so far it has not transpired that the Hon. Truman and ex-president has made any sign which would indicate that he is either an insouciant or a regular in the political arena. It is said that he will not talk politics for the next two months, as we will be obliged to wait and see in the meantime for that length of time. The leading newspapers claim him and the regulars seem to feel a little uncertain as to what he may do or in politics when he does speak. The newspapers of the east claim that many newspapers have invited Roosevelt at the Greater Dan home and now sure is going the rounds about the politicians at the president's home is in the effect that the newspapers have come and went but not composed. We there are some equally positive claims that the regular voters toward the radical element is the republican party.

What may happen or what the president may see at the end of two months' rest, of course, is pure speculation. Should he go over to the mountains there may be trouble for the regular republican formation. President Taft and the regular will undoubtedly get together and talk over matters generally and appoint themselves a committee to look after the welfare of the grand old party. It must not be forgotten that Mr. Roosevelt is the political father of Mr. Taft and after a period of retirement for his political life, it is not his ability, it does not seem that he will ever go back on the map he occupied. Should Roosevelt become the leader of the movement, the political combination may become fatal. Should he turn his back on the men who have been voting with the Democrats, it is not improbable that the important cause will suffer.

DISGRACING THE FOURTH

The governor of California having driven the prize fighters, Jeffries and Johnson out of his state they have fled to Reno, Nev., where on Monday next the brutal contest will be waged. To say that a large portion of the people of the whole country are not interested in this fight would be mistating the facts. Some people believe that law honestly enforced can not prevent certain evils if there is a considerable party in favor of them. They always favor restrictive laws rather than prohibitory ones, but somehow or another many legislatures have passed laws prohibiting prize fighting and these have been effective. The state of Nevada is an exception. It is the one disreputable state in the Union and until a different class of people locate there and dominate politics it will continue to be what it is, a disgrace to the whole country. The governor of Nevada says that he is powerless to prevent this brutal encounter for the very good reason that the state has a law framed for the sole purpose of fostering prize fights and until that law is repealed the executive of the state is powerless to interfere.

California, like other states, has its percentage of men who are deeply interested in the prize ring and that particular element will be in Reno to see the disgusting exhibition that will disgrace our national holiday, but the executive of our sister state will have the satisfaction of having driven the sluggers and breakers beyond his borders. The people of other states may not object to having Nevada win laurels from being the prize fighter's friend.

S. O. MEDICAL ASSOCIATION HELD AT MEDFORD TUESDAY

The Southern Oregon Medical association was held at Medford Tuesday and the Grants Pass profession was represented by Drs. Finnagan, VanDyke, Smith, Stricker and Lemon. Dr. Finnagan read a paper entitled "Business Side of the Profession," which was well received by the assembly and was a credit to the doctor's ability, bringing out some extremely good points, which were thoroughly discussed by the medical men present. Another paper which caused much favorable comment was read by Dr. Houck, of Roseburg, entitled "Good Roads, Automobiles and the Doctor." There was a good attendance at the meeting of the association, much larger than would ordinarily have been, perhaps, owing to the fact that Wednesday, being the meeting day for the doctors of the State Board of Health, many of the state medical men were present on Tuesday and took part in the association. In addition to other important matters the question of medical education was brought up and thoroughly discussed, much interest being manifested in this subject. After the business session was over, the visitors were taken for an automobile ride by the Medford auto club and were shown all the interesting places in and about the little city and the day's proceedings were finished by a social banquet in the evening.
