Our Sermonette.

A peculiar people, zealous of good works. Titus 2: 14.

A 'peculiar people,' not peculiar in dress, nor in manners, nor in language, nor in foolish, senseless forms and idiosyncrasies; but peculiar in that it is separate from the world. It has the Spirit of Christ, a spirit of full consecration to the Lord, and separateness from the world and its selfish aims. It is peculiar in its adherence to the Word of the Lord as its only law. It is peculiar in that it rejects worldly wisdom when it conflicts with the Divine revelation. It is peculiar in that it is in the world but not of the world. It is peculiar in that it has a decided faith and acts in harmony with its faith, and with zeal. It is peculiar in that it is self sacrificing and knows no will but the will of its king. It is peculiar in that it knows the truth and is able to give a reason for the hope within, while others merely speculate and wonder and doubt.

Tax on Toilet Articles etc.

Under a recent ruling by the Treasury Department the tax on toilet preparations and patent and proprietary medicines is based upon the selling price of each article and not upon the total price of a number of articles. If a person buys five packages of 5 cent cough drops, a 1 cent stamp must be attached to each package. If a person purchases a tube of tooth paste for 35 cents and a bottle of perfume for 65 cents, a 2 cent stamp must be placed on the tooth paste and 3 cents on the perfume, a total of 5 cents. In other words, the tax is on each article and not on the combined purchase price.

This revokes a ruling previously made by the Department.

More About Good Roads.

The only thing in Oregon from which the tax payers derive any benefits without any cost to themselves is good roads, according to Chas Hall of Marshfield, president of the Oregon Chamber of Commerce, referring to the proposed constitutional amendment raising the state bonding limit from two to four per cent, to be voted upon May 21, at the primary election.

Good roads in one community inspire other communities to build them and greater efforts along the lines of advancement should be put in action at once. The automobile license fees and gasoline tax are sufficient to pay interest on and retire any bonds which may be issued under the proposed amendment, and the money from these bonds will attract federal aid, of which \$2,29,555 remains unclaimed, as all available funds are exhausted by being spent or contracted. In addition, whatever would be apportioned under the proposed bill before congress, which is sure to result in Oregon having the opportunity to claim more than \$5,000,000.00, would be lost. The cost of good roads to a farmer is easy to figure out, but the cost of bad roads to the same individual is hard to determine. A farmer living at Meadow Lake stated that bad roads cost him 10c a bushel to haul out his potato crop, which, of course, is ultimately paid by the consumer at his table. Never have the markets paid higher prices, and the farmers want to get their products to market to sell them.

2 cups flour
1/2 teaspoon salt

2 tablespoons shortening

Griddle Cakes with Eggs

1 1/2 cups flour
1/2 teaspoon salt

2 eggs
1 1/2 cups milk
1 tablespoon shortening
Mix and sift dry ingredients; add beaten eggs, milk and melted shortening; mix well. Bake immediately on hot griddle.

Buckwheat Cakes

2 cups buckwheat flour
1 cup flour
6 teaspoons Royal Baking Powder
1/4 teaspoon salt
2 1/2 cups milk or milk and water
1 tablespoon molasses
1 tablespoon shortening
Sift together flours, baking powder and salt; add liquid, molasses and melted shortening; beat three minutes. Bake on hot greased griddle.

Waffles

2 cups flour
4 teaspoons Royal Baking Powder
1/4 teaspoon salt
1 1/2 cups milk
2 eggs
1 tablespoon melted shortening
Sift flour, baking powder and salt together; add milk to yolks of eggs; mix thoroughly and add to dry ingredients; add melted shortening and mix in beaten whites of eggs. Bake in well greased hot waffle iron until brown. Serve hot with maple syrup. It should take about 1 1/2 minutes to bake each waffle.

The Shedd Jersey Calf Club.

That the Shedd Jersey Calf club is the best of its kind in the country, was the statement of M D Munn, president of the National Jersey Cattle club, in an address to the clubs on the occasion of the visit of the Jersey Jubilee people to the club.

He said that the young peo-

ple of the club will someday be the leading Jersey breeders of the state.

Ten minutes had been allotted for the stop of the Jubilee people but more than an hour was spent in inspecting the 30 calves, of which 15 are registered.

The members of the calf club were formed in a semi-circle near the school building and sang their club song to welcome the visitors. Each member stood beside his calf and after the

song eight of them gave in brief, short statements the history of the club, giving the time it was organized, the number that were enrolled at that time, the results of the club work last year, the number enrolled now and the plans for their future work.

The Shedd club was the only club in the northwest to win the \$75 prize given by the American Jersey Cattle Breeders' association last year, and they are working hard to win it this year.
