If .: to Entployees Are Not Deductible from Employers' Returns.

No Guesswork Allowed. Tax May Be Paid in Full or Divided

into Four Installments.

Only single persons whose net income for 1920 was less than \$1,000 and married persons living with husband or wife whose net income was less than \$2,000 are exempt from the requirement to file an income tax return.

The obligation to consider his own case and to file an income tax return on time, if one is due, is laid squarely on the shoulders of every resident of the United States. Guesswork is barred.
