Hogs—Top blockers, 110 to 150 pounds, 17c; Market steady.
Veal—Fancy, 80 to 110 pounds, 18 to 19c. Market shows signs of weakness.

Dressed poultry—Dry picked heavy hens, 80 to 31c; dry picked light hens, 25 to 26c; dry picked springs, 30c.

Turkeys—There is a good demand for Toms over 13 pounds at 45c. Fancy hens, 40 to 42c. Off grade turkeys not moving satisfactorily.

Fancy heavy capons, 28 to 40c.
Live poultry, net—Heavy, over 4 pounds, 26c; light hens 20 to 24c; springs 25c; old roosters 13c.

The state market agent's office reports that the general agricultural market outlook does not vary materially from that of a year ago. Corn, hay and beef have not been profitable. Potatoes, butter, eggs, wool and hogs have had fair markets.

The wheat crop of eastern and central Oregon looks promising for the latter part of year.

Shot the Cowards Who Tormented Him

Recently the Enterprise reported the killing of one person and the wounding of two more at Ingersoll, Okla., by C. E. Marble in reprisal for their having habitually used provoking language to him, stoned the shack in which he lived, stolen his fruit, etc.

In Oregon the use of tantalizing language lays the offender liable to arrest and fine or imprisonment under a law prohibiting conduct tending to provoke a breach of the peace. The insolence of cowardly "smart Alex" who find pleasure verbally abusing somebody whom they think unable to strike back at them, as in the case of Mr. Marble, sometimes yields them an unpleasant surprise.

Last Monday's Albany Democrat-Herald contained pictures of Mr. Marble and his shack at Ingersoll and the story, from which we reproduce the following paragraphs:

Marble was a good man, in his way, say his neighbors. That is a part of the pathos of it.

When a husband died, leaving his wife destitute, it was Marble who saved her groceries and chopped her wood.

When another family was freezing, one winter, Marble retrieved a worn-out stove from the dump yards, carted it to their place and set it up, with a goodly supply of wood.

When once an aged bachelor became sick and there was no one to nurse him Marble did the job.

"I intended to kill them all and myself," he said.
