## Petition Presented For Tunnel District

Fifty Autos In Procession To Hillsboro. Senator Joseph, Judge Tucker Both Are Present.

About fifty automobiles left Beaverton Monday morning at nine o'clock in a caravan which proceeded to Hillsboro and filed with the County Court the petition for the creation of Oregon Tunnel District No. One, with the view to constructing a tunnel from Portland to the Tuastin Valley. Senator Geo. Joseph of Multnomah, attorney for the petitioners, was present and in person presented the petition, which was accepted by the County Court of Washington County, E. J. Ward, Judge, F. W. Livermore and J. M. Hill, all Commissioners, and E. C. Luce, Clerk of the Court.

The petition authorized the County Court to call an election to submit the question to the people whether a tunnel district shall be formed, and authorized the making of preliminary plans and estimates for the tunnel.

County Judge Ward set September 9th as the date of a special election, when the question of the formation of the district will be submitted to the voters of both Multnomah and Washington Counties.

If the approval of the voters is given in this election, as the petitioners feel certain it will be, another election will be called and the question of voting a bond issue to cover the cost of the tunnel will be submitted to the property owners within the district.

A bond of four thousand dollars, which guarantees the expenses of the election to be held Sept. 9, was filed at the same time with the petition for the creation of the tunnel district.

About fifteen objectors to the petition, all living in two sections, near the north line of the proposed district, filed a remonstrance, but the petitioners agreed to leave those two sections out of the district, so the tunnel petition was accepted by the Court with that understanding.

### GRAIN INSPECTION AND CERTIFICATION

Those wishing grain fields inspected for certification for seed by the O. A. C. Extension Service should not wait until they are ready to harvest before notifying the county agent as notices must be received in advance to allow for time to arrange for schedules for the inspectors. It is not possible to secure inspectors on short notice as they have much territory to cover and must schedule their routes to reach the largest number of farms in all the state. Application may be made to the county agent at Hillsboro, Oregon.
