LOOKED CARS HINDER

THEFT. AVOID CRIME!

The crime wave and the auto theft wave ebb and flow together, according to Joe Keller, veteran police officer, and special agent in the auto theft bureau of the Pacific Coast auto underwriters' conference. "Criminals have discovered that autos are convenient for going to the scene of the crime, handy to carry loot, and of material aid in effecting escape. They have discovered further that cars are easy to steal and abandon, and that the pursuit is thrown off the scent in this manner.

"An unlocked car is one of the most potent temptations to crime for the stolen car plays a part in almost every violation of the criminal code which contributes to the headlines of the daily newspapers.

"There are too many cars parked along the street and the highway with the ignition key still in the lock, ready on the instant to make a getaway. "If the motorists would lock their cars, automobile theft would be practically eliminated from the police calendars. "Form the habit of locking ignition or transmission in an open car and doors and windows in a closed car. You'll be doing your part in crime prevention," said Keller.

As Mr. Keller is one of our prominent Beavertonians and is well versed in his specialty, the Review is pleased to have the opportunity to print this, one of the articles running in the Portland Telegram, on discouraging crimes.

Widespread sentiment in favor of a bill to compel motorists to provide insurance for the protection of persons physically injured in automobile accidents is growing up in Oregon and California, according to MacCormac Show, member of the Multnomah county bar, in an article published in the April issue of the Oregon Law Review.

In 1926, the automobile accident bill in the United States was in the neighborhood of 435 million dollars, of which about 315 million related to personal injuries and deaths. New uninsured automobile owners were financially responsible and bore part of the loss.

Last year's insurance premiums were distributed among injured persons and their families, investigators, paid witnesses, lawyers, court costs, miscellaneous expenses of litigation, overhead, commissions, reserves and profits.

The public in 1926 bore a large slice of the total bill in the form of taxation, free wards, clinics, medicine, medical attention, nursing and direct charity. A large part of the direct bill and practically all of the more remote damages from accidents fell upon the injured persons and their families.

"Men are coming to the belief that this distribution is unjust for three broad reasons," says Mr. Snow. "First, the public at large should not be penalized; secondly, the share falling on the victim and his family appears unjustly high; and thirdly, that falling upon the motorist appears unjustly low."

No state has yet attempted the solution of the problem, through compulsory insurance. But the state of Massachusetts has dedicated itself as an experimental laboratory for compulsory insurance of the liability type.

Offices a grower will wait until late in the season before making his application. It is difficult to get the inspector on short notice on account of the heavy demand for inspection during the potato growing season. The inspector makes his plans for trips several weeks in advance.

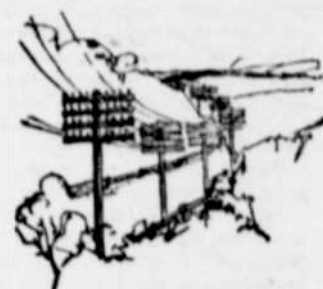
