FARM ACCOUNTING CONTEST LAUNCHED

Bankers Evolve Plan for Stimulating Important Aid to Farm Success

The Cache county, Utah, bankers recently added a stimulus to banker-farmer cooperative work by launching a farm accounting contest. At a meeting of the Clearing House Association of the Utah Bankers Association and the Agricultural Committee of the Utah Bankers Association.

The scoring will be done on the following basis: Farm and home account records (accurate and complete) . . . 50% Success of year's operations as brought out in the summary of the year's business . . . 25% General appearance of farm and improvements and condition of livestock and poultry, (judging to be done during the summer months) . . . 25% The contest will end December 31, 1933. The judges will be the County Agent, the County Key Banker, a representative of the Clearing House Association, and two representatives selected by the Extension Division of the College.

The banks of Cache county have agreed to subscribe to an award fund, which will be presented to five winners as follows: first prize, \$35.00; second prize, \$25.00; third prize, \$20.00; fourth prize, \$12.50; fifth prize, \$7.50.

Recognition for Good Farming In addition to the cash prizes, every farmer customer enrolled, who scores sixty per cent or more, will be awarded a special certificate issued by the Clearing House Association and the Extension Service jointly in cooperation with the Agricultural Committee of the Utah Bankers Association.

The scoring will be done on the following basis: Farm and home account records (accurate and complete) . . . 50% Success of year's operations as brought out in the summary of the year's business . . . 25% General appearance of farm and improvements and condition of livestock and poultry, (judging to be done during the summer months) . . . 25% The contest will end December 31, 1933. The judges will be the County Agent, the County Key Banker, a representative of the Clearing House Association, and two representatives selected by the Extension Division of the College.

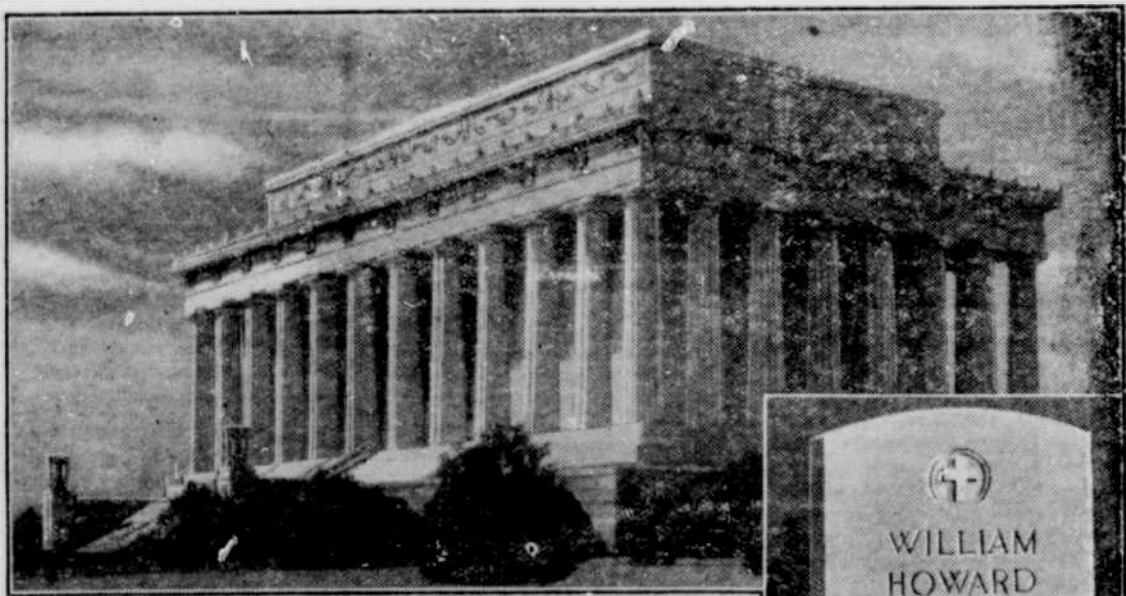

VARIOUS SUGGESTIONS ADVANCED FOR MEMORIAL FOR PRESIDENT COOLIDGE



Lincoln Memorial in Washington, D. C., constructed of Colorado marble. Eight, plain Vermont marble marker on grave of President Taft.

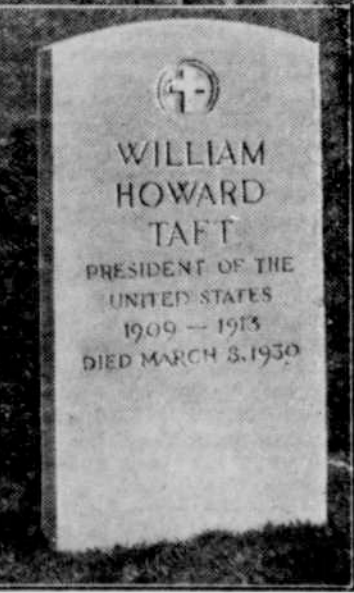
WHILE various suggestions are being advanced for the perpetuation of the memory of Calvin Coolidge in the marble of his native Vermont, the question has arisen as to the type of memorial that would be most appropriate.

Some would have a simple marble headstone, such as marks the grave of President Taft in Arlington National Cemetery. Others would erect a more pretentious memorial like the amphitheatre for President Harding in Marion, Ohio.

There is no precedent in this as there is in so many matters pertaining to the Presidency. Of the twenty-eight predecessors of Mr. Coolidge, three—the two Adams and Wilson—were entombed in church crypts. All the others were buried in graves or vaults. One was cremated. Six who served as President rest in Virginia. Washington lies in a marble sarcophagus in a simple to his estate, Mount Vernon. Taft is among the soldiers dead in Arlington, Jefferson was buried at Monticello,

Madison at Montpelier, and Monroe and Tyler at Richmond. Ohio, the "Mother of Presidents," claimed five of them in death. Harding was taken back to Marion, McKinley is buried at Canton, Garfield at Cleveland, Hayes at Fremont, and Harrison at North Bend. Five are buried in New York State. Grant's Tomb is on the Hudson in New York City, Van Buren was buried at Kinderhook, where a marble memorial was recently unveiled in his memory. Fillmore in Buffalo, Oyster Bay, and Roosevelt in Astor, New York.

Three presidents were buried in Tennessee—Jackson and Polk, at Nashville, and Johnson at Greenville. John Adams and John Quincy Adams were interred in crypts in Quincy, Mass. Taylor rests in Louisville, Ky., Pierce in Concord, N. H., Buchanan in Lancaster, Pa., Cleveland in Indianapolis. Wilson occupies a crypt in the National Cathedral in Washington. Lincoln was taken back to Springfield, Ill. Many Lincoln memorials



have been erected but that in the National Capital is the best known. Built of Colorado marble, it is one of the most beautiful memorials in the world. Calvin Coolidge lies in the village cemetery at Plymouth, Vt. In time his name probably will be carved in stone from the hills over which he roamed as a boy! But whether it be a simple headstone or an amphitheatre, time alone will tell what future generations will think of him.
