WHAT IS WRONG WITH BEAVERTON?

Census reports seem to confirm that villages and towns throughout the country are slipping, says the Publishers' Auxiliary. Various reasons are given for this, but the general blame is placed upon the automobile, which makes available to residents of the smaller towns the larger metropolitan trading areas and the consequent loss of business to the small-town dealer.

Probably it is too late to do anything for the villages. There is not even an Oliver Goldsmith to set forth their plight in undying verse, remarks the Publisher. But the case of the suffering towns may not be hopeless. There may be something wrong with the towns themselves. If so, it is the duty of the newspapers in those towns to find out the trouble and point out the remedy. An eastern newspaper has addressed a questionnaire to the community, especially to the farmers, asking their opinion on the various phases of the trouble with the local community. At first it was feared that this might antagonize the business men, but to the gratification of the publisher it received their hearty cooperation. Stores provided themselves with copies of the questionnaire, passed them out to customers with their purchases, urging them to criticize freely, and displayed large cards in their windows asking: "Have you answered yet?" The response was gratifying and, in most instances, the merchants greatly appreciated the suggested changes made by their customers.

The Review would be pleased to have the readers fill out the questionnaire and will be glad to give space to all communications relating to the same. It is as follows:

- 1. How do you feel about Beaverton as a place to trade? 2. What do you think about the stores here in general? Why? 3. How could these stores be improved? 4. Which are the best stores, in your opinion, in Beaverton? 5. What criticisms or complaints have you of Beaverton stores? Which ones? Why? 6. What articles do you buy elsewhere because you cannot get them in Beaverton? 7. How often do you go to Portland? 8. Do you prefer to buy on credit or for cash? 9. Have you been refused credit by any of the stores here? Which ones? 10. Would you trade in Beaverton if offered more credit? 11. In what way can the local papers be improved? 12. What advertisements do you read in the Review? 13. Are they reliable or unreliable? 14. What improvements would you like to see made in the community? 15. What roads would you like to see improved? 16. What improvements would you like to see in the schools? In amusements and recreation and social facilities?

OUR RESPONSIBILITY

Last week the Review published a communication from a "Group of Citizens" in which they criticized rather freely the town administration. This paper disclaimed any responsibility for the statements made therein, and in the communication itself it was stated that "this article is sponsored by a group of citizens not interested in individual differences... and finally it is not by any means the thought of the Beaverton Review editor—he has kindly given us permission to print it in his columns."

Despite these statements the Review has been bitterly assailed by a number of people who do not take into consideration the fact that a newspaper is, in a sense, a public property. It is expected to print both sides to a controversy and should not be condemned for giving space for expression of views on one side of a question when its columns are equally available to the opposition.

In the instant case, however, the Review feels that it has been used as a cat's paw in order to pull somebody's chestnuts out of the fire. Hence, in the future, any communication that openly criticizes either the officials of the town or any individual will have to bear the name of the writer.

We are not interested in the petty squabbles and factional differences that seem to permeate the political at-

mosphere of Beaverton, other than to say that those who are responsible for keeping alive the ill feeling that has developed are working against the best interests of the town.

It is time for a new deal. Both factions should get together, bury their differences and work for a condition of harmony and advancement. Beaverton has suffered too long from this attitude and it is time that it came to a stop.

In the article mentioned the charge is made that the town council is prone to go off "half-cocked," yet the author lays himself liable to the same charge when he admits his own ignorance of facts in regard to the proposed sewer. Yet, in the same breath, almost, he looks upon it with eyes of suspicion.

The Review believes that Mayor E. E. Fisher and the majority members of the town board are endeavoring to do something constructive for the city, and if they have acted hastily, which we do not admit, that they were impelled to do so merely because of that constructive attitude. The town administration has had the opportunity of inquiring into certain data that has as yet not been made a matter of public knowledge, but which will be set out in full detail when the plans of the engineers who have been making a survey of the city have been embodied in their report. A mass meeting will be called at which these engineers will be present ready to answer any questions the doubting Thomases may propound and, if possible, clarify their minds as to the advisability of completing the project. So why not wait until then and at least give the town council the benefit of the doubt?

DIRECT ACTION NEEDED

There is only one way to cure the irresponsible hunter who takes a snapshot at one of his unfortunate companions and that is to give him a dose of his own medicine. If it were fully understood by these people that a "mistake" on their part meant a like "mistake" resulting in their death or serious injury, there would be fewer accidents in the woods during the hunting season.

Down in southern Oregon, in the vicinity of Yoncalla, where hundreds of hunters from Portland and other outside sections of the state go during the open season, they are informed before their entry into the woods that any wild or reckless shooting on their part will result in dire consequences to themselves. The result is that in the past few years only such accidents as were unavoidable or due to the carelessness of the victim himself have occurred.

There is no excuse in the world for mistaking a man for a deer, and no excuse should be accepted. It is murder, pure and simple, and the murderer should receive the same treatment he deals out to his unfortunate comrade.

Laws which define such cases as homicide, and under which there is seldom a conviction, are useless. Taking a man's gun away or refusing him a license does not fit the gravity of his offense. An eye for an eye and a tooth for a tooth is the only law one of these morons understand.

It is estimated that the proposed Bonneville dam will give employment to 17,000 men when construction work is in full swing. That, with the numerous municipal improvements which now are contemplated, should make a mighty big hole in the ranks of the unemployed in Oregon and means that the era of depression is in sight, and not "just around the corner."

It might be well for the town council to buy one of the second-hand gas masks for the fire department, as was proposed at a recent meeting by one of their number, but with the stipulation that the city dad who suggested this economy be the one to wear it in case of another fire such as occurred at the City Market recently when escaping ammonia fumes made entrance into the building impossible. The lives of our fire fighters should not be endangered through the purchase of inadequate equipment.

Anyone who is dissatisfied with the brand of weather that Forecaster Wells is dispensing at the present time would probably complain about the cold in that certain place which is said to be populated mostly by delinquent subscribers to the local paper.

RECORD DEMAND FOR FARMS REPORTED BY FEDERAL BANK

Oregon, Washington, Idaho and Montana Included in Transactions

Testifying to an increasing demand for farms in the northwest since the first of the year, a record land-sale volume of \$1,401,958 was attained by the Federal Land bank of Spokane in Washington, Oregon, Idaho and Montana during the first eight-months' period of 1933, according to President E. M. Ehrhardt.

The largest sale volume was made of any August in the history of the bank, with \$204,094 involved, topping the previous August record made during 1929 by over \$19,000, it was added.

"A gradually increasing amount of cash has been noted since the first of the year," President Ehrhardt said, "with over 12 per cent of the total for the past month paid in cash." With the passage of the emergency farm mortgage act recently, cash loans, based on safe farm security, have allowed the farmer in many instances to consolidate all his debts under the Federal Land bank and land bank commissioner mortgage at a low interest rate and long-time payment basis.

"Apparently encouraged by gradually increasing farm commodity prices and the cash prospects of farm security liquidation, the public is responding with heavier cash payments on land in the interest of securing the best farm possible. They realize that the farm income in reviving and that land values will improve with better prices for farm products," Ehrhardt concluded.

A. P. Conrad, field man for Spokane county, Washington, led the entire field staff in the four states for the

For the hostess, who wishes her table to be especially colorful, the first-course salad is a most welcome vogue. One reason this new salad custom has become so smart is that it may add very distinctively to the color scheme of any table. We are suggesting a few luncheon menus, that show how effectively this new idea may be worked out. You will notice that the salad, served as the first course, is used as a part of the table-decoration—is light in character—and dainty in size:

LUNCHEON MENUS

- Grapefruit and Orange Salad Sweetbread Patties Buttered Peas Baked Potatoes Bread Sticks Cantaloupe à la Mode Coffee Shrimp and Cucumber Salad Fried Chicken Corn on Cob Potato Soufflé Currant Jelly Hot Baking Powder Biscuits Berries and Cream Butter Cookies Coffee Tuna Fish Piquant Salad Cold Baked Ham Scalloped Potatoes Cold Sliced Tomatoes Sweet Mixed Pickles Fresh Berry Tart Coffee

- Grapefruit and Orange Salad 1/2 cup mayonnaise 1/4 teaspoon horseradish 3 tablespoons cream, whipped 2 cups grapefruit sections, free from membrane 1 cup orange sections, free from membrane Fold mayonnaise and horseradish into whipped cream until thoroughly blended. Place 2 sections of grapefruit with 1 of orange in between on crisp lettuce for each salad. Serve with mayonnaise, horseradish, and cream mixture and garnish with maraschino cherries. Serves 12.

- Shrimp and Cucumber Salad 2 1/2 cups cooked shrimps 1/2 cup mayonnaise 1 1/2 cups cucumber, diced Watercress Cut shrimps in 1/2-inch pieces, leaving a few whole for garnish. Add mayonnaise and chilled cucumber. Serve on crisp watercress. Garnish with whole shrimps. Serves 10.

- Tuna Fish Piquant Salad 1/2 cup mayonnaise 1 cup tuna fish 1 teaspoon prepared horseradish 4 slices fresh tomato Filoneto To mayonnaise add tuna fish and horseradish and blend. Spread on tomato slices. Serve on crisp lettuce, garnished with tiny strips of pimiento. Serves 6.
