State Banking Superintendent Meets With Depositors

Plans Are Made for Reorganization of Bank of Beaverton, With Consent of Depositors, to Operate on an Unrestricted Basis

Last Friday evening A. A. Schramm, superintendent of banks, and Malcolm H. Clark, attorney for the state banking department, met with approximately 60 of the largest depositors in the lobby of the Bank of Beaverton. Mr. Schramm presented the problem which confronts the bank and the plan of reorganization, which he has approved, in such a splendid manner that it was easily understood by those present.

Mr. Schramm explained in detail the condition of the assets and liabilities of the Bank of Beaverton at the present time, and the plan of reorganization, which will release the bank from its present restrictions. Any depositor who was not present at this meeting, but interested in the same, may inquire at the Bank of Beaverton as the bank has in its possession a duplicate copy of the figures used by Mr. Schramm and the form in which he presented them, and the officers of the bank will be more than glad to explain them.

The plan for reorganization calls for a new cash capital structure and obtaining waivers from depositors for a portion of the funds which are at the present time restricted. The portion of the restricted deposit which every depositor will be requested to waive will be released gradually by a group of trustees to be selected by the depositors, who will liquidate those assets which the reorganized bank will not be permitted to accept. These assets are good assets but would not be acceptable to the reorganized bank, because due to present business conditions they do not possess a sufficient degree of liquidity.

If the proposed plan of reorganization is successful the Bank of Beaverton will be permitted to open as an un-

restricted bank, a member of the federal reserve system and the Federal Deposit Insurance corporation, on January 1, 1934. Approximately 45 per cent of the restricted commercial deposits and 50 per cent of the restricted savings deposits will be released.

Both Mr. Schramm and Mr. Clark vigorously recommend this plan as the best and wisest solution to the problem which confronts the depositors, and are very anxious to have the Bank of Beaverton open for unrestricted banking business and a member of the Federal Deposit Insurance corporation by the first of the year.

It was stated that the main thought in setting up the above plan has been the interest of the depositors of the bank, and the advantages to result from the completion of this plan of reorganization may be enumerated as follows:

1. The immediate release of the largest percentage of deposits.
 2. Assurance of the maximum amount of ultimate distribution.
 3. Conservation and economical administration of the remaining assets during the course of realization.
 4. Placing the bank in sound condition and making it eligible for insurance of deposits under the new bank act.
- It is earnestly requested that when depositors are called upon they respond at once, as prompt action is of vital importance to all other depositors, to Beaverton and to the tributary communities.

At the present time all deposits made with the Bank of Beaverton are guaranteed, as they are held in trust with the Federal Reserve bank. New accounts are solicited on this basis.

HEALTH ESSAY CONTEST OPENS FOR GRADE PUPILS

Cash Prizes To Be Awarded by County Association

The Washington County Health association is sponsoring an essay contest on the subject: "Immunization for Diphtheria and Smallpox—What Is It and Why Have It?"

Prizes to be awarded are: First, \$5; second, \$3, and third, \$1. These prizes in cash will be given in each of the two divisions.

Division A consists of Forest Grove, Hillsboro, Beaverton, Tigard, Aloha and Huber. Division B is composed of all other grade schools of Washington county.

The contest, which is open to all boys and girls in the sixth, seventh and eighth grades, opened October 23, and the best two essays from each school in division B, selected by the teacher, must be in the county school superintendent's office by November 13.

Schools in division A may send in the three best essays from each school. Essays will be judged on English, information and strength of argument, and should be limited to 300 words or less.

The winning essays will be read at the County Health association meeting on November 22 and the prizes awarded at the school program on November 23. The judges will be Mrs. C. E. Wells, Miss Pearl Allen, Rev. Leroy Walker, Dr. J. O. Robb and Miss Margaret Dixon, county health nurse.

The essays must be written in ink or typewritten, on one side of the paper only. Essays submitted should be numbered (name of the writer omitted) and the number of the school district should be given. This is for identification. A sealed envelope containing the number on the manuscript submitted and the pupil's name should accompany the essay. The sealed envelopes will not be opened until the judging is completed.

Mass Meeting on Sewer Project May Be Called Soon

Survey Has Been Completed, Maps Drawn and Estimates Made; Will Probably Be Submitted to Board of Town Trustees Next Week

MAYOR WAS THERE

CALL ISSUED FOR ANNUAL RED CROSS MEMBERSHIP

Every man and woman in Beaverton is invited to join the American Red Cross during the annual rollcall for memberships held between Armistice day and Thanksgiving, November 11 to 30.

W. F. Norman of Washington county in extending the invitation declares that never before in the 52 years of Red Cross history have so many people in this state been direct or indirect beneficiaries of Red Cross services.

Memberships are designated as follows: Annual, \$1; contributing, \$5; sustaining, \$10, and supporting, \$25.

All except 50 cents of each membership goes to support activities of the local Red Cross chapter.
