HARLOW VOSE INJURED IN ACCIDENT

While Mrs. R. A. Vose was visiting her daughter, Mrs. Kenneth Denney at Whitford, December 22, she learned that her son Harlow had met with an accident while driving on the Pacific Highway near the Red Rock Dairy.

Mr. Vose was found unconscious, with an injury to his head. His car was in the ditch.

Taken to the hospital, he regained consciousness, but was unable to explain the cause of the accident. He did not know whether he had been struck by a passing car, or if he struck an obstacle on the highway which threw his car. He soon recovered from the effects of the accident.

Vose was a former resident of Whitford, and is well known here.

MANY RECEIPTS FOR 1932 TAXES GIVEN

According to Miss Gladys Elsner, chief deputy tax collector for Washington county, almost a negligible number of people have offered to make segregated tax payments. She is also authority for the statement that more than 10,000 receipts for 1932 taxes have already been issued.

FARMERS RAISING HOGS PLAN TO MEET

Farmers raising hogs in this county are cordially invited to be present at a meeting to be held at the Chamber of Commerce rooms in Hillsboro at 1:30 p.m. today (Friday, January 5, 1934), according to Wm. Cyrus, county agent. The Federal program of corn and hog control will be explained there.

This control is reported to be similar to the wheat, corn and cotton allotment. If you are interested in this matter it will pay you to be present at the meeting.

CALL FOR SCRIP HAS BEEN ISSUED

A call for \$500 of the scrip that was issued last fall and winter has been sent out from the script office. The call covers all denominations numbered from 100 to 130.

If our memory serves us right, this is the second call that has been sent out for the redemption of this scrip, the first coming in a very short time after the Washington County Scrip committees began to issue the paper.

LOANS TO FARMERS BEING APPROVED

Loans totaling \$181,350.00 for farmers in the western part of Washington county have been approved by the Federal Land Bank according to a statement issued by N. S. Stook, secretary for the Forest Grove area.

These loans average about \$2,500 each. Twenty-three of the 107 applied for so far have been granted. Applications have been coming in to the office of the secretary at the rate of about 14 per month.

According to the figures set forth in the published statement from the secretary, 26 loans are still under consideration. That indicated that of the 107, only eight have been definitely and finally refused.

CLEANLINESS LEADS TO GOOD HEALTH

"Good manners are made up of petty sacrifices," says Emerson.

Good health demands that physical life be maintained at its maximum vigor. Personal hygiene is the individual's final fight for health. Nearly everyone can have good health if he is willing to work for it. Good health requires regularity of action. Most of us have good health and the chief problem is how to preserve it. In most cases it is as easy as cultivating good manners. There is a clear connection between good manners and good health. When good manners are formed they tend to become unconscious. Likewise when good health habits are formed they tend to become unconscious. The person who is well trained in good manners does not find it necessary to be thinking all the time of his behavior. Neither does the person who is well trained in health find it necessary to be thinking all the time of his health. He has trained himself to do automatically those things that promote good habits.

Take the question of hand washing as an illustration. It does not look well to sit down to a meal without having washed the hands. It does not look well to go to school and when hand inspection is called for, present a pair of dirty grimy hands for the teacher to see. But when we insist on hand washing as a matter of routine, there is more in it than the mere appearance of cleanliness.

A great many diseases we have—sore throat, influenza, colds, diphtheria to mention only a few of them—are believed to be spread through germs carried in the secretions from the nose and throat. Others like typhoid are spread through the discharges from the bladder and bowels. We have what are called "carriers" of disease, that is, persons who are not ill themselves but who throw off the germs of the various diseases and who are a source of danger to other persons. You can readily see why it is extremely important for these carriers to form the hand-washing habit.

But there is every reason why all of us should form the hand-washing habit, especially after visiting the toilet, before handling food or preparing it for the table and before eating. Our hands are also carriers—literally, the most active we have, and in contact with all sorts of things all day long. If each of us would organize himself or herself into a hand-washing league we would do a great deal toward protecting ourselves, and others as well, from disease-producing germs that we pick up or carry around with us.

Various means have been developed for blocking the many channels through which disease-producing organisms may pass from the sick to the well. Washing of hands is only one of these. With our increasing knowledge of the transfer of bacteria, isolation of the infected is becoming a very specific thing and the general quarantining of the premises less and less practiced. A sanitary conscience must be developed within each individual so that he coughs only into his handkerchief, each farmer washes his hands carefully before milking,

OBITUARY

JAMES D. WILMOT

James D. Wilmot, 85, died at his home in Sorrento Tuesday January 2, after a ten days' illness with pneumonia.

Mr. Wilmot was born in Warren County, Missouri, April 13, 1848. In 1850 when he was two years old his parents with their family of four boys and a little 6-weeks' old daughter, started on their long journey across the plains. When they reached Wyoming, the mother was stricken with cholera and died. Her body was wrapped in a blanket, and buried on the plains, and the wagon train was driven over her grave to conceal it from the Indians.

The party reached Oregon in October and the Wilmot family settled on a place 12 miles east of Portland, on what is now known as the Sandy Blvd. Nineteen years later they moved to a farm east of Beaverton, now known as the Mott place.

Mr. Wilmot received his education in East Portland, and the old Tualatin academy at Forest Grove. In 1875, Mr. Wilmot was married to Miss Ziona Fanno and in 1886 they moved to the home place where he resided until his death.

He is survived by his wife, Mrs. Ziona Wilmot and his daughter, Mrs. W. H. Boyd of Beaverton. He was a charter member of Beaverton Grange No. 400, which was organized in 1874, and which was disbanded some years later, and a few years after the present grange was organized in which he continued his membership as a granger. In October, 1932, he was presented with a 25-year membership card in the present grange.

Funeral services were held at the home Thursday, at 1:30 p.m., with interment at Crescent Grove cemetery. W. E. Pegg was in charge.

ERNEST LEE REAMY

Ernest Lee Reamy died in Portland last Saturday, at the age of 45. He has lived in Hillsboro for the past fourteen years.

Reamy was born in Tarreyville Mo., January 18, 1888. Surviving are his parents, Mr. and Mrs. William Reamy, and five sons and a daughter. Carl, Robert, John, Raleigh, Milo and June, all of Hillsboro; two brothers and three sisters, Carl and Albert Reamy, Hillsboro; Mrs. G. O. Gray and Mrs. E. W. Vincent, Portland, and Mrs. F. W. Ullman, Los Angeles.

Funeral services will be held at 1 p.m. Monday in Donelson & Sewell's chapel, with burial in Hillsboro cemetery.

New Members Take Over City Government

Retiring Council Holds A Short Session to Finish Business of Year

REPORTS ARE GIVEN

New City Officers Appoint Committees for Coming Year

The new members of the City Council took over their duties at the meeting held at the Town hall Wednesday evening of this week. Before their being sworn in the retiring council held a short session to wind up the business for the past year.

After the roll call which showed Alderman Bishop absent, and the reading of the minutes of the previous meeting, police W. P. Jones turned in a report of his work for the month of December. V. P. Reimer gave an account of the status of the case, Stevenson vs. Town of Beaverton et al, stating that one case had been decided in favor of Stevenson, and that the other had not yet been heard by the judge, but he had become associated with Stanley Myers, who would represent Beaverton in case Reimer found himself unable to appear in the City's behalf.

Dr. G. E. Watts, owner of the Beaverton airport, appeared along with Roy Davis and reported that the United States Officer who passes on such projects did not look with favor on the city's leasing the property and then getting Federal money to improve it. The Doctor admitted that there was a big indebtedness against the property which the City would have to assume in case they took over the ownership of the property.

The pump at the well came in for considerable discussion and it was decided to ask the Bingham Pump Co. for an extension of their guarantee because the pump had not been giving the satisfaction they felt had been guaranteed.

Alderman Koshland reported on improvements put in with recommendations for the future. Mr. Boswell reported on sidewalk conditions and work done in securing better drainage. Mr. Barnes told how the lighting had been improved since he took over the chairmanship of the committee, more lights, though of a little less candle power, but secured at an annual saving of \$890. Mr. Livermore said that the finances spoke for themselves. Mr. Fordney told of the accomplishments of the water department of which he has had charge. Mr. Fisher in retiring from the Mayor's chair extended best wishes to the incoming officers, and Mr. Boswell spoke feelingly of the good work done by the out-going officers especially of the efforts put forth by Mr. Bishop who was not present to hear the kind words of his former co-worker. Following these verbal reports Alderman Boswell moved that the hearty thanks of the remaining (Continued on Back Page)
