J. H. Wier Speaks To Townsendites

Nearly Seven Hundred People Are Present Despite Downpour

Candidates Seeking Political Offices Are Introduced

The county wide Townsend rally held at the Forest Grove high school auditorium Sunday, in spite of the terrific downpour of rain, was attended by nearly 700 people, representing clubs throughout the whole of Washington County, and a few outside visitors. The rally program was in charge of the Forest Grove Townsend club. Robert H. Kelly, of Hillsboro, Washington county rally chairman, had charge of the meeting.

During the program candidates seeking political office were introduced but no speeches were allowed. Special numbers on the program were a dance by Helen Powell, and a vocal solo by Elaine Foster, both of Forest Grove club. Mr. Kelly then introduced the State Area Manager, James Logan, who gave a short address before introducing Mr. John H. Wier, the representative from the Western National Regional office, who gave the main address of the day. Some of the high lights of his address were as follows:

"First I want to call attention to a remark that Mr. Logan made. He said we were charged with robbing Peter to pay Paul. It would be a relief if the Townsend plan would confine it to Peter and Paul. The other gang has been robbing the whole twelve."

"The Townsend Plan is planned. Seven thousand delegates, approximately, met in Chicago and they outlined a plan. One of those rules was to this effect: each state should organize a speakers' bureau comprised of accredited Townsend speakers. You are too easy on those speakers in Oregon. They make them take an examination in California. They should do the same thing here. It isn't that they have anything personal against the men but they have a definite program, not two, but one, that should be strictly adhered to."

"The Townsend Plan is a plan to cut through this great wall of opposition and bring the Government back to the people of the United States. You are going to have an election. I want you to go out before the election and if you have friends that do not understand and are not acquainted with the Townsend movement, go to those friends and talk to them personally. I believe that there is more of the ethics of the Man of Galilee and more of the principles of brotherhood of man in the Townsend Plan than in any other plan that has ever been formulated. I believe this should show at the polls. Make it your order of business that day to see that the men and women in your community get out to vote and that they vote for men that are Townsend men. Townsend men that came into the program without any thought that some day they might be called to run for public office. But since they are in the plan and are running for public office it becomes the duty of each Townsend man to carry the march to every voter."

"We are going to be charged by these little plaything politicians with everything. One man said to me yesterday he wanted to get this kind of a program operating in the Townsend movement: That the State Area Office would be paid a salary instead of a commission; that they are getting about \$3500 a month. I wish you could have seen Jim Logan and me yesterday trying to raise \$25.00 to keep them from taking our telephone from us. You have 150,000 members in Oregon and the biggest month we ever saw in dollars and cents, including membership dues, literature and every other kind of money was \$2600.00. You are not paying 1 1/2 cents. The enemy thinks we are paying 10c each. But you are not doing it. I want them to get

"CIVIL SERVICE" COURSES DISCUSSED

The United States Civil Service Commission has sent a notice to post offices, warning that misleading information is being given the public by representatives of some of the correspondence schools which sell "civil service" courses.

For a long time, the Commission has been receiving complaints from different parts of the country which indicate that opportunities for obtaining Federal employment have been greatly exaggerated.

It was made clear that no school has any connection whatever with the Civil Service Commission or with any other branch of the Government, and also that the Commission has no agents who solicit applications for civil service positions or who sell "civil service" courses.

No school can "guarantee" Government employment and none is given information regarding examinations, or any other information, which is not available to the general public. The Commission stated that it does not recommend any school, and explained that it is not necessary for anyone to take a course with a so-called civil service school in order to compete in a civil service examination.

A special point was made of the fact that information concerning examinations may be obtained at any time without cost, from the Secretary of the Civil Service Board at any first or second class post office or from the Commission's office in Washington, D. C.

Meetings To Help Farmers Make Lists

Filing of Work Sheet Is Part of New Soil conservation program

SIGN NO CONTRACTS

Officers Are Chosen for County Agricultural Association

Every farmer in Washington county is to have an opportunity of filing a list of his 1935 crop acreage in connection with the new soil conservation program if he cares to do so. Newly-elected community committees, meeting Friday afternoon, decided another series of meetings for the express purpose of leading individual assistance to farm operators in filling out the work sheets should be held. A schedule of these meetings is listed below.

Officers of the Washington county agricultural conservation association elected Friday afternoon were John W. Kanna, president; C. B. Buchanan Jr., vice-president; A. E. Krueher, county committeeman; R. Glenn Ritchie, alternate; County Agent W. F. Cyrus, secretary.

Filing a work sheet which just amounts to a list of the crops grown in 1935 together with the acreages of each, does not in any way obligate the farm operator to the performance of anything. Under the new program there will be no contracts and no agreements. The farmer does not promise to do anything; he merely lists what he grew in 1935 and then if in 1936 he makes the shift from soil depleting to soil conserving crops in accord with the program, he will receive the payment he is entitled to for performance. A filing of a work sheet does not obligate him to do this. It merely puts him in a position to take advantage of the program if it proves practicable to do so. Even though the farm operator cannot do anything this year to get a payment, since the program is expected to be carried through another year, it may be possible that he will be in a position to carry out some phase of its provisions in 1937.

There is also always the possibility here that weather conditions or insect pests might make it necessary to reseed or plow up a crop and where this has to be done, it might be practicable to do something that would come under the provisions of the conservation program. Having filed a list of his 1935 crops, the farmer having to do these things would be in a position to get some benefit out of the conservation program.

Waterfront Unrest And Battles Are Discussed

For more than two years the waterfront situation along the Pacific coast, from Seattle to San Diego, has been surging between a state of unrest and open violence, with its consequent loss of lives and hundreds of thousands of dollars in property damage.

The economic loss to the people of Oregon is conservatively estimated at several million dollars according to officials of the Oregon Producers and Shippers Association, who have made a careful study of labor relations in this state during the past two years.

"Vessels are tied up in California ports today as a result of radical and communistic labor leadership, and determined efforts are being made to extend this same waterfront trouble to the port of Portland," according to W. H. Perkins, manager of the association.

"Two years ago our wheat, our wool, our fruit and other agricultural products to every part of the state lost hundreds of thousands of dollars as a result of these labor disturbances, and unless the people of this state awaken to the danger of the present radical labor leadership up and down the Pacific coast, our growers face the prospect of even greater losses before the passes are closed on the present year."

"The present waterfront trouble in California is not a fight between union and non-union workers. Instead, it is a jurisdictional wrangle between rival labor organizations. Nor was the bloody battle at Seaside a couple of months ago, in which several lives were sacrificed a dispute between union and non-union workers. It, too, was a fight precipitated by rival labor leaders for supremacy in that area. In these two recent instances and in many others, the sleek, well-paid, rabble-rousing labor leaders incite their workers to violence and the public, as always, pays the bill."

"No honest man will deny labor the right to organize and to employ all legitimate efforts to obtain the best possible working conditions and wages consistent with the nation's economic status, but when labor attempts to set itself up above the law then we believe, and we are certain that all good citizens are in agreement, that labor leaders must be given to understand that the public has certain rights which must be zealously guarded and protected."
