## Good Time To Be Had At Camp

### SPONSORS WOMEN'S VACATION CAMPS

Rural women's vacation camps are again being sponsored in several sections of the state this year, with members of the OSC extension staff directing the programs.

For women in the Willamette valley a single camp in the Silver Creek recreational area is to be used for four camping periods from July 16 to August 8. Klamath County is arranging a camp from July 14 to 18, and Josephine county will hold a camp from July 21 to 25. Malheur county will hold a similar camp August 14 to 18.

In all of these camps a nominal charge is made to cover the expense of the camp, which also includes the necessary camp work so that the women are relieved of everything in the way of cooking, dishwashing, or other things that would mar a homemaker's vacation. The camps are open to enrollment by any woman over 20 years of age.

These camps are planned to give those who attend a good rest, new interests and new friends, says Miss Izola Jensen, rural recreation specialist of the extension service. A typical program includes classes in several crafts, sing periods, nature walks, health book and travel talks, swimming and vesper and campfire programs. A library is provided so that book lovers will have a wealth of reading materials available.

The Smith Creek camp in the Silver Creek area will accommodate 50 campers at a time. Those wishing to enroll may do so by contacting Nellie Lyle, home demonstration agent at Eugene; Mrs. W. S. Averill, county agent's office, Corvallis, or Hazel Packer, home demonstration agent, Gresham.

While the various counties have been assigned certain weeks at the camp, no hard and fast rule will be enforced in this respect, says Miss Jensen. Dates are July 16-21, Lane and Deschutes counties; July 24-28, Benton, Linn, Marion, Polk and Yamhill counties; July 30-August 3, Multnomah and Columbia counties; August 4-8, Clackamas and Washington counties.

### DATE FOR PICNIC JULY TWENTY-ONE

Washington County 4-H club members, parents and local leaders will hold their annual picnic Sunday, July 21 at Roamers Rest, two and one half miles south of Tigard. A picnic luncheon will be served about 12:30 according to an announcement made by the committee selected by the local leader's association to make the arrangements.

Club members and their families will bring lunch baskets, coffee, punch and cream will be furnished. The afternoon recreational program will be directed by Ed Setniker, of Hillsboro.

### TOURS PLANNED FOR 4-H CLUBS

An educational camping tour for 4-H livestock and crops club members will be held July 30, 31 and August 1, according to an announcement received by Palmer Torvend assistant county agent. ### FIRES HELD UNDER CONTROL NOW

All civilian workers are released from fire fighting in the Washington County sector of the Sunset fire, and dismantling of the temporary fire camps at Timber and Westtimber was reported Tuesday from the office of Cecil Kyle, district fire warden as blazes continued inactive.

Both the Sunset and Westtimber fires will be patrolled, however, until rain ends all threat of the smoldering blazes springing to life.

Portable two way radio sets were used during the week to speed communication between Kyle's office and the fire fronts. Another aid useful to the fighters in directing the battle against the flames was a mobile weather forecasting unit of the United States department of Commerce, housed in a truck and operated at the fire headquarters to localize reports on expected weather conditions.

## Grand Jury Continues New Term

### TWO JUDGES BUSY IN CIRCUIT COURT

Two circuit court judges presided over separate trials in progress at Hillsboro Tuesday as the March term of the court was brought to its close.

A jury in the court of R. Frank Peters concluded a one day trial by deliberating ten minutes to find James Lewellen Reed, 38, of Portland, guilty of drunken driving. Reed had appealed from a justice court conviction of last March.

Circuit Judge Howard K. Zimmerman of Columbia County also completed a hearing on a suit in equity brought by Rex S. Bechtel of the Sherwood district against his father, Sheldon Bechtel, involving an accounting with real estate and improvements thereon.

The case is being taken under advisement.

Two of the jurors on the Reed case, Erwin Springer of Hillsboro Rt. 5 and Peter A. Mulloy of Sherwood Rt. 2 were drawn for grand jury service.

The two will replace Mrs. Bessie Armfield of Forest Grove and Knut Nystrom of Beaverton, Rt. 2 grand jurors unable to serve further because of having left the state, the court announced.

The present grand jury will continue through another term.

### SIXTY NATIONS WERE MEMBERS

Eight members of the League of Nations withdrew a year or more ago. The changes in governments in the past year happened so fast and furiously that the League began to dismiss the members of its staff last spring. The 89 employes that survived were let out during June, and now a mere half dozen persons are all that survive of the workers of the League, which was formally organized January 1, 1920 through the coming into force at that time of the treaty of Versailles. The League functioned in a healthy way in its purpose "to promote international co-operation and to achieve international peace and security". At one time 60 nations were members. And now look at it—a tragedy of dishonesty and broken treaties.

### MEMBERS TO PRACTICE JUDGING

A poultry judging and culling practice for 4-H club members will be held at the Frank Erickson farm, Rt. 5 Hillsboro, Monday, July 22, at 10 o'clock, according to Palmer Torvend, assistant county agent. N. L. Benlion, extension poultryman, will assist with the practice by giving the club members some pointers on culling and judging chickens.

All poultry club members are urged to attend the meeting, on the Erickson farm, which is located on the Hillsboro Scholls highway, two miles northwest of Midway.

### NEW STANDARD FRUIT CONTAINERS

Effective July 10 two new containers for shipment of apricots were standard in Oregon, the state department of agriculture announces. Authority for use followed a hearing conducted earlier this month in The Dalles.

One of the new containers is a pyramid box 15 inches long, 10½ inches wide at the top, 8 inches wide at the bottom and 8¼ inches deep. The other is 4¼ inches by 12¼ inches by 16 inches. All are inside measurements.
