"Rival Sues S. P. R. R. To Enjoin Occupancy Of Siuslaw Canyon.

Portland, Ore., Nov. 30.—Officials of the Southern Pacific Company in Portland and San Francisco were somewhat surprised yesterday when they were served with injunction papers restraining them from occupying the Siuslaw Canyon in constructing the new road from Eugene to Coos Bay.

The suit is brought by the Pacific Great Western Railway Company, a concern that has been in existence for the last few years, but which, heretofore, has not displayed great activity in preparing to do actual construction work.

What interests are back of the Pacific Great Western has not developed, but some railroad men have guessed that the Hill roads are well in touch with the situation. Conley & DeNeff, of Portland, their attorneys, declare that the enterprise is backed by English and French capital. However, Portland railroad men are of the opinion that the real power behind the road is nearer home than England or France.

In its complaint the Pacific Great Western declares that it has prior rights to the route through Siuslaw Canyon, having run a survey through the canyon several years before the Harriman interests became active there.

It has been suggested that the Hill interests are back of the Pacific Great Western and that desperate opposition will be offered the Harriman lines in their efforts to reach Coos Bay, but representatives of the Hill system here deny any knowledge of the Pacific Great Western.

Boak Makes Reply.

In a recent issue of your paper I see a communication signed by W. R. and T. W. Panter purporting to be an answer to an article of agreement published recently in your paper. Allow me to say I did not have anything to do with the publishing of the document, but will now say it is a correct copy of the agreement signed by W. R. and T. W. Panter and the document is the property of the Coquille River Transportation Co. and is not null void but should be in effective force at the present time if a man's word and honor availeth anything. And in justification to myself permit me to say their reply was a conglomerate of evasion and fabrication which every one interested or conversant with the facts well knows. Dunham and myself purchased from them the steamers Liberty, Antelope and Venus, forming a partnership with the owners of the Dispatch and Favorite and a part of the stipulated purchase price was that embodied in the aforesaid agreement not to engage in, aid or abet, any steamboat enterprise on the Coquille river for a period of six years without the mutual consent of those interested and it has never been annulled or cancelled and should be at the present time in full force and effective.

Capt. White and myself are owners in the aforesaid steamers, and were, when the agreement was consummated. I complied with all requirements notwithstanding his erroneous statements which I can verify. He had an ironclad contract on us, we exacted nothing but a signed agreement, which apparently is worthless when men repudiate their agreement.

When we purchased the steamers they owed Dunham his portion of

the amount and when the steamers passed into our possession I paid my portion in U. S. coin, and thereafter made payments to T. W. Panter, except at a time when Capt. Willard sued them and obtained a judgment against them. There was a writ of attachment served on me, accompanied by a garnishee directing me to pay the amounts as they became due into court, and I did so and have the receipts for the same, and do not now or for a long time past, owe them one cent.

When the Coquille River Transportation incorporated, W. R. Panter and there voluntarily took stock to the amount of One Thousand Dollars and I paid him in U. S. money the balance in full I owed them. They say they took stock in the aforesaid company in part payment of what was due them, with the express understanding between all of the signers thereof then interested in said contract, that the same thereafter to be null and void and be destroyed.

I appeal to any reasonable person—does the above paragraph look feasible that it such was the facts that they did not secure that agreement and destroy it when they knew it was in existence and of vital importance does not appear feasible to the public knowing their past history.

As I was not instrumental in the publication of the agreement signed by them I cannot comprehend why they seek to malign me, but content myself with what the Good Book says: "Verily I say to you the slanderous tongue of the falsifier hurteth not the righteous or just, but brings condemnation and reproach upon themselves."

In conclusion let me say: their answer to their published agreement is false misrepresentation of facts as every one that signed that agreement are interested or conversant with the facts therein, and I assure you all will corroborate my statements. G. BOAK.

The first bout is to be between the popular Chinese boy, Sing Hosan and a good man of his weight, on the 16th of the month. The Christmas day bout will be between "Rough House" Charley Burns and Jimmy Burns, of Portland. The contests are to be staged in Marshfield and there is a possibility of a match between "One Round Hogan" of Bandon and Earl Henderson of Marshfield at one of the bouts as a preliminary. Bandon goes strong on the one round boy and there may be a considerable interest developed in a match between him and Henderson. Should such a preliminary be arranged, it will be for not less than ten rounds, which will give the fans a good run for their money.—Marshfield Record.

DAVID GARRICK.

The Great Actor's Art and His Wife's Ruffled Feelings.

Mrs. Garrick's admiration of her husband's dramatic talents was intense, and on his great nights she would hang over her box next the stage in rapturous delight. The one flaw in her idol, she claimed, was a taste for low life, for which she blamed him greatly, insisting that he loved better to play scrub to a low level audience than one of his superior characters before an audience of taste.

On one particular occasion she was in her box in the theater when Garrick's impersonation of Richard III. was applauded to the echo. In that day a farce followed the tragedy of the evening, and as Mrs. Garrick rose to leave before he had some business in the greenroom which would detain him, so most unwillingly the lady was obliged to acquiesce and remain through the closing entertainment. This proved to be a comical series of blundering adventures which had befallen a countryman who had left his farm to see London and on his return gave his neighbors an account of the wonders he had met.

This characterization was received with such peals of applause that Mrs. Garrick, ever zealous of her husband's fame, began to think it rivalled those lately lavished on Richard III. Her feelings were nearly worked up to fever heat when she was attracted by the frantic efforts of her little spaniel dog to overleap the balcony that separated him from the stage, when she immediately became aware of the truth that the actor was Garrick and exclaimed, "Strange that a dog should know his master when the woman who loved him best in the world could not pierce his disguise."

His Biggest Failure. John Jacob Astor was asked one day what was the largest amount of money he had ever made in one transaction. This he declined to answer, but said that he would tell the largest sum that he failed to make. With De Witt Clinton and Gouverneur Morris, he said, he had planned to buy Louisiana from France and to sell it to the United States government, retaining the public domain and charging 2½ per cent commission. They changed their minds and Mr. Astor said that he lost \$30,000,000 by failing to go into the deal.
