BOND FOR GOOD ROADS

At the annual meeting of the Coos County Good Roads Association at Coquille yesterday, a movement was launched to bond the county to the limit under the new road bonding law and build a trunk line of highway connecting up the principal points in the county and also connecting with the Myrtle Point-Roseburg road. The plan would call for the issuance of \$450,000 bonds by the county the construction of the permanent roadway beginning at the Douglas county line and the work to be done under an expert road engineer.

There were about 50 delegates from the different parts of the county present and all were enthusiastically in favor of better and more permanent highways. President Morrison of Coquille, presided.

The plan would mean the construction of a hard surface road from the Douglas county line through Myrtle Point and Coquille to Coos Bay and ultimately to Sunset Bay, with a branch line to Bandon.

It was decided that President Morrison should appoint a publicity and educational committee to take charge of the project. A most complete organization will be made, a committeeman being appointed in each road district.

Whether a special election will be called to submit the bonding proposition will be determined later.

Dr. E. Mingus, D. C. Green, George Goodrum, Hugh McLain and A. J. Mendel of Marshfield and L. J. Simpson and Dr. Bartle of North Bend were in attendance.

L. J. Simpson first proposed that the trunk road should be built from Sunset Bay to the Douglas county line via Myrtle Point but D. C. Green suggested that it would probably be better and that Mr. Simpson probably meant to start at the Douglas county line and build to Sunset Bay.

The next meeting of the association will be held in Marshfield at a date to be fixed by President Morrison.—Marshfield Times.

Notice.

All those using water for irrigating purposes will please call and settle for same or the water will be shut off at once.

The rule permits use of water from 6 to 8 a. m. and 5 to 9 p. m. Those who violate this rule will be shut off.

The United States forestry service and the state game wardens will co-operate for the protection of game, as well as of the forests. Under an agreement recently entered into between State Game Warden Finley and District Forester Cecil. The agreement provides that rangers, assistant rangers and other officers may be appointed deputy game wardens. They will report all violations of the game laws within their respective districts and will also make arrests in cases which come under their personal observation, except during the fire season. On the other hand, the regular deputy game wardens will extinguish any small fires they may discover and all such fires will be as promptly as possible reported to the forest officer in charge of the district.

Saw Outlaw

Frank V. Catterlin, of Bandon, was in the city last evening having come over to meet Mrs. Catterlin, who arrived in Marshfield yesterday from a visit with friends in Portland.

Mr. Catterlin came direct to Marshfield from Gold Beach where he and his brother were on a fishing trip. They had a glimpse of Ray Diamond, the bank bandit before he gave himself up at Gold Beach.

While fishing along the Rogue Thursday Diamond came out of the brush and timber to the river banks but seeing the party of fishermen he turned back, evidently fearing as he stated later, that he might be shot. Mr. Catterlin said he did not run or appear particularly excited. They made no effort to capture him. A few hours later Diamond walked into the Sheriff's office in Gold Beach and gave himself up.—Marshfield Times.

POWERS STUNG BY I. W. W.

On behalf of his client, A. H. Powers, Attorney John C. Kendall this morning swore out an attachment in Justice Penrock's court on a supposed bank account of W. J. Edgworth and served the papers on Cashier R. F. Williams, of the Flannagan & Bennett bank. Mr. Williams took an hour to answer the attachment and then informed the complainant's attorney there was no account in the bank for Edgworth. The attachment was instituted by Mr. Powers to secure the payment of a loan of \$40, which he gave Edgworth last July, when the latter came to him and said he was in great need and would repay it. Since Edgworth was sent out of the country without being able to arrange whatever affairs he had here, it was believed, being secretary of the I. W. W. and receiving funds continually, he would have a deposit at the bank in his own name, but the idea was a mistaken one. Those who have seen Edgworth's business transactions say he has been making his deposits at the postoffice in the postal savings bank and it is believed he has a considerable amount to his credit there. There is no manner of finding out whether this is true or not, and funds placed in a postal savings bank are not liable to attachment.—Marshfield Record.

Are you taking advantage of the mass of good reading matter available in the Bandon Public Library? If not the librarian wishes to direct your attention to only a few of the very charming and instructive articles that are found in the current publications found on the library tables.

The motorists of Bandon would be fascinated by "The New Passes in Tyrol," by Charles Lincoln Freeston. He describes the motorist's paradise and is the author of many other stories descriptive of the excellent roadways in the Old World. Found in Scribner's.

To the student of anthropology, the "Land of Incas," by Ernest Piexotto would appeal. Piexotto gives a vivid account of a people most unique and interesting in a land high among the clouds and of all countries the most absolutely shut off from the outside world. In Scribner's what medical man would not feel a stronger attachment for his work if he should read "The Ethics of the Profession," by Gerald Crittenden. This story exemplifies the devotion of a young medico for his profession. Scribner's.

In the World's Work, "The New Freedom," Woodrow Wilson's great serial is running. This time it is the "Emancipation of the Business Man." Wilson's principles are sound and will work out, so better read this article, if you want to keep up.
