Portland, Oct. 16.—J. G. La France, the life insurance swindler, was found guilty last night of obtaining money under false pretenses by placing a body on the banks of the Clackamas river near Estacada and later collecting \$3,000 insurance from the Modern Woodmen. He will be sentenced on Saturday.  
There are other charges against La France and these will be consulted later. Mrs. La France was indicted jointly with her husband and will be tried later on.  
J. C. La France secured almost \$13,000 from his criminal acts. At getting the money La France hovered about Portland and Coos county. Part of the money he got from the insurance companies was used in buying a sawmill and some timber about Bandon. La France has several small children, one of them a mere infant.




