NORTH BEND NEWS

From the Harbor:

Jack Melzer, Wm. Murphy and A. Buchler, three members of the Brewery Worker's Union, who were discharged by Chas. Thom, owner of the Coos Bay Brewery last Saturday, allege that the trouble arose over their refusal to work with a non-union workman who had been employed at that place for the past nine months and that they had requested to join at different times.

The commercial club started by the citizens of Cooston on the east side of the bay, held their regular meeting on Monday evening and was attended by about 40 people. The membership is increasing every week, many of which are persons who live elsewhere but who have purchased lots there, and are interested in the move recently taken by the citizens who have long awaited development by the corporation owning the bulk of the lots.

Word has been received by friends of L. D. Kinney, recently taken to the state hospital at Salem that he is suffering a severe attack of blood poison from an injury he received in the arm while being taken to that institution. His condition is reported to be improving mentally.

F. W. Wood of this city has copies of the Boise Tri-Weekly Statesman, published April, 1865, the first year of the existence of that great modern newspaper. The paper was set in the smallest possible type, the advertisements condensed, and the paper contained but four pages. The illness of Jeff Davis was told, as was the doings of several tribes of Indians, and other pioneer movements. The paper was sold at \$12 per year and advertisements were charged for at the rate of one dollar per line.

Milliron and Pitney, the genial proprietors of the Club Cigar Store, have a speed boat ready for her trial trip, which bids fair to outclass anything yet floated on Coos Bay. The hull is 25 feet long and built on speed lines, and she is equipped with a 16 horse Dunn four cylinder engine, which turns up a 16-inch wheel at 900 revolutions.

Beginning August 1st Lakeside will have a daily mail service, Sundays excepted. The mail since railroad activities started at that place has increased to the extent that a daily mail service has been granted by the department. The mail has formerly been taken out every other day.

The steamer Mary Olsen, which has been lying at our new wharf since last Thursday, taking a cargo of railroad ties, finished loading yesterday and sailed for San Pedro with 23,000 ties, said to be the largest single shipment of ties ever carried out of any port on the coast, and equal to one million feet of lumber.
