CIRCUIT COURT.

Some of the Important Cases Disposed of.

TUESDAY.
Edward Downs, forger and sharper on general principles or lack of principle, will reside in Salem and wear a penitentiary blazer for two years. There is no doubt about his guilt, as he confessed to all the charges against him and plead guilty to the indictments which the grand jury returned against him.

Wm. Barnhart was acquitted of the alleged crime of larceny of horses. District Attorney Lawrey, of the sixth, and John L. Rand, prosecuting attorney of the eighth district, were council for the state, and Messrs. Reeder & Raley defended.

Trial of Henry Barnhart, for stealing horses, was begun Monday evening and continued, when the jury, after consultation, returned a verdict of guilty as charged in the indictment.

The case against Mike Ryan, for cattle stealing was continued until the first day of next term. Ed. Peters plead not guilty to larceny of money from a dwelling.

The next business of the court was the trial of William E. Welch, administrator of the estate of James Morris, deceased, vs. Mrs. Mary M. Baker, F. H. Kerney and Peter West appeared for the plaintiff, and Reeder & Raley for the defense. Mrs. Baker has put in a claim for \$1200 for services as nurse during Mr. Morris' illness, at \$1.50 per day. The claim was allowed by the county court. Administrator Welch now brings suit to recover the money, excepting about \$150. The case is now on trial. Judge Eakin presiding.

Judge Balleray, referee, has filed his report in the case of Sabin vs.

Anderson et al, recommending a decree in favor of the plaintiff. Col. Butcher appeared for the plaintiff and Judge F. DePeatt for the defendants.

WEDNESDAY.
Elmer Bruce, jointly indicted with his brother, Fred, for the larceny of 60 sacks of wheat from Harala & Son, was tried before Judge Eakin and a jury Wednesday afternoon. The case was submitted to the jury at 5:30, and four hours later a verdict as charged was returned.

The case of C. C. Frazier against Robert and Alexander Ferris and B. F. Stone was also tried in the evening. The plaintiff sued for possession of the southwest quarter of section 25, township 5, north of range 34 east, which he claimed he had taken up as a homestead, and which the defendants wrongfully withheld from him. He also asked for \$800 damages. The jury returned a verdict for Frazier, awarding damages in the amount claimed.

The case against Elmer Nolin, for adultery, and Mrs. Mary Sams, for polygamy, which had been continued over from last term, was dismissed, and the defendants were discharged.

THURSDAY.
After six hours' consideration of the evidence, the jury in the case of Ed. Peters, indicted for larceny, failed to reach an agreement, and were discharged by Judge Lowell. The case was submitted shortly after 10 o'clock yesterday morning, and the jury retired. In the afternoon they reported that the prospects for a verdict were poor. Still they remained out until 4:30 o'clock when Judge Lowell had them brought in, and as they said they could not agree, they were discharged.

The case of Ezekiah Key against George W. Staggs was tried before Judge Eakin. The plaintiff sued for \$356 upon a mortgage on 892 sacks of wheat. The jury found for the plaintiff in the sum of \$255.

The jury was impanelled to try Fred Bruce, jointly indicted with his brother, Elmer, for the larceny of 60 sacks of wheat from Harala & Son. The taking of testimony will be begun this morning.

Elmer Bruce was ordered to appear for sentence at 9 a. m. today. Last night his attorney, Mr. Bean, presented and argued a motion for a new trial. The motion was taken under advisement until this morning.

W. M. Pierce filed a motion for a new trial in the case against Henry Barnhart, accused of horsestealing. It will be argued today.

GETTYSBURG POST.

At a Meeting Saturday It is Re-located in Athena.

Last Saturday the members of Gettysburg Post, No. 33, G. A. R., of Helix, met in Athena. The object of the meeting was to consider the moving of the headquarters of the Post from Helix to this city. After some consideration and discussion, it was decided to locate the post in Athena. Four new members were added to the post, which is now in a flourishing condition. The post was formerly located in this city, but for the reason that a number of its members were residents of the Helix neighborhood the post was changed to that point, but it has since transpired that Athena offered better inducements, and its removal back to this city is the result.

There is also some talk of organizing a Sons of Veterans camp here. There are several at Weston, at Adams, at Helix and in this city who are eligible to membership. It is thought from point of location that a county organization of Sons of Veterans could be made a success. Weston at one time had a camp, which, for some cause or other, surrendered its charter and disbanded.

Deal Probably Off.

The Portland Oregonian says of the Lively street railway deal: "Nothing is heard nowadays in regard to the purchase and consolidation of the electric railway systems of this city. The whole scheme is believed to have failed. The options expired months ago. The latest proposition from the promoters, the final outcome of all the negotiations in this and other countries, was that the railway companies give them a bond on their properties, and they would sell them if they could. This, it is understood, settled the matter with the City & Suburban Company, and all negotiations may be considered off."

Albert O'Harra, a well known pioneer of Umatilla county, died at his home, east of Weston yesterday morning at 8:30 o'clock. Mr. O'Harra had been in ill health for the past two years, and his death has been expected for some time. The deceased had many warm friends throughout Eastern Oregon and Umatilla county, who will be grieved at hearing of his demise. The remains will be interred at Weston today.

AN ENTHUSIAST ON IRRIGATION.

Wm. Rigby Visits Yakima and Tells His Impressions.

William Rigby spent several days in the Yakima country and has just returned, with an enthusiastic account of what was seen on the trip. To a Pendleton paper yesterday morning Mr. Rigby said: "The Sunnyside country is immense! Irrigation is king! I have come to the conclusion that 'we must do as William E. Smythe said when he was here, 'irrigate or emigrate.' Anyone riding through the country will be very much struck with the contrast between the sagebrush plains on one side of the road and the magnificent fields of grain and alfalfa and the orchards on the other. They raise everything over there which will grow in such a zone as ours. Land is too high, \$100 to \$125 per acre for unimproved lands, but nevertheless they get big returns from every acre. Let me detail some of the profits and yields: Alfalfa cuts from 6 to 9 tons per acre, growing finely on sandy soil, even better than on the black soil more resembling an eastern loam; broom corn cuts at least a ton to the acre and sells for \$100 per ton; sorghum produces 200 gallons per acre and potatoes turn out an enormous quantity, such crops are seldom seen in any country. Fruit was a good crop and prices were very fair. The great feature of the fruit industry is drying it for future sale at distant market points. Hops were only about half picked, prices being very low. I saw corn on which the ears were so high I had to reach up to touch them."

"Then there are the artesian wells, eight of which I saw. One is 1000 feet deep and throws a six-inch stream 20 feet high, irrigating 1000 acres. The water is warm—74 degrees Fahrenheit. At Prosser there were pumps run by motors, taking water from the river, elevating it to a high hill, from where ditches led it to points quite a distance up the river. Two of these pumps I saw which irrigate 4000 acres."

"I am satisfied that we must have irrigation. Nothing else will pull this country up to its rightful place and where it may go with its rich soil and genial climate."

Chinese Lecturer.

Rev. Jo Hawk, an educated Chinaman, spoke at the Christian church in Athena, Tuesday evening. Jo Hawk received his education at Drake University, Ohio. He is president of the Chinese Missions of the Christian church and preaches in Portland. "China and her Customs," was his subject, and while he is no way palliated the heathenish customs of his countrymen, he made several points by showing that Americans were guilty of just such foolish practices as the Chinese. One for illustration, was the Chinese lady lacing for small feet, and the American lady lacing for a small waist.

Work of the Sheep Inspector.

Sheep Inspector George W. Ellis report that he has inspected 40 bands of sheep since September 20. Most of the sheep are now in the mountains. Mr. Ellis says that there is not much feed in the mountains, and none at all in the lowlands.

The Lost Child.

The upper jawbone of a child has been found about forty rods from the spot where the skull, thought to be that of Alma Miller, was picked up a few days ago. The jawbone contains two teeth, which had just started from the jaw, and the doctor who examined it says that they indicate that the child was about six or seven years old. This was the age of Alma Miller, and is regarded as conclusive evidence that she died in the brush there. However, the doctors in La Grande, who have examined the skull, claim it is that of a child from 10 to 14 years old. All agree that the skull and jawbone are those of a white child. Mr. Miller, the father of the lost girl, is still of

the opinion that the child was stolen by gypsies. He thinks she died while in their hands, and was returned to the place where the bones are being found. Mr. Miller has requested the people of Grande Ronde valley to assist him next Sunday in a search for more evidence of the lost child. The meeting point will be at the Ladd place. Five hundred men are wanted, as the country to be searched is very brushy.

Three Buildings Burned.

The Crowner hotel, town hall and bathhouse at Meacham were destroyed by fire early Wednesday morning. Barney Crowner, the owner, and C. Betts, the manager of the hotel, were in Pendleton when the fire occurred. There were no lodgers in the hotel at the time. The fire started in the hotel, but its origin is a mystery. The flames soon enveloped the adjoining bathhouse and thence spread to the town hall, and soon the three buildings were reduced to ashes. A building situated within 50 feet of the burning structures, was not damaged. The postoffice was located near the hotel, but it is not known whether it was burned. The loss will amount to several thousand dollars.

The "Pudding" Was There.

D. A. Hendricks says in his last week's Montanian: "A fact not to be overlooked was omitted from the last issue. The neighbors having been kind to us in leaving their henneries unlocked, the editor, his family and a few friends partook of a fine chicken dinner on the 10th. It was the advent of the eight anniversary of their married life and around the table was proof of the pudding. That is to say, that marriage is not always sometimes a failure."

He is a member of Portland Camp No. 107, Woodmen of the World.

Law Was Sustained.

The Arkansas Supreme court rendered a decision in the Corbett case. Judge Leatherman's decision was reversed and the prize fight law sustained. Corbett was remanded back to the custody of the sheriff of Garland county. Chief Justice Brunn, in delivering the opinion, severely criticised Chancellor Leatherman, and said he had no authority for his action in the habeas corpus case.
