Tomorrow night a citizen's mass meeting will be held for the purpose of nominating candidates to be balloted for at the city election on Tuesday, March 7. At this meeting for the first time the new regime of naming six councilmen instead of five will be followed. The three councilmen receiving the highest number of votes at the election will be holdovers for the long term, a period of two years. The interest the PRESS has in the selection of candidates for municipal office lies only in common with the property owners and tax payers of the city, the prime object being the selection of men who are not only willing but who are capable of administering the government affairs of the city, and its interest centers in the nominations to be made for councilmen. The present year will witness the expenditure of a large sum of money in the extension and improvement of the city water works system, and the men who have brought about and made possible a betterment in the city water service, are those serving on the present council. They are cognizant and familiar with all the details of the enterprise up to the present time, and it necessarily follows that these men, seasoned with practical experience, stand in a better position to appoint a water commission, and as occasion requires, advise and confer with such commission, than an entirely new set of councilmen would be. For this reason the PRESS hopes to see members of the present city council nominated at the mass meeting tomorrow night.


