But it was no use. All could see that Geer was defeated, so in a last desperate effort to save the day for the people Mr. Burgess voted for Harvey W. Scott.

Mr. Burgess has been charged of making a "death bed repentance." Does the action of Mr. Burgess in 1903 looks as if he needed any "re-

His action was that of a man scrupulously honest, who did his duty. At that time Mr. Burgess saw that voting for the people's choice gave a chance for the machine to get in, so he has always considered the Statement not so much as an oath for a man to take, by which he should be bound, but more as a statement of

However, at the Primary election the people of Oregon made it emphatic by a majority of 75 percent that they considered the statement bind-

As soon thereafter as was possible Mr. Burgess wrote out a formal statement and deposited it with County Clerk Saling.

As an honest farmer, and an honest man, there is not one right thinking man in Oregon believes "Newt" Burgess will violate his pledge.

Mr. Burgess has made his attitude clear but if there is any Republican voter who would like a personal pledge, he has only to write to Mr. Burgess to obtain it.

Mr. Burgess is not an Assembly man, although he is charged with being one.

He is not an Assembly nominee but was the unanimous nominee for the farmers and business men of Umatilla county who are republican voters. He is known from one end of the

county to the other. He is opposed to the tactics of his opponent, Dr. C. J. Smith, who for eight years has consistently misrepresented Umatilla

Mr. Burgess is a farmer and a wool grower. He is in favor of good roads and will act accordingly. Although his opponent voted for the Crater Lake national road and belped to vote \$50,000 for that road, he has never done a thing to improve or better the roads for the Umatilla county farmer. As a citizen Mr. Burgess has been public spirited always. The farmer knows that in Mr. Burgess he will find a man who can sympathize with his troubles always-and who will do

more to help to alleviate them. The citizens of this, an agricultural county, can do no less than send a man who will truly represent them to the State Senate. Such a man is J. N. Burgess.


