3. The State Highway Commission now works without pay. Mr. Pierce introduced a bill to pay the commissoners \$12,000 a year. 5. He was responsible for the stopping of junketing trips by state officials at state expense. 6. He secured the passage of a budget law effecting large economies in the state government, which could not otherwise be accomplished. Pasture-Good pasture for horses 4.
