Cook two cupfuls each of sugar and water until it spins a thread; take from the fire and stir in the juice of a large orange, the lemon and the mint. Let stand on ice

until chilled. Serve on ice. Oyster Cocktails .- Clean and chill five dozen oysters, mix with three tablespoonfuls of horseradish, one tea spoonful of tabasco sauce, two table spoonfuls of vinegar, five tablespoon fuls of lemon juice, three tablespoonfuls of worcestershire sauce, three ta blespoonfuls of catsup, one and one fourth teaspoonfuls of salt. Mix well and serve over the oysters, which are placed in lemon, grapefruit or glass cups. This serves twelve to fourteen
