A committee, composed of Dr. Hawks, Forest Grove; Dr. Via, Hillsboro; Dr. Baker, Gaston; Dr. Hyde and Dr. Robb, of Hillsboro, was appointed to formulate plans for the best methods of procedure and this committee is to report on February 2nd, 1920, when the Medical Society will have another meeting at Hillsboro.

At the meeting Tuesday evening the Medical Society of Washington County was re-organized and Dr. Tucker was elected President, Dr. Wiley, of Hillsboro, Secretary.

The Society expects to push vigorously the building of a hospital and will do everything in their power to enlist the public in the idea.


