SCHOOL MEETING WILL BE HELD IN EVENING

Change in Hour is Made to Enable Workers in Portland to Take Part in School Affairs Here.

Because many Beaverton people work in Portland and have been unable in the past to attend the local school meetings, which were held in the afternoon, the School Board has this year called the meeting for an evening session and in the call which is published in another part of this paper, the hour of meeting is set for 8:00 o'clock.

This should result in a large attendance and a deeper interest on the part of patrons in the welfare of the school and the School Board should be commended for its foresight in making the change.

The meeting is called for the purpose of electing a successor to H. E. Weed, as director, and Miss Katherine Desinger, as clerk. Miss Desinger will probably be her own successor, as she has made a very competent official during the short time in which she has administered the duties of the office and her position at the bank makes it very convenient for teachers and others having business with the clerk. We have heard no one else mentioned for the place. For director, Mr. Weed and J. C. Huntley are being prominently mentioned by their friends for the three year term. Mr. Weed has made a very enviable record on the Board, his several years' experience in that capacity have given him a valuable fund of information and his excellent qualifications render him a desirable member of the Board. Mr. Huntley has shown his interest in the schools during his residence here, has served as president of the community club, has children in both the high and graded schools and has been quite in harmony with those of Chairman R. W. Cook regarding school matters.

A TRIP TO STATE GRANGE AT BEND

Mrs. D. G. Lilly sends us the following account of the Grange meeting which was held at Bend, Oregon, last week:

We left Portland Monday morning at 8:45 and got into Bend at 7:45, a distance of 270 miles. We went on the O. W. R. & N. There were quite a number of delegates, and they had to put on two extra coaches and then seats were at a premium. We surely enjoyed the Columbia River scenery and reached the Dalles at about noon. Didn't stop only a few minutes as we were on the through train for the East. We changed cars at Sherman. There are two lines from here, running to Bend, the O. W. R. & N. and the Oregon Trunk, one on either side of the river up the Deschutes canyon, to Metolius. From there on to Bend, 41 miles, they operate jointly on a single track.

Arriving at Bend at 7:45, the committee which should have met us, hadn't gotten back from their fishing trip, so it took some time for 200 people to find rooms and supper, but it was finally managed, with the exception of one or two parties who came in by gasoline route, so late, they had to stay in the Hotel Lobby all night and look for rooms next day.

Bend has a population of 8000. Our headquarters were at Pilot Butte Inn, a most unique building of native lava rock, rough logs and rough lumber. It is said to have cost \$100,000 and was built in 1917. Tuesday evening the Bend Rod and Gun Club and the Commercial Club united in serving us a "Trout Barbecue." The menu was printed on a small pine board, from the Brooks-Scanlon Lumber Co., which has a large mill here. Between four and five hundred pounds of fish were served, (gotten from all over the

SOUTHERN PACIFIC PROCEEDS WITH TRACK

Getting Ready for Passing Track Improves Appearance of Right-of-Way Along Hamilton Boulevard.

The Southern Pacific Company, the past week, has made a vast improvement in the appearance of the right-of-way along Hamilton Boulevard. The secret of the improvement is that the company is now proceeding with the passing track which, for the past six months, they have been planning to lay from near the Starch Factory to East of the Hedge property.

The grading which has been done has converted the old frog pond which once disgraced this property into a very respectable grade and one which it will easily be within the ability of the company to keep in attractive shape.

There are two or three other spots along the right-of-way and within the town limits which could see similar treatment, but without the aidings.

LIST OF MEN WHO MADE SUPREME SACRIFICE

County Clerk H. A. Kurath has received the following letter from Adjutant General White, which is explanatory to the list which follows of those from Washington County who made the supreme sacrifice in the late world war with Germany so far as has been reported to the State officials by the government. The list is, no doubt, incomplete, and anyone knowing of others who should be added to this list should report them to County Clerk Kurath or Adjutant General White, as requested in the letter. We give the full text of the communication:

There is attached hereto a statement of the men from Washington County who paid their lives in defense of the Country during the War with Germany.

This list, covering the Army and Marine Corps only, was made up by this office from red casualty cards furnished the State of Oregon by the War Department.

It is possible that there may be an addition or two because of oversight on the part of the Federal Government, although as the record now stands the attached list is a complete one covering Washington County, (except for losses in the Navy).

It is requested that if there are any omissions or if any of the data contained hereon is inaccurate that the relatives inform this office. To this end it is desirable, if you wish to do so, that the list be given to your local papers for publication.

I might add that if there is any information which you or your relatives of the men who died desire other than that contained hereon, I will be very glad to give you a complete statement in the case of any man from the records furnished us by the Federal Government.

SCARCITY OF TEACHERS BOARD'S BIG PROBLEM

Only Three Contracts Signed to Date.—Applications are Few and Big Wages is Demand.

The local School Board has its troubles. Of the elections made earlier in the year, only three contracts have been signed, those of Superintendent P. M. Nash, Mrs. L. B. Wilson, seventh and eighth grades, and Mrs. Austin Pharis, second grade. Applications are scarce and those who do apply have either limited qualifications or expect very large pay.

And to make the matter more difficult, Superintendent Nash has been ill since the closing of his school at Crawfordville and has been unable to assist the Board in securing applications.

As the annual school meeting is near, no strenuous efforts to hire teachers will be made until after the personnel of the new Board is known. It is expected that Supt. Nash will be in Beaverton before that time.

TWO FIRES AT GROVE THE PAST WEEK

On Friday of last week a serious fire was averted by the Fire Department's quick response and efficient action when the hot material used in dipping the Cinch Gopher Traps caught fire at the Cady & Whited bicycle shop where the famous little traps are manufactured. The use of chemicals checked the flames until a big stream of water was on the fire which was rapidly spreading. No great damage was done.

On Wednesday night shortly before midnight the Fire Department responded to the call and when they arrived, which was very quick, the frame dwelling just west of the Michigan House on Pacific Avenue, which was occupied by a number of employees of the Warren Construction Company, was all ablaze in the rear part of the house. How the fire started is not known, but possibly from a cigarette or cigar stub. The men had to beat a hasty retreat and escaped the flames, but were unable to save their clothing or other belongings. The building was practically destroyed.

CONTAGIOUS DISEASES MUST BE REPORTED

If Physician Is Not Called, Head of Household Must Report to Municipal or County Health Officer.

The health laws of the State of Oregon require the reporting of the following contagious diseases by physicians in charge of cases:

Chicken pox, diphtheria, erysipelas, German measles, influenza (flu), measles, mumps, pneumonia, scabies (itch), scarlet fever, small pox, tuberculosis, whooping cough.

It is not incumbent upon any one to call a physician for the sake of diagnosis or treatment of these cases, under the law, but the cases must be reported to the county or municipal health officer in any event. The responsible party, if a physician is not called, is the head of the household, in which the above diseases exist. He is supposed to have the necessary intelligence to make a diagnosis, if he assumes the responsibility of the care of the diseases enumerated above, in the absence of an attending physician.

Severe penalties are imposed under the law for the violation of the health laws relating to the above diseases. It is with the belief that lack of information is the cause of most violations of the law that this bulletin is issued.

All reports made to the County Health Officer, relative to the above will be used in the interest of public health.

CHURCH DEDICATION AT GROVE, SUNDAY, JUNE 13

The Dedication services of the First Congregational Church of Forest Grove will occur next Sunday. There will be four services during the day.

At 10:30 the service of dedication will be held. The sermon will be preached by the pastor, Rev. W. Walter Blair, the theme of which will be, "The Larger Investment." Rev. A. J. Sallens, Superintendent of Congregational Churches for Oregon, will be present and have a part in the service, as will also the pastors of the Christian and Methodist Churches, and others.

At 3:00 o'clock, there will be a mass meeting, at which Rev. W. T. McEivens, D. D., of the First Church, Portland, will speak on, "Why Do We Have Churches?" Others will have a part in this service.

At 6:00 o'clock the Young People of the Church will have a luncheon in the dining room, at which Rev. R. M. Pratt, of Portland, will be honor guest, and at 7:00 o'clock, there will be a Young People's Service, at which Rev. Mr. Pratt will speak on the subject, "The Three Great Questions of Life."

At 8:00 o'clock, Rev. A. J. Sallens will speak on, "The Invisible Church of Forest Grove," and Dr. W. C. Kantner, of Salem, will also speak on, "The Christ Who Cannot Fail."

Mr. Russell Beals will preside at the piano, and there will be much special music throughout all the services of the day.

The new church bell will ring next Saturday afternoon at 3:00 o'clock, for the first time, this ringing being only for a tryout of the bell. Next Sunday morning, however, the first bell for the dedication services will ring at 10:00 o'clock and the bell will strike the number of times the Church organization is old in years.

Other bells of the city will ring a response at the close of this ringing.

There will be services each evening next week in connection with the opening of the Church. A beautiful and elaborate printed program has been arranged for the Sunday and week-day services.

An unusual feature of the church dedication will be the fact that no solicitation will be made for funds.

TOWN COUNCIL WILL INVESTIGATE PRESSURE

Fire House Ordered Painted.—Bills Paid.—Water Contract Referred to Attorney.

The Beaverton Town Council, at its meeting Monday night, instructed the city attorney to look into the contract which the town has with the water company and report on the pressure to discontinue. Water pressure in Beaverton has frequently been unsatisfactory in the past few weeks and the council does not propose to take any chances on a fire and inadequate water pressure happening at the same time, nor does it wish patrons living in the higher parts of town to be deprived of water during the irrigation hours.

An order was passed to have the fire house painted, thus greatly improving the appearance of the block in which it is located.

BIG TIME PROMISED FOR SHRINE MEET

The citizen of Washington County who fails to attend the big Shrine gathering in Portland, June 22nd, 23rd and 24th, will miss one of the greatest treats that may come to him or her for a generation. It will be one of the greatest spectacular displays ever given on the coast. Portland is planning on entertaining from fifty to one hundred thousand visitors during that week, and while the big show will be put on by Shrines everywhere will be welcome and the bigger the crowd the better it will be.

Here are some of the thousands of features planned:

There will be in Portland 84 marching patrols, 74 bands, 15 chautau organizations, five jazz bands, 16 drum corps and one gun squad.
