TELLS OF THINGS SHE SAW IN CHINA

Former Forest Grove Girl Tells First Impressions of Missionary Work in Foreign Field.
First impressions of China as given by Elizabeth Carlyle in a letter to the members of the Woman's Foreign missionary society of the M. E. church.

Peking, China, Sept. 18, 1920.
My dear W. F. M. S. Friends:
At last, as you will see by the postmark, I have come to the end of my long journey. While things are still fresh in my mind, I will try to tell you about my trip up from Shanghai, and all the strange and wonderful things I saw.
We came up from Shanghai by train, as it is so much quicker, and more comfortable than the boat trip. The trains here are quite different from our American trains, more like the European plan, I think. On the way from Shanghai to Nanking, eight of us were crowded into one compartment, and as it was an extremely warm day, we nearly suffocated. (When we got on the other train at Pukow, it was much better, only two in a compartment, and everything arranged very comfortably, and much more room than in our Pullman cars at home. They have some very fine stations along the way, especially in North China. It seems that China borrowed the money for the first part of the road from England, and had British engineers build the road, then she borrowed the money for the north end of the road, up to Tientsin, from the Germans, and the German engineers finished the road, so naturally the better they made the stations and everything, the more money China would have to borrow. Quite a good scheme, for the Germans, at least.

The country is very pretty in Central China, there are a number of high mountains, and so many canals and rivers, so that everything is fresh and green, much different from North China. In several places we saw the farmers working around the farm, carrying an umbrella over the head with one hand, and their farm implement of some kind in the other. It doesn't seem as if they could get up much speed that way, does it? We saw lots of graves all through that region, too, just little mounds where scattered all over among the fields; sometimes a large mound where a whole family is buried, and at other times, just a single one. We passed a great many rice fields, too, at different stages of cultivation, some ready to cut, and some just planted, with only the tops showing up thru the water.

At Nanking we had to get out and go across the Yangtze river on the ferry, then take another train at Pukow. There was an awful scramble to get all our baggage out, and see that the coolies had everything, and didn't run off with any of it. The Yangtze is over a mile wide there, but they haven't any bridges across the river. There was a whole family in a little boat right next to the ferry, the father was rowing the boat, the big boy was tending the baby, while the mother and little sister held out little wire seines, (such as people use to catch butterflies with) for us to drop a few coppers in. I suppose that is much easier for poor father than working for a living would be. We saw one or two threshing floors, too, where they thresh the wheat by hand. After we struck Shantung, the country looked a great deal different, not so green, and the crops were very poor. They use the water buffalo a great deal, and often have a buffalo and a mule or a donkey hitched up together behind a plow. Donkeys are still very popular animals in North China. The first thing I heard this morning was the musical bray of one of the tribe.

After we had coffee, we went for a walk on the wall. It is only a little ways from the compound, and given you a fine view of the city, and the mountains to the west. There is a good stone walk all the way, so it is a fine place to walk, as there is no dirt or slush.
Monday morning, December 1, I will try to bring this lengthy epistle to a close today; am afraid you will never want me to write again if I don't stop soon. Yesterday morning I went over to Auburn Church, which is really a student church, although others attend. They say it is the largest church in Peking, there were over a thousand people there yesterday, all Chinese but about twenty. It certainly looked fine to see so many of them there, they have such fine faces, most of them, and they sing with so much vim. The regular preacher didn't preach, but a visiting pastor from Shantung, who had come down for Conference. The regular pastor made a great long speech of introduction, telling all the things the visiting brother had ever done, or expected to do, or as I should judge by the length of his speech, judge like some American preachers I have heard. At half past five we went down to the Y. M. C. A. to Union Church. All the English speaking people go there. Then, after dinner, which is at seven, we had a Methodist sing.

Conference begins tomorrow, so I suppose from now on, those of us who aren't teachers will be busy meeting trains. They expect nearly a hundred, I think.
Well, I must stop, as there are several other things to do this morning. I will always be glad to hear from all of you, and especially ask you to remember me in your prayers, for I do need them. If there is anything special you would like to have me tell you about, just feel free to tell me, for I may not think of the things you want to know now.

OREGON NOTES

News in Brief, Gathered From Various Parts of The State.
U. R. Grant has been elected mayor of Dallas.
Heppner's new \$100,000 hotel will soon be open to the public.
The school house at Spray, Wheeler county, was totally destroyed by fire last week.
The 1920 tax roll shows a total valuation of \$37,174,360 for taxable property in Marion county.
Harney county at the recent election passed an initiative bill placing a 5-cent bounty on rabbits.
Assessment rolls for Coos county have been completed and show a total valuation of \$25,642,353.
Out of 361 students in a Salem school examined by the school nurse, 170 were found physically imperfect.
The total rainfall at Marshfield during the month of October was 10.14 inches, breaking all previous records.
With \$1100 on hand and a budget of only \$2000, Creswell will probably have the lowest tax rate of any town in the state.
The annual school budget of Medford, an increase of \$10,120 over last year's budget, was passed by a vote of 163 to 12.
The annual teachers' institute of Marion county will be held in the high school building in Salem, November 22, 23 and 24.
The Bend Commercial club closed its three days' membership campaign with a total of 366 members and pledges for a \$7600 service fund.
All the sheep have been moved out of the Wenaha forest reserve to lower levels. There is about six inches of snow in the reserve.
Nearly 150 farmers in the section south of Myrtle Point have presented a petition to the county court asking a \$50 bounty on coyote scalps.
The main building of the Albany Tanning company, one of Albany's leading industries, was destroyed by fire. The loss will exceed \$40,000.
Ex-service men attending the Oregon Agricultural college have reinstated their war risk insurance to the extent of \$250,000 since last April.
The second annual convention and show of the Western Walnut association will be held in Portland on Wednesday and Thursday of this week.

Working men are still running on Sunday mornings, east of Eugene. It is supposed that all the girls will be thrown by the end of the week.
An official postal bulletin announces the restoration of the postoffice at Middle and Sutherland to the presidential claim, effective as of October 1, this year.
The Oregon Agricultural college student livestock judging team was the intercollegiate contest held at the Northwest Livestock show at Lewiston, Idaho.
The concrete pavement between Pendleton and Walla Walla, with the completion of also miles between Walla Walla and Bismarck, has been completed.
The Oregon public service commission has issued an order granting an increase in rates to the Calapooia Telephone company, with headquarters at Sutherlin.
J. O. Holt, manager of the Eugene Fruit Growers' association, left Friday for Chicago as a delegate from the northwest to the National Canners' association.
During a two weeks' campaign the Oregon Growers' Cooperative association, of Salem, increased its membership to 1554 and now controls more than 25,000 acres.
Fifty-eight per cent of the labor union members who have reported on an inquiry by the state labor commissioner, claim they saved no money during the years 1918 and 1919.
Leonard Truesdell, from the Pelet school in Polk county, who is only 11 years old, passed the eighth grade examinations with the highest standing of any pupil in the county.
The pear crop of the Madford district of the Rogue river valley will not go over 750 cars this year, of which 787 cars have already gone to the eastern auction market.
Miss Grace Arnold, who is reported in news dispatches as reaching the United States after harrowing experiences in Russia, is a Lane county girl, her home being at Pleasant Hill.
The annual convention of the Older Boys' conference for western Oregon will be held in Salem December 10, 11 and 12. More than 300 boys will be in attendance at the conference.
Indications of all at the Point St. George diggings near Crescent City are better every day and recent developments point to a gusher being brought in. The drill is now down 420 feet.
The state highway commission has made a proposal to Clackamas county to build the bridge at Oregon City and pay two-thirds of the amount, the county to have three years to pay its portion.

While the train was running 40 miles an hour, Harry Broadbent of Tacoma, a demented man, jumped through the window of a sleeping car near Eugene and alighted on the ground unharmed.
Kenneth Woodin, a sophomore in the Grants Pass high school, is dead from the effects of a fall from a roof while, with a number of classmates, he was attempting to paint the class numerals.
Success is claimed for the voluntary arbitration board in Salem, which was created by the Central Labor council and the Salem Commercial club. It has made Salem free from strikes and lockouts.
George Hayes of Coos Bay who follows the occupation of tapping trees for pitch for the Portland pitch refinery, is making \$15 a day, or \$45 a month. He sells the pitch at 50 cents a gallon.
Six new home nursing classes have just been organized at Springfield and in the McKenzie river country. Three of them are at Springfield and one each at Mt. Vernon, Thurston and Walaterra.
There are approximately 7000 men in Portland out of employment at the present time and a proportionate number in other sections of the state, according to C. H. Gram, state labor commissioner.
A total of \$78,000 will be required to cover the needs of the state bureau of labor for the next two years, according to an estimate submitted to the secretary of state by A. C. Gram, state labor commissioner.
The state banking department, of which Will H. Bennett is superintendent, has been exonerated by the grand jury of Jackson county from any blame in connection with the failure of the Bank of Jacksonville.
Representative men and exhibits from practically every creamery in the state are expected to be in Portland for the 11th annual convention of the Oregon butter and cheese makers, to be held December 8 and 10.
The Eugene Fruitgrowers' association, which already has a long list of fruit and vegetable products, put up at its cannery in that city, is now experimenting with the manufacture of apple syrup for table use.
The Oregon pentecostal ministers have given a series of three performances in the auditorium of the institution, netted approximately \$600, according to L. H. Compton, warden, under whose direction the show was staged.

The Alsea River Lumber company of Eugene, which recently completed a large sawmill at Glenbrook, has filed in the office of the Lane county clerk a trust deed to all its properties in Lane and Benton counties to secure a bond of \$500,000.
The lifeless body of Miss Edith Barlow, a student, was discovered in her room at Herrick hall, the girls' dormitory of Pacific university in Forest Grove. The young woman was found dead in bed with a towel saturated with chloroform about her head.
A movement has been launched at Salem to have the city council call a special election in the near future to

vote on the question of authorizing bonds in the sum of \$25,000 with which to help defray the expenses of the city government during the next 15 months.
The Lane county court has issued an order, restricting the weight of loads to be hauled over the Mohawk valley road extending northwesterly from Eugene through Donna, Marcola and to Wendling. The order states that loads heavier than 2000 pounds will be prohibited.
Application for a 20 per cent increase in telephone rates was made by the Pacific Telephone & Telegraph company of Portland to the public service commission. If the increase is granted it will mean an increase of about \$1,500,000 a year in the revenue of the company.
A professional trapper will soon be sent by the state game department to several localities in Lane county to trap beaver that have been damaging property near their habitat. Many complaints have reached the game department from Lane county regarding depredations of beaver.
Acting upon requests from the secretary of state, warden of the state penitentiary, superintendent of the Oregon state industrial school for girls, and the secretary of the Oregon state board of control, Sam A. Koser, in charge of the state department, has issued a call for the state emergency board to meet in Salem November 23, to consider proposed deficiency appropriations aggregating \$55,544.52.
Action taken by the Lakeview chamber of commerce and premises by the Lakeview Box and Lumber company indicate a roosevelt future for Lakeview. The chamber of commerce voted to purchase a 40-acre tract of land adjoining the city limits as a site for the construction of a \$300,000 box factory. A committee was appointed to raise \$14,500 by popular subscription to purchase the site. J. E. Campbell, representing the company, has promised to return to the people of Lakeview the \$14,500, with 8 per cent interest, in case the mill was not in operation within two years. Besides a box factory, Lakeview will probably have a \$100,000 sack and door factory in the near future.
