Mr. Jos. Whyte of Matney has sold his three splendid creek claims to John Harrison on Thirty-mile, and expects to engage in some kind of business at Condon at once. Mr. Whyte is an energetic business man and is a well-educated gentleman. He will be a welcome addition to our town.

Hon. T. G. Woodland was up to our town Saturday on business. His wife and children came very nearly meeting with a serious accident a few days ago. While out driving, the horses became unmanageable and upset the buggy, throwing the occupants out. No one was hurt, however.

Mrs. H. F. Downer of Rock creek met with a frightful accident Saturday morning. A dog scared the horse she was riding near home, and she was thrown off violently, breaking her leg between the ankle and knee. Both our doctors—Nicklin and Hogan were hastily summoned. She is getting along as well as could be expected.

Up to the hour of going to press—Thursday noon—the only nominations yet heard from by the Dem. state convention at Portland are as follows: For congress—1st district, Hon. R. M. Veatch of Linn county; 2d district, Hon. J. H. Slater of Union; for supreme judge, Hon. A. S. Bennett of The Dalles; for judge of the 7th judicial district, Hon. W. L. Bradshaw of The Dalles; for Dist. attorney 7th judicial district, Mr. Moore of Prineville.

Since the nomination of W. R. Ellis for congress, it becomes very funny to see several of the country exchanges "scour" with each other over the credit they want for having first mentioned his name in that connection. Why not go right up to him and say: "Mr. Ellis, I've placed you where you are, and if you get elected, don't forget me when any 'fat' appointments are to be made out here."

See the political card of W. H. Wilson, prosecuting attorney for the 7th judicial district. Mr. Wilson wants to be re-elected, and he isn't afraid to let the people know it. The people throughout the district know personally that he is thoroughly qualified for the position, and the rousing vote he will get next June will be proof that they appreciate his ability and integrity.

Harry Halstead has purchased the Metteer sawmill and planer, and will move the same at once from Thirty-mile to Lost Valley, to a location about two miles from where the Plitter mill stood. Harry is full of snap and energy, and as he has had considerable experience in that business, he will no doubt make a success of his new venture. He will have the mill in running order in less than a month.

This week John Meek purchased four lots in North Condon, two northwest from the public square, and two just by the school house, from J. W. Blake, Ag't. The lots near the school house seem to be going like hot cakes, on account of the excellent location and abundance of good pure water in that vicinity. No doubt in another year, fifty buildings will surround the school house.

It may not be particularly uncomplimentary to Judge Bradshaw to know that during court week at Condon, no less than 50 people were heard to remark that he was an exact likeness of Grover Cleveland. A number also remarked that they "bleeved the judge comes nearer 'looking clean through' a man than anybody they ever saw. It doesn't take him long to discover whether a man is guilty or not, or whether a witness is telling the truth. His eyes, by the way, are about three inches apart.

Last Saturday was a pleasant spring day. But Sunday wasn't. The people were surprised Sunday morning to see the country covered by about 13 inches of snow, which fell during the night. It was entirely unexpected, but it would be difficult to determine the number of 20-dollar gold pieces it will be worth to this section. It went off gradually, just fast enough so that all of it soaked into the ground. In consequence, the farmers' faces have shortened so much that they are now trying to get the barbers to reduce the price of shaving to 15c.

Father Lemay, Catholic priest, of Heppner, was in town several days the first of the week. He held mass here Sunday, and hereafter he will hold services regularly at this place every third Sunday of each month, and at Mayville every fourth Sunday. Father Lemay is a French-Canadian, and has been in Oregon only one month. The reverend gentleman is extremely sociable, also very humorous. In answer to a question as to whether he spelled his name with a big M, thus, "LeMay," he said: "No, indeed! I am too poor to afford such extravagance as that." His usual weight is 255 lbs.

All the farmers are unanimous in their prediction that the coming harvest will be the most bountiful in the history of the country. There isn't the least doubt any more that the soil in this section is the richest and most productive in the world. The eastern people are learning this, and immigrants will soon begin pouring over the Rockies on their way to Central Gilliam. The Oklahoma rush will be very tame in comparison. Let 'em come; there are millions of acres of the best government land in the West in this section, not yet taken, awaiting the industrious settler and his plow. Don't put it off any longer, or you'll be too late.

There is better water and greater abundance of it in the vicinity of the school house than in all the balance of the town together. In order to protect our town from fire, why not call a meeting of the citizens and discuss the advisability of putting in a wind mill and reservoir near the school house and thus establish a water works system. It is just the proper distance and has just the right slope to have the desired effect, and this is too important a matter to let drop. Don't put it off until after the town is burned to the ground. The town then could be supplied with the very best water in the country, entirely free from the nauseating drainage from all the stables and outhouses in town, which creates all manner of diseases.

On Friday, the 15th day of April, 1892, the same being the fifth judicial day of the term, the following proceedings were had:

Comes now A. A. Jayne, an attorney of this court, and informs the court of the death of J. M. Ramsay, lately an honored member of the bar of the 7th judicial district of the State of Oregon. Whereupon the business of the court was suspended, and fit and appropriate remarks were made, concerning the life, character and standing of the deceased, by the following members of the bar: A. A. Jayne, W. H. Wilson, H. H. Hendricks, H. S. Wilson, J. A. Brown and Geo. Watkins. The following resolutions were adopted, and spread at large upon the journal of the court, and that the court stand adjourned for the day, in honor of the memory of the deceased:

Resolved that this court and bar have learned with unfeigned sorrow of the death of our brother, J. M. Ramsay, and that in his death the state has lost an honored citizen, and the bar one who was destined, had his life been spared, to become one of its brightest ornaments. As a man his character was above reproach; as a lawyer he was honest and capable, and in all respects honorable and faithful.

Resolved that the members of this bar heartily sympathize with the relatives and friends of the deceased in their sad affliction, and assure them that the life and conduct of the deceased during his brief sojourn among us was such as to win him many friends, and no enemies. Resolved that a copy of these proceedings be furnished the papers of this county for publication, and that a certified copy thereof be sent to the family of the deceased.

GRAND JURY'S REPORT.

To the Honorable Circuit Court of the State of Oregon for Gilliam county:

In the matter of our final report of the grand jury, April term, 1892.

We, the grand jury, respectfully report as follows:

That we have been in session five days and have found and returned into court five indictments and seven not true bills. We have also inquired into other matters brought before us, which did not warrant indictments.

We have inquired into the condition of the public buildings of the county, and find the jail inadequate for the wants and safety of prisoners.

We examined the books of the clerk, sheriff and treasurer, so far as our limited time would allow, and find them in neat and careful order.

We find in our examination that the vault, for the county records, is in an unfinished condition; and we earnestly recommend the county court to repair and complete the same.

We find that the county contemplates building a court house and jail, and we recommend that suitable buildings be erected to answer the needs of the county. We also recommend that the court make some effort to procure water for the safety of the county buildings, etc.

Having finished the duties that have come before us, we respectfully ask to be discharged. Dated at Condon, Or., April 15, 1892. A. HERRIOTT, Foreman.
