It appears that a cow, belonging to John Harrison's little girl, was found dead a few days ago in Jos. Whyte's field, and thinking he had killed her, a warrant was at once sworn out for his arrest. After hearing the evidence on both sides the Squire dismissed the case, there not being sufficient evidence, in his mind, to warrant an investigation by the grand jury.

Mr. I. Hurt, whose home is seven or eight miles north of town, was examined last week by Drs. Hogan and Nicklin as to his sanity, and was adjudged insane. Deputy sheriff Anthony and Doug Hurt, his son, took the unfortunate old gentleman down to the state asylum at Salem the first of the week. This is a very sad case. Mr. Hurt has been one of the brightest men in the country, but for the last few months his mind had been falling him, with the above result. He and his family have the sympathy of the community.

Stock Inspector Alex Duthie finished his work this week of inspection and the other duties connected with his office. There are 94,300 sheep in the county, all free from scab. Two small bands had been slightly affected with scab, which, by the way, was imported into the county, but they have been thoroughly dipped and are now cured. Mr. Duthie's term of office expires July 1st. He has conducted the office in a very satisfactory manner, and the county court could not make a better selection than to re-appoint him at the next session, which meets the first Monday in July.

An English scientist has made a calculation about the time it will take to fill the world with all the people it will hold. The present population of the globe is supposed to be about 1,467,000,000; and he estimates that the maximum of the inhabitants that can be sustained on the entire land surface of the earth is 5,994,000,000, and that this figure will be reached A. D. 2072, or in about 180 years, at the present ratio of increase, which is 8 per cent per decade. We might add that there is plenty of room in Central Gilliam county for two or three thousand more industrious settlers.

Two well-developed faces, with the back of the head united, would have enabled the animal to graze on each side of the path at one time, the two tongues were joined at the roots. Four eyes set in their respective places in the two faces, would have made it impossible to approach the calf with a rope and branding iron with malicious intent. Only one set of ears graced this double head—one on the front side of each head—and in all other respects the calf was proportionately developed.
