Unjust Criticism.

MAYVILLE, OR., Dec. 13.

Ed. Globe:—The Fossil Journal last week in criticizing the action of the county court for instructing the supervisor of that district to collect property road tax from the citizens of Fossil, its editor evidently acted upon what he terms "current rumor," instead of upon the facts in the case. I will state the facts, and if the Journal man is not satisfied I would refer him to the road supervisor, also to the other members of the court.

The facts are that some time before the order spoken of was made, I was in Fossil and the supervisor informed me that the residents of Fossil refused to pay or work their road tax, giving as a reason that they thought they were exempt from road tax outside of the city limits, and asked my opinion as to what course he should pursue. I told him that the matter had been before the court some time before; and that to the best of my recollection they were exempt from a poll tax, but not from the payment of a property road tax. I told him, however, that if he desired any instructions upon the matter that the proper way to get it was to apply to the court, and not to any of the individual members thereof. At the next term of court there was a letter from the supervisor, asking the court's opinion in the matter. After careful consideration I found that what I told him at Fossil was correct.

The Journal, in all candor, makes the statement that "at the next session of the legislature the law will be so amended that the citizens of Fossil will be exempt from road tax outside of the city limits," etc. I assure them that whenever they get their incorporation law so amended, the county court will not instruct their supervisor to collect road tax of them. If it had been their intention to have an exemption clause and it was omitted, it certainly is no fault of the court, but rather that of the incorporators, instead.

In reply to the weak, long-winded article in the Journal referring to this matter in behalf of Squire Donaldson (who, by the way, was obliged to get some one else to do his writing) I will say that it is simply an effusion of misstatements throughout, and it is unnecessary to refute any particular part of it.

The county court's action in the matter was based upon the law regulating such matters, as well as the opinions of several reliable men and taxpayers as reside in the Fossil country, who were present at the trial, out of which originated the dispute; and not based, as the Journal stated for the Squire, "upon apparent prejudice and falsehood."

This learned Squire says—through some one else's writing—that he performed his duty in the case "faithfully and honestly." Perhaps he did. In his talk through the Journal he may have been "faithful" enough; but he did not do it honestly—in my case, at least.

As to the "political capital" the Squire speaks of, I am not in need of any at the present time, thank you; but if the aforesaid Squire has any political capital to spare he might divide with the fellow who does his writing—as he will surely need it if he gets the position he is working for, a year from next June.
