We are sorry to state that Ferd Halstead has been very sick the last week with pneumonia. Dr. Hogan is in attendance and reports him out of danger.

The postoffice at Crown Rock, in this county, has been discontinued, and parties heretofore receiving their mail there must hereafter go to Fosil or Antelope.

Little Veve, the 3-year-old daughter of Mr. and Mrs. Henry Hoss, died Sunday last at Arlington, of diphtheria. Much sympathy is felt for the bereaved parents.

Louis Meek, who has been stopping with his sister, Mrs. W. P. Scriyer at Heppner and attending school, is visiting his folks near Condon until after the holidays.

We poke our head out through the snow to holler that we are having some pretty solid wintry weather this week, a cold fact which most of you have noticed, no doubt.

The new ferry boat between Arlington is propelled by gasoline and naphtha power, and can be operated at a cost of about 50c a day for fuel. It is said the boat is of a very unique plan and pattern.

To-day, Thursday, is the shortest day in the year. The GLOBE was just about to "strike" for longer days, but will drop the matter, now as the days will gradually grow longer anyway.

A very large crowd is expected to be present for the grand masquerade to-morrow night, 23d. As ours is the largest and best hall in the county, the young folks are coming from far and near, as the enjoyment will be greater.

Our citizens met Tuesday evening and discussed the advisability of incorporating the town at the coming legislature. It was unanimously decided to do so. Ere many more weeks Condon will doubtless be a city in every sense of the term.

The Masons here have partitioned off their hall, over Downing's store, and propose to carpet the floor and fix it up in royal style. It will be much more comfortable for their purpose, but will prohibit the use of it hereafter for dancing.

The Brown Bros., Snipion Bill and Jim, returned a few days ago from a brief visit to the home of their parents near Dallas, Polk county. The old folks had not been apprised of their sons' intended visit, and it was an agreeable surprise to them.

Stock Inspector Alex L. Duthe has just finished his semi-annual inspection, and reports 116,000 head of sheep in Gilliam county, all in healthy condition. There had been a little scab, but the sheep were carefully dipped and are now in excellent order.

Dalles Chronicle: Judge Bradshaw is at home again, after having sat for Judge Stearns in court No. 2 at Portland for the past two weeks. Judge Bradshaw was well liked by attorneys and all who came before him. He was so kindly treated that he may wish to go there again in the same capacity sometime.

The editor of the Dispatch, which has just been moved from Dufar to Grant, evidently does not regret the change. Hear him: "The difference is great between living in a town where the music of locomotive and mill whistles is heard, and vegetating in a moss-grown and gossip-ridden cross-roads village."

An exchange very sensibly says: "Do something besides chores this winter. How can a man expect to make farming profitable when he works seven months out of twelve, and spends the other five in growing over his hard luck, and eating the profits of his months of labor? Get up and hustle; put yourself and team to work hauling stone, lumber, wood—anything that you can get paid for. If this is not possible, at least do enough repairing of tools, farming implements, buildings, fences, etc., to keep you from getting sluggish. Be enterprising and progressive. Do not be content to live simply from hand to mouth."

Capt. S. H. Miller returned home this week from Goldendale, where he attended the wedding of his son, Phillip H. Miller, who was married at that place Dec. 5th to Miss Allie Collins, a most estimable young lady. The Captain says that it was a grand affair, and that many beautiful and costly presents were presented to the happy couple.

To a man who has given the subject much thought, this modern inveighing against mortgages and other forms of securities is ridiculous. Giving a mortgage in no way changes the nature of an indebtedness. If a man incurs a debt he should look upon the eventual payment of that debt as a sacred obligation. The security he may give, in no way strengthens the original obligation; it merely records the fact of the obligation; shows what it is, and prevents all forgetfulness or misunderstanding as to the promises made for repayment.

The litigation between lawyer Goode and Alex Berry still boils with unabated fury. Berry moved to Marion county about three weeks ago, taking along a few head of horses on which Goode claims to hold a mortgage. Last week he had Berry arrested on a charge of larceny by bailee, and Constable Carlisle went down to Salem and brought him back to Arlington. Berry demanded a trial, and as Goode did not appear to conduct the prosecution, Squire Zeigler dismissed the case and Berry was turned loose. Thus poor old Gilliam is "in for it" again to the tune of several hundred dollars unnecessary expense. It would be a grand thing for the county if the law compelled prosecuting witnesses in such cases to give bonds for the costs. Some one remarked that Goode and Berry ought to be treated like the Kilkenny cats. They could then fight it out between themselves and save the county the unnecessary expense.

An exchange very truthfully remarks: "A newspaper man has no business to seek office. It is his business to try and get an office for the other fellow; to sound the praises of the candidate regardless of his own private feelings; to whomp her up for his man and let this same man forget all about him when he is elected; to defend his candidate against the unjust attacks of the opposition, and then see that whatever favors his candidate has to bestow goes to the other fellow. It is his business to boom the city for all it is worth, month after month, and then see hundreds of dollars worth of printing go out of the city because 10c might be saved in doing so. It is the business of the newspaper to give every enterprise a frequent send-off, and then catch sheep because he had failed to record that some prominent citizen had his delivery wagon painted. To subscribe liberally to every public, charitable and church entertainment, advertise them for nothing, pay his own way to everything, and then be called prejudiced and mean-spirited because a column is not devoted to that particular affair. Is it much wonder then that there are so many cranks in the newspaper business? It is bound to make either a crank or a philosopher out of a man."

The 3d Regt. on Solid Footing.

Col. Jay P. Lucas returned home Tuesday, after an absence of several weeks inspecting the various companies of the 3d regiment. He expresses himself as much pleased with the healthy and solid condition of the different companies of this regiment, and the intense interest manifested in the National Guard. He says that while in every company there are several indifferent members, they are gradually filling up with substantial and energetic members, who take great interest in military matters.

With the exception of uniforms, they are splendidly equipped, and as arrangements are now being made to supply the entire regiment with new uniforms, the boys have reason to feel greatly encouraged. Adjutant-General Mitchell, in his annual report, pays the boys the following compliment in this month's number of the Northwestern Guardsman, published at Portland:

"Col. J. P. Lucas, of the Third Regt., assumed command of the regiment in August, 1892, and has shown remarkable sagacity and energy in the reorganization of his command; and his report shows that he is rapidly placing it upon a higher plane of efficiency than it has ever been in the past. An officers' school has been organized in this regiment, carried on by mail, in which the officers take a deep interest, and are already showing a marked improvement in the knowledge and practice of military science. Col. Lucas also deplores the lack of respectable uniforms, which is a constant source of complaint throughout the National Guard."

Unnecessary Delay and Hardship on Settlers.

Times-Mountaineer: We are informed that instructions have been received at the land office in this city forbidding any proofs to be made or other business done requiring the inspection and signature of the register until he is able to perform his duties. Of Interest to Settlers.

An answer from W. M. Stone, Acting Com. of the General Land Office, in reply to a letter written by Jacob Bortzer of Shelby, says:

Department of The Interior, General L. O., Washington, D. C., Oct. 17, 1892.

Mr. Jacob Bortzer, Shelby, Oregon. Sir:—In reply to your letter of Aug. 22, 1892, I have to state that settlers on forfeited railroad lands lying between Wallula Junction and Portland, Oregon, have an extension of one year's time to pay for their lands, under a law passed the first session of the 52d congress. This law applies only to the third section of the act of forfeiture of Sept. 20, 1890, and extends the time of payment until Sept. 20, 1893, to actual settlers who were residing on or improving their lands when the forfeiture took place. Moiety lands reserved for the benefit of the Cascade Branch of the Northern Pacific railroad, including the alternate odd sections, numbered 1, 5, 9, 13, etc., are not subject to entries.

The above letter was sent to the land office at The Dalles by Clerk Lucas, and following is their reply:

U. S. Land Office, The Dalles, Or., Dec. 16, 1892.

JAY P. LUCAS, Esq., Co. Clerk, Condon, Oregon.

Dear Sir:—I am in receipt of your letter of the 14th enclosing certified copy of Hon. Com.'s letter under date of Oct. 17, 1892.

This office has held in every case, where the question has been raised, that the so-called extension act applies to actual residents only. The act approved June 25, 1892, which amends the 3d Sec. of the act of Sept. 20, 1890, uses these words: "So as to extend the time within which persons actually residing upon lands forfeited by said act shall be permitted to purchase the same in quantities and upon the terms provided in said section at any time within three years from the passage of said act."

The words of the statute are very plain, and we do not see how they can be construed differently from the way we have construed them. We shall, however, write to the Hon. Commissioner, calling his attention again to the matter, and will advise all parties interested by publication or otherwise as soon as a reply is received.
