Two weeks ago the GLOBE stated that Manley Keizer had sold one of his ranches to John Wasson, lately from California. Since that time we have learned that Mr. Keizer has not sold the place, but has only leased the same to Mr. Wasson.

Atty. S. A. D. Garley of Arlington was today appointed United States Commissioner by Judge Gilbert, of the United States circuit court, Oregonian of Aug. 9th. Mr. Garley also was appointed notary public by the governor. His many friends in this county are pleased to learn of his success.

There are only 600,000 pension claims pending before the department at the present time. Just think of it, there are more than 850,000 names already on the pension rolls, and 600,000 more are clamoring to get there. The Burns Herald is hot under the collar, and screeches: "The county court of Harney county has allowed the clerk and sheriff each \$1000 for deputy hire for the ensuing year. The Demorest Contest.

Probably the largest crowd that was ever in the Cong. church at one time was that which enjoyed the Demorest contest entertainment here Monday evening. The people were packed in like sardines, even the standing room all being occupied. The church was magnificently decorated with flowers for the occasion, due to Mr. Curran's good taste and energy.

The six contestants for the medal were: Goldie and Belle Darling, Lulu and Rose Miller, Birdie Henshaw and Cora Myers. Each delivered their little speech on prohibition with clear and distinct voice and with the ease and ability that would have done credit to much older and more experienced orators. Each speaker did so well that it evidently was a most difficult task for the judges to determine which was entitled to the medal. In order to secure judges who would not be liable to favor any one through acquaintances, Mr. Curran went to the trouble to go to Fossil for the three judges—consisting of Misses Jessie McLain and Stella Mastain and Mr. Albion Kahler. After due deliberation the judges decided that Lulu Miller was entitled to the medal and rendered their verdict to that effect. Mr. T. R. Lyons was chosen to make the presentation speech, which he delivered very neatly and gracefully. A prouder girl never won a prize than was Miss Lulu as she received from his hands the medal which had caused her so many hours' hard study and anxiety.

Besides the Demorest contest a very interesting program, consisting of instrumental music and singing, was rendered, all of which was greatly enjoyed by the large audience.

The next contest is set for Sept. 20th, and after eight such contests the eight winners of the silver medals will be given an opportunity to contest for a gold medal; and after eight such contests the eight lucky ones will then compete for a diamond medal. These medals are furnished free of charge by Mr. Demorest, a very wealthy old gentleman of New York, the object of which is to encourage prohibition. These contests also prove highly beneficial and instructive to the young competitors, as there is no school or other way by which they can learn oratory so well and rapidly as in this manner. The rules governing these contests forbid any one over 18 or under 12 years of age competing for the medals, and not more than eight competitors in each contest. Mr. Curran deserves much credit for having introduced the Demorest contest here.

A Big Foot Race.

Antelope Herald.

The foot race which took place at Antelope Wednesday, 8th inst., between the professional, Harry Stevens, and E. M. Shutt, of the Herald, for \$500 a side, resulted in the latter coming out winner by 6 feet. Stevens had acceded Shutt 15 feet on the start, and the former's backers, besides many others, judging from the race run on Sunday, July 30th, and his world-renowned record as a sprinter, were confident of Stevens' ability to win the race, even with such handicap. Early in the morning, Stevens' backers—Billy Hunt, of Tygh valley, and C. D. Beach, an insurance agent from Illinois, tossed their \$50 bills around promiscuously, and which were promptly covered until all their money amounting to about \$750, was up. A great deal more of Antelope's money could find no takers. Beach lost a \$65 gold watch and chain, a finger ring, a pocket-knife and his hat, besides his money. Billy Hunt lost his \$30 overcoat, sleeve-buttons, pocket-knife, two fine finger rings, and many other trinkets, besides all his money. By 3:30 the race track west of town was occupied by over 300 excited spectators from all parts of the country. After the necessary preliminaries, the runners took their respective positions, with Grant Mays as starter, and E. D. McArthur, E. M. Wingate and Wm. Menefee as judges. When the pistol cracked, both runners broke from the line as if shot from a cannon, and ran with the speed of a deer with a split stick over its tail. Stevens gained slightly on Shutt until within 25 yards of the outcome, when the latter got scared and spurred over the line about 6 feet ahead of his competitor. At this stage the Antelope crowd went wild and such unearthly yells had not been heard since the memorable baseball game on June 16th. Some of the boys hollered until their throat-ropes could be seen by looking down their throats. Shutt was tossed in the air and carried by the boys to his tent, where he was dressed and attended by his trainer, Mr. Rodriguez.

It was a severe and painful disappointment to Stevens and his backers, who are out of pocket not less than \$1,500 on the race. The boys had simply overestimated their runner's speed, but they took their defeat with unusual nerve. Nearly \$2,500 changed hands on the result.

Next day Mr. Stevens, in company with Walt Silvertooth, left for Arlington, from which place he expected to go to Portland, where he no doubt will soon be able to win back his lost laurels, also a lot of money. He has run some big races in his time, having won a race at Denver last fall on which his backers had \$20,000 bet. He has run in all the large cities of the United States and Canada.

The Quarterly Examination.

Of the four candidates who applied for teachers' certificates at the examination held at Condon last week, three were successful in securing certificates, viz:

Miss Ethel Parman of Condon, a second grade; average standing 81.4; Miss Retta Schomp of Fossil, a second grade; average standing 80.6; Miss Kathleen Fitzmaurice of Rowe creek, a third grade; average standing 71.7. Mr. S. I. Stratton of Lone Rock failed to get a second grade, and as he has already taught in this county on a third grade he will be obliged to give up teaching until he secures a 2d grade, which he will probably succeed in doing at the next examination. He gave excellent satisfaction as teacher at Lone Rock.

Miss Fitzmaurice is entitled to much credit for her success, when the facts are considered that she has attended only one term of school, all told, and is but 16 years of age. By her own efforts, assisted by her parents, she has attained a better education than the majority of young ladies whose parents have expended large sums of money in the attempt to educate them in so-called "high" schools. There is an excellent moral lesson in this for young people of both sexes who imagine nothing can be learned except at high-priced distant schools and colleges.

As to Gathered Waists.

Death of John McCullough.

Weiser Signal, of June 21st.

McCULLOUGH—At the family residence in Weiser, Idaho, on Monday morning, June 18, 1894, John McCullough, aged 71 years.

The subject of the above notice was born in County Tyrone, Ireland, in 1823, and was therefore at the time of his death about seventy-one years old. He came to the United States in the year 1835 and to the Pacific coast in 1852, and engaged in the mercantile business in Southern Oregon. In 1862 he followed up the gold excitement of Eastern Oregon and Idaho, making his headquarters at Canyon City, in Grant county, Oregon, where he resided until about ten years ago, when he removed to Weiser, where he has ever since made his permanent home. Late last fall he visited San Francisco, in the hopes of obtaining relief for a chronic ailment from which he had been a sufferer for several years. While at San Francisco he was taken with a severe spell of pneumonia, and his life was despaired of for several days, but rallied sufficiently to return home. Soon after his return he suffered a relapse and continued to grow weaker until the end peacefully came on Monday morning last at one o'clock.

"Old Mc," as he was familiarly called, was a man of the strictest business habits and scrupulously honest in all his dealings. Being a man of wide experience and business ability, he had accumulated a considerable fortune, variously estimated at from one hundred thousand to a quarter of a million dollars, which was bequeathed by will to his surviving wife and nephews, nieces and grand-nieces, he having died childless.

John McCullough's Will.

Weiser (Idaho) Signal of Aug. 9th.

The will of the late John McCullough was proved in the probate court at Weiser last Monday, Aug. 6th. The estate, consisting chiefly of money and negotiable paper, amounts to about \$90,000, and is disposed of by will substantially as follows:

I, John McCullough, of Weiser, Washington county, state of Idaho, of the age of 71 years and being of sound and disposing mind and memory, and not acting under duress, menace, fraud or undue influence of any person whatever, do make, publish and declare this my last will and testament in manner following: that is to say:

First, I direct that my body be decently buried, with proper regard to my station and condition in life and the circumstances of my estate.

Secondly, I direct that my executrix, hereinafter named, as soon as she has sufficient funds in her hands, pay my funeral expenses and the expenses of my late sickness.

Thirdly, I give and bequeath to my wife, Rebecca McCullough, the sum of \$40,000.

To my niece, Margaret Wood, of Canyon City, Oregon, the sum of \$1,000.

To my sister, Fannie McLaughlin, of Tyrone, Ireland, \$1,000.

To my sister, Margaret Galbraith, of Tyrone, Ireland, the sum of \$1,000.

To my brother, Andrew McCullough, of Tyrone, Ireland, \$1,000.

To each of the two sisters of Robert Galbraith, of Gilliam county, Oregon, \$500.

To my nephew, Amos McLaughlin, of San Francisco, Cal., \$1,000.

To my nephew, Robert Galbraith, of Prairie City, Oregon, \$1,000.

To my nephew, Robert Galbraith, of Gilliam county, Oregon, \$1,000 [and other bequests].

To my sister, Jane Keys, of Gilliam county, Oregon, \$500.

To my niece, Jennie Muldrick, of Canyon City, Oregon, \$1,000.

The several legacies bequeathed to my niece, Margaret Wood, and her daughters Johanna, Jennie and Blanche, I direct to be paid to said respective legatees in warrants of the counties of Baker, in the state of Oregon, and Washington in the state of Idaho, at their face value, without regard to accrued interest.

Fourthly, I give and devise all the rest, residue and remainder of my real and personal property and estate of every name and nature whatever owned by me at the time of my death, equally to Margaret Wood, hereinafter named, her daughters Johanna Wood, Jennie Wood and Blanche Wood, William Galbraith, Amos McLaughlin and Jennie Muldrick, to be distributed by the executrix as soon as she shall have closed the administration of my estate.

Fifthly, I hereby nominate and appoint John Muldrick, of Canyon City, Oregon, as guardian of the several legacies bequeathed to the minor daughters of my niece Margaret Wood, as well as guardian of all legacies that may go to any minor entitled thereto by reason of the death of parents, to act as such guardian without bonds and without the usual process of law.

Lastly, I hereby appoint my said wife, Rebecca J. McCullough, of Weiser, Washington county, Idaho, the executrix of this, my last will and testament, to act as such without bonds, and hereby revoke all former wills by me made.

In addition to the \$40,000 left in my wife, he made her a gift of \$25,000 in cash prior to making his will.

Curious Answers.

Salem Statesman.

The county board of examiners to pass upon the papers of the applicants for teachers certificates finished their labors yesterday and have the general averages yet to figure out. They had a big lot of answers to peruse this time and quite a number of them were most ridiculous displaying ignorance on the part of the applicant. For instance, on the subject of modern history such responses were given to questions as follows: Q. Name three forms of government that existed among the colonies prior to the revolution: A. French, English and Spanish. Q. What caused the civil war: A. Annexation without representation. Q. Name two American poets: A. Shakespeare and Byron. The Pequot and Sioux wars were given as among the battles of the French and Indian war. Tenneyson was named as an important American invention.
