

Now that the tariff bill has passed the Senate it is high time for business people to regain their confidence. For nearly two years the advocates of a high protective tariff have done all they could to injure the business of the country by saying that democratic rule is synonymous with ruin. Now that a really conservative bill has been passed these prophets of evil must stop talking and go to work. This summer will undoubtedly be a dull one in many ways, but the fall trade will come in with a rush that will surprise everybody. No candid person will hold for an instant that the treasury of the United States was in a healthy condition when Secretary Carlisle took charge of it. The question of issuing bonds had already been discussed and this bad condition was assisted by a lack of confidence. The crops of the country have been just as large as usual and no war or epidemic has decimated the people. The only trouble was that the people lost their courage and the result has been a disastrous falling off of values of every kind. In addition to the troubles named above the Senate showed a most exasperating indifference to the needs of the situation and spent more time discussing useless points than would have sufficed to pass two tariff bills. Let us all get ready for the good times that will soon make us forget that times have been very hard indeed for the past two years.

The Oregon railway & Navigation Company has reduced its operating expenses by cutting the wages of its employees, and at the same time has reduced the freight rates on wheat from the Inland Empire. The benefits to be derived from this reduction in wheat rates cannot be estimated, but its influence will be felt in every line of business. Railroad employees are the only sufferers, but even with the cut in wages, they are receiving salaries from 25 to 30 per cent higher than those paid for the same kind of work in the Missouri river territory. The course decided upon by the O. R. & N. will prove of immense advantage to the people living east of the Cascades; the railroad will also be benefited by the handling of more business and the shipping of more goods into the interior, and with this increased business will come greater prosperity and the probable restoration of the wages of its employees. High taxes, high tariffs, high freight rates, are enemies of labor, industry and enterprise; they retard growth and prosperity and render stagnant the channels of business. The new manager of the O. R. & N. realizes the needs of the country through which his road passes, and is governing his actions accordingly.

In Oregon the hard times are practically over. The returns from the present harvest will place the people generally in an easy condition. We feel confident that Oregon will revive from the depression long before her sister states. The conservative business methods of the people here warrant this belief. The conduct of the laboring class during the past great strike has been such as to inspire confidence in capitalists. Oregon has been charged with being one of the slowest states in the Union, but the present speedy return of confidence here and revival of business, has demonstrated that she has been steady and sure rather than backward.

The Pullman strikers are on a stampede. The men who struck in haste have had all the leisure for repentance that they want. They are now rushing up and clamoring for their old places at any wages the company will offer. If their foresight had been as good as her hindsight they would never have been in this predicament. We pity these poor deluded men whose families are on the verge of starvation, and who are about to be evicted from their homes, yet they have no one to blame but themselves. The labor agitator and the walking delegate stirred them into mutiny, and having had their dance, they are now paying the fiddler.

The reason why wheat is so low in price is that the world is turning so much of it into market. The same is true of cotton and wool.—Oregonian. Then we are to understand that the new tariff bill is not what ails the wool market. This is a reversal of the morning paper's former conclusions. Heretofore the Australian product, to be admitted to this country free of duty, was what gave to the price of wool "that tired feeling."—Portland Mercury.

The election in Alabama on Monday resulted in a complete victory for the democrats. The populists and the republicans combined for the purpose of defeating the democrats. For weeks past we have been hearing the claim made by the populists and republicans that the democrats would be completely overthrown in that state. The result in that state shows that populism is rapidly waning there. Two years ago the democrats defeated the same combination by 11,437 majority. This year the majority as indicated by the returns will reach 85,000. Both branches of the legislature is democratic assuring the re-election of Senator Morgan. Populism seems to be rapidly dying out in the South.—Guard.

There is more point in the following few lines than can be found in an average speech containing many columns: We let our timber rot and buy fencing. We throw away our ashes and grease, and buy soap. We raise dogs and buy hogs. We let our manure go to waste. We grow weeds, and buy vegetables and brooms. We catch five-cent fish with a four-dollar rod. We build school houses and send our children off to be educated. And, lastly, we send our boys out with a \$40 gun and a \$10 dog to hunt for a 10-cent bird. That is precisely what is being done all over Oregon, and the hard times is largely due to this indolent state of affairs.—Ex.

Abolish all laws for the collection of debts and the mortgage crop would not be so luxuriant, while money would be more plentiful for legitimate enterprise. It would then have to seek investment in industrial undertakings, rather than in mortgages and bonds as now. Nothing is more detrimental to a free country and a free people, to prosperity, peace and comfort, than an interest-taking class, supported by an interest-paying class and perpetuated by the mortgage and bond upon the soil. Persist in it, means in time a nation of masters and slaves, a nation of arrogance and servility, rather than a nation of independence and freedom.—E. Oregonian.

The following amendment is suggested by Jas. A. Sterling, assessor of Douglas county, Oregon: "I have read the article on the fourth state census and think the people of Douglas county should petition to the legislature to amend the census law to commence March 1st, the same as assessing. Why make double expense? It would be best financially for me, but it is not right and just to the taxpayer. Why assess around over two months and then go over the same ground again census taking? Once would do if the law was amended to read March 1st instead of May 10th."

Now let us quit talking tariff and get around to something else. If we are to have a revival of prosperity we must begin to work for it. And the work must commence right here at home. It is by encouraging each other and by helping each other that prosperous conditions will be resumed. Let us quit talking about hard times, and argue ourselves into the belief that the good times are at hand. In that way we will have more confidence in ourselves and in each other, and when confidence is restored the times will be all right.

A suspended city has been discovered off Glacier Bay, Alaska, by a party of excursionists. This curious phenomenon is seen regularly after full moon in June, and in no other time. It is said to be a beautiful mirage of some unknown city suspended directly over the bay. A photographer has taken pictures of it four times, but no one has been able to identify one of the ghostly buildings outlined.

A long drawn out Korean war would settle the Chinese immigration question to America's satisfaction. A singular feature in connection with arrival of steamers from the Orient is the fact that none of them are bringing any Chinese passengers.

According to the government report the condition of the wheat crop in Oregon stands at 95 as against 83 for Washington, 30 for Kansas and 41 for Nebraska. Oregon is always on top. Crops never fail here.

The Demand For Trained Teachers Rapidly Increasing. The demand for teachers with Normal training is growing rapidly in the state. The State Normal School at Monmouth reports that out of the 46 members of the graduating class of 1893 all but one were employed as teachers during the past year. Of its 217 graduates, exclusive of this year's class of 51 members, 184 are reported as at present engaged in teaching. The first class was graduated eleven years ago. The demand for teachers with training and experience is far beyond the supply; the supply of untrained and inexperienced teachers, on the other hand, is far beyond the demand. Both for the good of the teacher and the good of the schools, a thorough Normal course should be taken by those who expect to seek positions in the public schools of the state.
