Rev. M. Bramblet, Baptist minister, of Lone Rock preached three interesting sermons at Condon—Saturday evening, Sunday morning and evening, to large congregations.

M. J. Canty, the young harnessmaker who has been in the employ of Gene Smith for several months, left this week for Arlington with the intention of opening a harness shop in that town. His friends here wish him success.

The demurrer to the indictment for embezzlement against Fred Weatherford was overruled by Judge Stephens Saturday. The defendant entered a plea of not guilty, and his case was set down for December 26th.—Portland Sun.

Frank Stricklin of Rock creek brought a load of fine turkeys to town Monday for Thanksgiving festivities. So did Mr. and Mrs. C. J. Quinn of Mayville. Birds of that kind are not hard to swallow when they are fried in proper style.

United States circuit court convenes at Portland on Dec. 4th. L. A. Henderson of Mayville and J. E. Frick of Arlington are summoned to appear as grand jurors from this county. Some very important cases will be disposed of at this term.

Ed Keizer, who has been at work near Payette, Idaho, since spring, is home on a short visit. His brother-in-law, G. L. Phillips of Wilbur, Idaho, came with him and is visiting his father, G. L. Phillips near Olex. They will return to Idaho next week.

James W. Smith, a prominent merchant of Arlington, is at the Perkins. Mr. Smith laid the townsite of Arlington 13 years ago and is very favorably known. He reports a large crop of wheat in that section this year and no market for it.—Portland Sun.

Messrs. J. A. Ward and Earl Weatherford, of the Olex country, were in the city Wednesday. Before leaving town they each invested in a "glory ticket," and on Thanksgiving evening both deserted the ranks of single cussedness, notice of which appears in another column.

Our town was thrown into the wildest excitement Wednesday by the report that Mike Sullivan had made an assignment. After careful investigation we have learned that the rumor is without foundation—and the town is safe. Mike's financial condition today is as sound as it ever was in his life, and his credit still remains unimpaired.

Messrs. Ed Smith, J. W. Landy, R. R. Hankins and Dr. Geisendorfer of Arlington came up to our city Saturday for the purpose of organizing a K. of P. lodge at this place, which was done that evening in the Masonic hall. No new members will be received until their paraphernalia, which has been ordered, arrives, when a number of accessions to the lodge will be made.

There seems to be an epidemic of horse stealing in this state. With horses worth \$40 a dozen, one would think the chances of going to the penitentiary for 75 cents worth of "hoss," would deter even the worst thief from taking them, but it doesn't. Our own private opinion is that a man convicted of stealing a horse now should be sent not to the penitentiary but to the asylum.

It was a false report that the grand jury at The Dalles failed to indict Otis Savage for robbing the express office. Both Klein and Savage were indicted, but Ralph Gibbons was turned loose. Klein's trial has been continued until the next term of court and Savage's trial is in progress now. Savage wanted a change of venue to Sherman county, but it was denied by Judge Bradshaw. It will be a long, tedious trial.

Wheat, says the Medford Mail, is selling in the Rogue River valley for 50 cents a bushel. It sells in New York for about the same figure. In Eastern Oregon it brings only 35 cents a bushel. This is rather a peculiar condition of things. It strikes us that wheat in Eastern Oregon ought to bring a good deal more than it does, or that in the Rogue River valley a good deal less. Something wants regulating very badly.—Salem Post.

Sheriff Sears disposed of the extensive law library and office effects of John L. Ayer (who absconded several months ago) by auction Friday. The sale was well attended by members of the legal fraternity and others interested in securing possession of some good furniture and valuable law books. There were 100 volumes in the collection, and it is estimated that the library and furniture were well worth \$1100. About \$800 was realized.—Telegram.

Mr. W. H. Wilson Saturday was appointed acting prosecuting attorney during Mr. Jayne's severe sickness. Mr. Jayne is still no better, and his physicians thought it unlikely he would be sufficiently well for several days. His friends sympathize with him, and hope a speedy recovery will be given him. Mr. Jayne wished Mr. Wilson to act temporarily in his place, and accordingly Judge Bradshaw made the appointment.—Chronicle.

Ashland (Or.) Record: The continued decline of the value of horses until they are now seldom worth feeding is turning this most civilized of the animal kingdom back into barbarism. On the desert in Lake county there is now a roving band of 1000 "unemployed" horses that are running wild and are almost as shy and hard to approach as the deer and the bear of the forest. Shooting horses to get rid of them as an expense is becoming more frequent every year.

Frank McFarland, of Heppner, who has been at St. Vincent's hospital for three weeks, is improving rapidly. It is a singular fact that there are two other cases at the hospital similar to that of Mr. McFarland. One of the parties is said to have been a patient of a faith-curer, and that he has suffered greatly with the verminiform appendix. The physicians who operated on Mr. McFarland state that a half dozen cranberry seeds caused his sickness, and necessitated the operation.—Portland Sun.

Edward Martin, ex-deputy county clerk of Wasco county, has been indicted by the grand jury at The Dalles for forgery. It is claimed that fraudulent county warrants bearing Martin's signature were issued. Great surprise was felt when the matter was made public, as Martin stands high in the community, and has many friends who maintain his innocence. He was allowed till Monday morning to plead. Mr. Martin was the democratic candidate for county clerk at the late election and polled a large vote throughout the county.

We feel sorry for Astoria in her frequent and wearisome disappointments concerning railroad connection with Portland. She ought to have it, but we much fear she will never get it until her citizens quit quarreling and all take a pull together. With a solid front and a determination to have a road, she would get it. As long, however, as the city is divided into two or more factions, there is no hope of her accomplishing anything; she can only sit and wait until outsiders need the road to Astoria, or think they do, and proceed to build it.—Chronicle.

After 36 hours of terrific fighting the Japanese last week captured Port Arthur, the most important and powerful naval station in China. The loss of life on both sides was fearful. At this battle the Chinese showed more backbone than usual, hundreds of them being cut down at their posts, both armies having fought with the desperation of tigers. But the Japs were too much for them and the Chinese that were not killed were either taken prisoners or escaped to the mountains. On this occasion over 100 large cannons and thousands of tons of ammunition and provisions and the large city fell into the hands of the victors. The way is now clear for the Japs to capture Peking, the capital of China, and that will probably be done very soon. China offers a larger indemnity than Japan has ever demanded (\$200,000,000 and all Japan's war expenses, which will amount to as much more) but the war is fast reaching a point where peace cannot be had for an indemnity. Japan has earned territorial expansion, and probably will demand it.

Sunday's Portland Sun: Word was received here last night by Governor Penoyer announcing the death of his son, Horace, who was attending college in Williamstown, Massachusetts. Horace was taken down some days ago with typhoid fever and became so low that his mother was telegraphed for. Mrs. Penoyer is expected to arrive there tonight, having started from here Wednesday. Horace was a bright and handsome young fellow 19 years old, and of genial qualities that made for him a large number of friends who will be much grieved to hear of his sudden taking away. His remains will be immediately brought home for interment in the family lot.

Monday while threshing on J. C. Cooney's place, just south of town, his little son Willie narrowly escaped a frightful death. The little fellow's clothing caught on the tumbling shaft while the machine was in motion and he was violently thrown against the ground a number of times before the horses could be stopped. Only another round or two of the shaft and the little fellow's earthly career would have been at an end. Fortunately no bones were broken, but the little fellow is one mass of bruises and will be confined to his bed for some time. He was so tightly wrapped around the shaft that his clothes had to be cut from his body before he could be liberated.

Heppner has been agitated thoroughly for the past week, owing to the arrest and trials in justice court of the saloon keepers for keeping open Sundays. The first case called was J. B. Matlock, proprietor of the brewery saloon. The case was submitted to the jury at 8 p. m., Friday, who brought in a verdict of not guilty, after being out two hours. Thursday morning G. B. Tedrowe, proprietor of the City Hotel bar, was on trial. The case was given to the jury at 4 p. m., and after being out all night, they failed to agree. The other three cases were dismissed, thus ending chapter one of the W. C. T. U. crusade in Heppner. Some think this is the end of the fight against the saloons; others say it is just the beginning. What further action will be taken, remains to be seen.

The first issue of Mitchell's new paper, the "Monitor," reached our table last week. "Rocky Mountain" Smith, the notorious temperance reformer (who tries to drink all the liquors himself in order to discourage others from drinking) and W. F. Magee, a school teacher over there, were partners until the first issue came out, and in it their dissolution notice appears. "Rocky" has hit the road again and the paper is now owned and managed by Mr. Magee. The first issue was of course edited by Rocky and is filled up mainly by abuse of neighboring editors, some of them receiving some flattering compliments. In his general round-up he maps out our friend Stewart of the Journal as "a big nigger who never was known to tell the truth if a falsehood answers as well," etc. We wish the new paper success under its new management, but believe it will fall short of its main object—that of having a new county cut off—for a number of years yet, at least, until the population and wealth justifies it.

L. C. Trask last week traded his two ranches near Mayville to E. P. Weir of Jordan, Linn county, for a general merchandise store at that place. Mr. Trask was allowed \$5400 for the two ranches, \$10 a head for all his cattle and \$150 for his hogs. Mr. Weir will move his family up at once and engage in the stock-raising business on an extensive scale. His family will probably reside in Condon for the present. A. J. Shelton, also of Jordan, came up last week with Mr. Weir and traded his 180-acre Linn county ranch to Lee Bilyeu of Beecher Flat for his ranch and will move up at once and go into the stock-raising business also. Mrs. Bilyeu of Seio, Linn county, came up with them and visited her daughter, Mrs. J. M. Carl, last week. All left for home Monday morning, accompanied by J. M. Carl and Jim Poinexter, who will go as far as The Dalles with them and act as witnesses for Lee Bilyeu in making proof on his timber culture before the register of the land office. The people of this county regret to lose Mr. Trask, but all wish him success in his new field. Mr. and Mrs. Trask left Wednesday for their new home, via Arlington.

Arlington Items.

Wheat has declined a few cents. The recent rains have improved the roads very much.

Constable Cunningham made a trip to Fossil last week.

Miners have been washing gold along the river here this fall.

Our market here is well supplied with poultry for Thanksgiving.

S. S. Thomas and family have moved to town from Rock creek.

Dr. J. A. Geisendorfer made a professional trip to Umatilla this week.

C. W. Peters, a stockman of Washington, was in town Tuesday on business.

Dave Mason has been hauling lumber from town to his place 8 miles south of here.

L. Parker, proprietor of the Arlington-Fossil stage line was in town Monday night.

Sam McGilvray, one of Mayville's rustling farmers, was in town last Wednesday.

On Thanksgiving L. C. Edwards will raffle off a fine L. C. Smith hammerless, breechloading shot gun.

J. W. Smith's store was entered one night last week by way of the cellar. About \$45 in coin was taken from the till. No arrests as yet.

D. Morris was here last week for a short time. He was on his way to New York. From there he will proceed to England to visit his old home.

Stock Inspector Lee of Klickitat county, Wash., was here last week inspecting sheep. He is an excellent veterinary surgeon and did considerable work in that line while here in town.

No Need of a New County.

There will be an effort made during the next session of the Oregon legislature to have a new county carved out of the eastern part of Crook, the north end of Grant, and perhaps a portion of Gilliam and the southern corner of Wasco counties, with the town of Mitchell as the county seat. This proposition was before the last session but failed. "The people embraced in the territory named should have their county," says an exchange. "They are now isolated, as it were, from the rest of the world, being from fifty to seventy miles away from facilities for doing county business in either of the counties in which they live, and during the winter months are prevented from going to the county seat by an impassable barrier of snow. Give them a county we say."

Commenting on the above the Times-Mountaineer says: "There is no more need of this new county than there is for a fifth wheel on a coach. Some town desires county seat honors, and immediately there is a petition for a new political division to be formed. There is not enough property in the new county to pay proper salaries for officers, or to erect public buildings, and the division would eke out a miserable existence for many years. No new county is needed of the district named, and until the residents can show sufficient wealth to support the new organization the legislature should not grant the petition."

Chronicle: The Mitchell Monitor is a strong advocate of a new county organization; but it should contain its soul in patience, for Messrs. Smith and Magee will pass many snowy winters and warm luxuriant summers before Mitchell will be a county seat or Sutton county be one of the political divisions of the state.

Stock Brands.

The matter of recording stock brands was recently mentioned in a well-written article in the Fossil Journal that attracted considerable attention, yet perhaps the article was somewhat incomplete as to the requirements of the law.

At the time the impression of the brand burned on leather is filed with the clerk, a certificate description of the brand, where placed on the stock, together with ear marks (if any) and the range on which the stock run must be filed and recorded. JAY P. LUCAS, County Clerk.
