SCHOOL BOOKS.

Dallas Chronicle.

The school book question continues to be discussed at length. Some of the attacks upon the present system of books are really amusing, and make at least interesting reading. That the language series in use should be changed seems to be pretty generally conceded. Outside of that we still insist the sentiment of the teachers of the state is practically unanimous in favor of retaining the present system. We admire the progressive teacher and progressive ideas so long as they progress forward, but that admiration ceases when like the spirits of a seance, their progress has reached a point where they no longer use good English. The old books were thumbed by Webster, and before our most recent craze for progress the teachers who now have charge of the schools, themselves learned from the old books. If they are examples of the results of old methods and old books, then from our acquaintance with them we would say let the old books and the old system remain.

It is only six years since the present school books were selected, and if the school superintendents then made so poor a selection as some would have us believe, they should not be trusted to make another.

Senator Dolph of Oregon has introduced a bill to allow proofs to be made on forfeited railroad lands in cases where claimants have taken up the lands and put valuable improvements thereon with bona fide intention of purchasing them from the railroad company but from any cause have not made actual residence thereon. The bill is intended to offset the ruling of the present secretary of the interior by which actual residence is made a necessary condition of acquiring title from the government. Under Mr. Harrison's administration actual residence was not required where the conditions of the forfeiture act, as to possession and bona fide intention of purchase, were shown. Mr. Dolph's bill provides against another ruling of the present administration by which claimants are not permitted to acquire title to two or more separate tracts of land where the aggregate amount claimed does not exceed 320 acres. This ruling, like the other is persisted in, would work great hardship and deprive many a claimant of lands to which he has a just and equitable title.

New York Evening Post: Football, as now played, has grown into a gladiatorial show. It tends to promote the qualities which furnish our cities with their crop of blackguards, loafers and bruisers. It cultivates the gambling spirit in all our schools, high and low. It brings the poor and quiet student, whose object is mental culture, into contempt. It exalts brutality above intellectuality. Unless the proposed reforms in football are carried out, it may soon become an object of as much popular aversion as it now is of popular admiration. In their sober senses the Americans are not a brutal people; they will not long encourage brutality in the youth of their schools of learning, where, though physical culture has its place, it should not be exalted above all other forms of culture, and should not degenerate into savagery. The great public will soon conclude that games won by agility, skill and endurance, and not by violent personal collision, are the best and most manly.

The governor of Oregon is allowed \$1,500 a year, by the constitution, yet he pockets \$3,500, so it is said. The secretary of state is allowed \$1,500, but he makes over \$10,000 a year. The state treasurer makes considerably more than the secretary. The superintendent of public instruction gets \$3,000 above his constitutional salary, and the public printer, well—it is not exactly known how much he does get, but it is somewhere between \$2,000 and \$80,000 a year. Can the state stand this? Will the new legislature allow it to go on? We hope not.—Salem Post.

If the coming legislature does not change the present tax law, so as to provide for the taxing of mortgages it will fail to do justice to the people of the state. The money speculator, no matter how badly his cash is needed, should be given no such prestige as to exempt his mortgages, while the farmer, the home builder and the small business man is taxed on what he owes as well as what he owns.

Ex-Senator Edmunds strongly objects, in a current magazine, to the proposition of electing senators by popular vote. But he would hardly venture to draw on the present situation in Delaware to illustrate his argument. The legislature there is composed of 30 members, and in the hands of only 16 men repose the power to elect a United States senator for six years. Fishing for their favor is one man who has, probably, made money enough in the gas business to send the 16 all home independently rich if he should choose to employ his means in that way. Is that a situation in the long run best calculated to make the senatorial qualification one of brains instead of cash or cash influences? Senators should be elected by popular vote. All honest people are of this opinion.

The Oregon Pacific railroad was sold under a foreclosure brought by the Farmers' Loan & Trust Company of New York, Saturday last at Corvallis. There was but one bidder, and the road, 147 miles in length, was knocked down to Bonner & Hammond, of Missoula, Mont., for \$100,000. Court convenes on the 3d of January, when the question of confirmation will be decided. About \$11,000,000 was spent in the construction of the road. The purchase of this road by the Montana syndicate will mean another trans-continental railroad within a couple of years, and it will also forever still the Prineville Review's arguments that a railroad will prove a curse instead of a blessing to Crook county.

Some say "Oregon wants immigrants, but it wants none who have not money." All the immigrants Oregon got in former times were people that had no money, but had a spirit that was better. Oregon was not made by the money that was brought into it, but by the spirit of a people who could create money and wealth. This demand for immigrants with money is the demand of a milkop plutocracy. Let us hear no more of it. Man is superior to money. But he must be the genuine man, not the pinchbeck article.—Oregonian.

Perhaps it is all the better for Oregon's interests that Senator Dolph is not a fellow of sufficient jest to suit the carping soreheads. If he were given to seeing the humorous side of things he might neglect his senatorial duties to split his sides laughing at the evidently serious efforts of a few recreant republicans in this state to prevent his re-election. They are providing one of the richest jokes of the season.—Portland Telegram.

In June last the total vote of Oregon was a little over 87,000. The vote of the state of Washington in November last was 73,755. School statistics show about 10,000 more persons of school age in Oregon than Washington this year. Unquestionably Oregon has the larger population—though the census of 1890, feebly taken in Oregon and very energetically taken in Washington, gave Washington considerably more than Oregon.

Princess Bismark was proud of her illustrious husband, and took great interest in all that appertained to his career. But, aside from this wisely sympathy, she had no ambitions beyond the home circle. She was regarded throughout the empire as an ideal wife and mother and as a model housekeeper, and that is glory enough for any woman.—Telegram.

While the United States has 47,000,000 sheep, from which it produces 300,000,000 pounds of wool, Australia leads us with 550,000,000 pounds, and the Argentine Republic with 400,000,000. Last year we imported half the quantity we raised. As mutton breeds are adopted the price of wool will advance, and sheep breeding improve in some lines at least.

Mr. Estee, the republican candidate for governor of California, ought to put his head on a stake for the balance of his life. He has now been beaten in the courts and at the polls. Any republican who couldn't get elected this year in any state and for anything he wanted, is a disgrace to the party.—Salem Post.

Hundreds of Tennesseans who fought in the confederate army voted the republican ticket this year for the first time in their lives, and gave this as a reason: "The democratic party has demonstrated that it is incompetent to govern this country."

The number of votes usually cast in the United States is approximately 10,000,000. It was a little under that in 1890 and a little over that in 1892. The totals for 1894 are likely to reach 11,000,000.

A telegram from Newark, N. J., dated Dec. 19th says: One hundred prominent men of this city sat down to a dinner of horse meat this evening. Horse was served in all manner of ways, such as horse steaks, chops, pot roasts, baked rib roasts, hash, liver and soup. Of course there were other things, but no other meat was entered on the menu. The garnishings were of the best and most palatable, and there was no lack of liquids with which to wash the dinner down. All pronounced horse meat as good as anything in the meat line they ever ate.

These words of a Kansas City judge, "I would make ballot-box stuffing and forging election returns treason against the state and punishable with death," have a true patriotic ring in them, and should be enacted into law in every state in the Union.—Ex.

Our legislature soon to meet should pass a law prohibiting football or repeal the existing law prohibiting prizefighting.—Statesman.

Will Take Anything.

The Sheridan Sun is authority for the assertion that Hon. T. T. Geer is an avowed candidate for the superintendency of the State Reform School? Now, what in the world is there that T. T. Geer is not a candidate for? First, he wanted to be governor, after that he was willing to take the United States senatorship, then gave out that he would not decline to be superintendent of the penitentiary, and now would not refuse to be superintendent of the school. Mr. Geer is a good, staunch republican, but his political career will be cut short if he does not quit trying to compete for every office in the land. Supt. Hendricks of the reform school is giving satisfaction and has done a great deal to place the reform school in a position for good work, and the Post does not believe in his removal, at this time, for partisan purposes. If he does not do his work properly, then it is time to remove him, and not until then.—Salem Post.
