

**A WORTHY BILL.**

A bill has been introduced in the legislature, which ought to become a law, to take effect at once. The present law allows a juror in justice's courts only \$1 a day and 10c a mile, each way, and witnesses \$1.50 a day and same mileage. Of the two the juror has the most work and longest service, and there should be no discrimination. The bill reads as follows:

"That all jurors summoned to appear before a Justice of the Peace, a city recorder when acting as ex-officio Justice of the Peace, a coroner in holding an inquest over a dead body, or before any other court having jurisdiction, shall be entitled to an allowance of one dollar and fifty cents per day for each day in actual service, and to the further sum of ten cents per mile in going to the place of holding court and returning therefrom to place of residence. In all cases where a juror is summoned to appear before any of the courts above enumerated, if rejected for cause or otherwise, he shall be entitled to an allowance of one day's service and mileage as above specified. All Acts or parts of Acts inconsistent with this Act is hereby repealed. This Act shall be in force from and after its approval by the governor.

Senator Dawson's bill to fix the time when taxes become delinquent provides that: "The sheriff shall make returns of collections to the county court on or before the first Monday of October next ensuing the date of the warrant issued by that court, and that if at least one-half of the respective sum of taxes so charged on said roll is not paid prior to the first Monday in April next succeeding the date of his warrant, said one-half shall be deemed delinquent, and if the remaining half is not paid prior to the first Monday in October following, it shall then also be deemed delinquent, and there shall be charged, collected and turned over by the sheriff a forfeiture of 1 per cent per month on all portions of said taxes that have been allowed to become delinquent, and from the date of such delinquency until the same are paid; and, provided further, that the sheriff, before entering on the duties of collection of taxes, shall execute an additional bond in such sum as the county court of the county may direct. That is, taxes may be paid in two half yearly installments.

The bill of Representative Hillegas concerning attorney's fees provides that in any suit or action brought upon a promissory note, contract or other obligation created either by agreement or statutory provision, wherein the plaintiff is permitted to recover from the defendant his attorney fees, no greater sum shall be allowed in any court, notwithstanding any agreement or stipulation in such contract for a larger sum than as follows: On sums of \$200 or less, 10 per cent of the judgment, including interest but exclusive of costs, exceeding \$200 and not exceeding \$500, 5 per cent; exceeding \$500 and not exceeding \$1000, 3 per cent, and on all sums exceeding \$1000 2 per cent; provided, that on any contract so providing, a fee of \$5 may be allowed, although it exceeds 10 per cent of the amount recovered; and provided further, that in any suit wherein a mortgage or other lien is to be foreclosed, a fee of \$20 may be allowed, although it exceeds 10 per cent of the amount recovered.

A justice of the peace hereafter, or as soon as the new law is approved by the governor, shall require the private prosecutor in a criminal action to give security for costs and disbursements before filing or receiving the complaint therein, in the amount authorized in civil actions, and not otherwise. This law is to be enacted owing to the fact that many irresponsible parties are repeatedly instituting actions on frivolous pretexts, resulting in needless expense to taxpayers.

A bill is before the legislature that will, if enacted, render valid in other counties teacher's certificates issued in any given county. In the large counties of Eastern Oregon such a law would afford much relief to teachers, some of whom have to travel many miles to examinations. Cases have been known where teachers have had to travel 150 miles in a storm and be out for expenses a month's salary in order to obtain a certificate for a three-months' term.

An exchange has the following sensible advice: The country has been temporizing with chronic growers long enough. Jay Gould's estate was appraised at \$100,000,000. The editor of the GLOBE is astonished at one man accumulating that amount of wealth. Let us do a little figuring. One man can live without work on the interest on \$5,000, hence Mr. Gould's property was sufficient to support without labor 16,000 men and their families. There is nothing right or just in it; but how it can be prevented is more than the GLOBE is able to state in this week's issue.

Much has been written in the newspapers of Oregon for and against state taxation to support special high schools here and there. The weight of argument is heavy against the system. The state does its full duty when it supports the common schools. Higher education, special education, the state ought never to be called on to pay for.

An eminent physician says: "One very big reason why country girls grow old faster than city ones, despite all their advantages, is because they are so much more in the habit of washing the face with cold water. Police Judge Campbell of San Francisco who, by the way, is an ex-Eugenite, has sent to the California legislature a bill providing for a whipping post for wife beaters. The Oregon solons should pass a similar enactment.—Guard.

The grand jury system is a relic of barbarism and as repugnant to American law as it is to liberty and justice. It is despotic humbuggery, it entails unnecessary expense upon the tax payers without any beneficial returns.—Ex.

The Oregon legislature has just passed a law raising the age of consent for girls from 16 to 18 years. A bill has also been introduced, and ought to become a law, compelling divorced people to remain single for three years.

**STATE EDUCATION.**

A few years ago, in response to the importunities of a certain class of "educators" and persons moved by local interests, the legislature of Oregon foolishly permitted several so-called normal schools to advertise themselves as state institutions. It was urged that it would cost the state nothing, and that, by making them state institutions in name, it would give them a standing that would materially benefit them, enable them to improve, attract pupils and generally promote the work of education. Despite the warnings of those with prescience enough to see the outcome, that it would be but a short time before a state school would piteously plead for state aid, and later imperiously demand it, the legislature yielded to the importunities and bestowed the state's name upon the schools.

Other schools then demanded equal recognition and received it. Solemn promises made on the floors of the house and senate have been violated, as predicted, and the state has been constantly impudently for money to aid these schools. Now this money is demanded as a right, and all who oppose the giving of it are branded as the enemies of education and as opposed to free schools for the common people; yet the very effort to maintain these alleged free schools for the common people is one of the reasons why the schools where the common people, in fact, have their only chance to secure an education are not today giving them as full an opportunity as they should have.

The whole theory of our schools is wrong. We are spending the major part of public money upon the minority of pupils. While public money is being appropriated to maintain state universities, agricultural colleges and normal schools, whose benefits are received only by a favored few, thousands of the children of the common people are denied the opportunity to attend any school whatever. Even in Portland money is expended upon an ornamental roof that would better be applied to the foundation and walls of the educational structure. The small per cent of children who can attend the high school are having money lavished upon them that should be used to improve the lower grades, where the multitude receive their only education.

In the state at large it is preposterous that thousands of dollars of public money should be given annually to alleged state schools, where the benefits reach an infinitely small proportion of the youth of the state, and thousands of children should be denied an opportunity to attend any school whatever. If state money is to be appropriated for school purposes, let it be given to the common schools, where the duty of the state to give its youth a common-school education is not now fully performed.

It is said that of the 153 clerks at Salem 111 are employed by the senate and 42 by the house. Just what work thirty senators can find for 111 clerks is the one thing that no one seems to know.—Chronicle.

As the people along the seacoast of China are said to be beginning to use Pacific Coast flour to the displacement of rice, there promises to be a big market for the farmer and his wheat by and by.

There are men in our legislature who are shouting "economy," refusing to take a paper or two, and then hiring clerks for committees who have nothing to do but draw their pay.—Salem Post.

The deadlock still continues at Salem. If there is a man in the state who does not now think that United States senators should be elected by the people, let him stand up and be counted.

The law compelling the payment of fees in advance has put a stop to much senseless and expensive litigation, and is proving a boon to the taxpayers in that respect alone.

About the only bill the majority of the representatives will succeed in getting through at Salem this winter will be their board bill.

The Oregon legislature costs the people \$3 a minute and they are now paying dearly for the election of a U. S. senator.

The deadlock in the Washington legislature is broken at last and John L. Wilson was elected U. S. senator.

It is now estimated that the revenue from the income tax will amount to \$50,000,000 per year.

A bill is before the legislature to prohibit the sale of cigarettes in the state. It should pass.
