The legislature closes next Friday, 22d. Rev. E. Corran will preach at Lexington next Sunday.

Miss Clara Lamberson left today for a visit with her sister, Mrs. Frank Palmer at Arlington.

Fine granulated sugar is selling at Eugene and other valley towns at the rate of 21 and 22 lbs for \$1.

W. L. Barker and family, who resided in town since last fall, moved this week to their ranch on Matney Flat.

Peter Snyder, a young man who is in the employ of B. F. Tennis of Eightmile, was in town Saturday on business.

Rev. F. Parrish of Castle Rock preached at Condon Monday evening to a large congregation. He left for home Tuesday.

The GLOBE comes out a little earlier this week than usual, owing to the editor expecting to be absent from town a day or two.

The legislature seems powerless to elect a senator. If the job were turned over to the people it would be done in a single day.

Senator Huston's homestead exemption bill, which passed Thursday, places the value of exemption at \$1000 instead of \$1500 as now.

Thos. Morgan of Mayville is teaching a short term of school on Matney Flat, commencing Monday last. Tom is an excellent teacher.

Barr & Stephenson had a "hog-killin'" in town on Monday, and butchered a number of fine porkers which they fattened for the market.

The total number in the insane asylum at Salem is 1001. This is the first time in the history of the institution that this number has been reached.

Phil Heppner of Arlington and Bill Snell of Olex attended the K. of P. lodge at Condon Tuesday night. Both are members of the Arlington lodge.

The Northwest Fire & Marine Insurance Co. of Portland has "gone bluey." It turned its toes to the daisies and died a violent death this week of starvation.

Deer are very plentiful in this section this spring. G. Schilling informs us that five were seen in a bunch several times this week near his place on Matney Flat.

Rev. John Davis of Olney, Wash., a disciple of the Latter Day Saint church, arrived here Saturday and has preached every evening since. He is the guest of W. A. Goodwin.

Wayne Grider and Horace Stricklin, two young men who worked in this section last summer, arrived here this week from their homes in the valley and expect to remain here until fall.

From reports, a tremendous crowd will attend the K. of P. invitation ball at Condon next Friday night, 22d. A grand time is assured for all who attend. The hall is the largest and best in the county and no one who enjoys dancing and a good time can afford to miss this rare treat.

Ignorance of the laws excuses no one from violating them. For that reason all laws should be published in the newspapers, at the state's expense. Why not do away with that abominable farce—the state militia, and a score of those useless commissions, appropriations, etc., and use a portion of that money in advertising the laws—which would do the people some good? The public has a right to demand such a law.

The coldest and most terrific storm that has visited the United States for 20 years has been raging in the country east of the Rockies for the last week. Snow fell in Florida for the first time on record. The orange trees are killed and the damage is immense. On this side of the mountains the weather is also colder than usual, but is a paradise compared with the country east of that, where it ranges from 30 to 50 degrees below zero.

The amount of railroad indemnity lands in Wasco, Sherman and Gilliam counties thrown open to settlement under the ruling of U. S. land commissioner, Dec. 12th, which ruling is now made public, amounts to 174,557 acres, and as these were tracts selected by the railroad company in 1885, most of them are first-class farming lands. They are open to settlement under the homestead act. Most of the land is very fertile, and will be soon crowded with homesteaders.

The fortieth and last day of the legislative session occurs on the 22d inst—Washington's birthday. If, on the latter account, final adjournment is taken on the 21st, as is probable, and both houses take the usual breathing spell from next Saturday until the Monday noon following, but eight and one-half working days will be left to dispose of the 600 bills on the calendar, and wind up the senatorial squabble. The legislature might continue in session longer, but its pay would cease.

Some of our exchanges give it as their opinion, that no senator will be elected at the present session of our state legislature. We think differently. The opposition should, and no doubt will see ultimately, that they can unite on no one. Until this fact becomes so plain that even an average legislator can understand it, things are apt to remain as they are. But when it finally dawns upon the opposition that their efforts are utterly futile, how can they, as sane men, do otherwise than yield?

Supt. Kennedy, assisted by Misses Bird Downing and Bessie Fitzwater, is conducting the regular quarterly examination at Condon this week. Seven applicants are being examined—Misses Emma and Blanche Edwards of Mayville, Stella Johnson, Nettie Schilling, Pearl Fitzwater of Condon, Mand Hayes of Schuttler Flat, and Mr. John M. Flaughter of Bockhorn. The Misses Edwards recently came up from their home at Eugene. One is a sister and the other a niece of W. J. Edwards of Mayville.

The doctors who took charge of the Italian who shot a fellow countryman at Portland last week, and then fired two shots into his own stomach, have done some very neat work on him. An examination disclosed that the intestines were perforated in several places, and that heroic measures would have to be adopted if the man was to be given a chance for his life. So they cut him open for a foot or two, removed five feet of the intestines and brought the ends of what was left together, fastening them with a Murphy button—whatever that is—and the patient seems to be doing as well as if his running gears had not been touched. Remarkable progress has been made in surgery within the last few years.

ABOUT PNEUMONIA.

The Cause and Prevention of a Common and Deadly Disease.

Dr. Cyrus Edson, Commissioner of Health for the state and city of New York, in a letter to the public gives some information and makes some suggestions in respect to pneumonia and its prevention. He says that pneumonia is probably an earth germ disease, and that in cold weather the germs make their way to the unfrozen ground beneath houses. Thus houses become their route of escape from earth to air, and thus all houses ought to be well ventilated.

Dr. Edson of course points out those well known but little heeded truths in respect to over-fatigue, irregular eating and sleeping and lack of open-air exercise. If a man is strong, if he eats at given hours, if he gets all the sleep he needs, if he walks or rides in the open air, he can generally throw it off again. All the doctors say this and say it pretty often, considering that they do so for nothing.

However, there are people who won't listen to their physicians, and they suffer sometimes. Dr. Edson gives these people a lot of very important advice. He says that when an adult is seized with a sudden chill, the chill, which is the beginning of pneumonia, ten grains of quinine in one dose should be taken immediately, followed at once by five drops of camphor in water or on a lump of sugar. The feet should be soaked in hot water, the body being wrapped in a blanket. "Then," says he, "jump into bed." The body will perspire, being yet wrapped in the blanket, and "a prospective case of pneumonia may be nipped in the bud."

In this climate, where sudden and violent changes occur, warm under and outer clothing and stout, dry shoes are, according to the doctors, absolutely necessary in early winter. The day may be pleasant, but death frequently lurks in the bracing, deceptive north wind.
