All who can dance, even a little bit, were well satisfied with the music, and the fine supper furnished at Maddock's hotel and Smith's restaurant was also a pleasing feature of the occasion.

Sheriff Geo. C. Sears and State Senator Henry McGinn had a very spirited and vigorous "argument" on the streets of Portland Tuesday, each of them knocking the other down several times.

The row originated out of a law just passed by the legislature, which decreases Sheriff Sears' emoluments several thousand dollars a year, the bill for which was amended by Senator McGinn.

It will be interesting news to some to learn that Cooke Bros. have struck plenty of good water at a depth of 50 feet, on their excellent ranch three miles east of town. Heretofore it was thought a useless task to try to get water on such high prairie land. All that is necessary is to dig for it anywhere. Muscle and energy will do wonders. Try the experiment.

A bill which passed the legislature last week in regard to creating two more judicial districts provides as follows: Sixth district, composed of Umatilla and Morrow counties, James A. Fee, judge. Eighth district, Baker, Union and Wallaw counties, a judge to be appointed by the governor. Ninth district, Grant, Malheur and Harney counties, Morton D. Clifford, judge.

The question was asked at the recent examination at Condon who was the first governor of Oregon, and the answer could not be given. The first governor and only governor of the provisional government was George Abernethy, 1845 to 1849. The first territorial governor was General Joseph Lane, appointed by President Polk, and assumed office March 3, 1849. The first state governor was John Whitaker, 1859. George L. Curry was appointed governor in 1853.

All the new county schemes were "knocked into a cocked hat" by this legislature, as were also about all of the usual appropriations for graded and state schools, which is very proper. The scheme to annex a portion of Grant county onto Gilliam failed to connect, and it is probably well that it was not annexed, as the people from the Wagner country would find themselves so far from the county seat that about the next thing we would hear would be a howl for a division of the county.

The long agony is over, the legislature has adjourned, and ex-Secretary of State George W. McBride is elected United States senator to succeed Hon. J. N. Dolph. His election took place at 7 minutes before 12 o'clock Saturday night—only 7 minutes before the session adjourned, and was the 60th ballot of the session. McBride received the full republican vote of the legislature—72 votes.

The new senator is a full cousin of Thos. H. McBride, deceased, who was formerly in the merchandise business at Condon. A number of our citizens met in the hall Saturday evening and nominated the following ticket for the city election, which will be held on March 5th: For Mayor—S. B. Barker; for councilmen—Al Henshaw, J. H. Downing, J. W. Barr, E. E. Smith, Chas. Fix, E. W. Moore, W. A. Darling and Wm. Dunlap; for treasurer—Ed Dunn and J. R. Clark; for recorder—G. W. Rinehart and Dr. Hogan. The doctor declines to accept the nomination, however. Ballots for the election will be printed at this office tomorrow.

The Clerk's Office.

CONDON, OR., Feb. 27, 1895.

EDITOR GLOBE:—Trusting that you will kindly allow me space in your columns, I desire to say a few words relative to the much discussed "clerk's office." I very much dislike newspaper notoriety, yet, owing to the criticisms indulged in by some relative to the conduct and needs of the office, compels me to say this much:

Many of our people have no opportunity to inform themselves on some matters of public interest and are compelled to depend on "hearsay" for their information, which is often incorrect and misleading. Much has been said by certain ones in censuring our county court for employing a deputy clerk at the expense of the county, and lauding the county court of Morrow county for its forethought and good judgment in refusing to employ a deputy, etc. Now what are the facts in this matter? I will answer:

On page 164 of the Session Laws of 1893 will be found a list of salaries allowed county clerks of this state, in which we find the salary of the clerk of Gilliam county fixed at \$1500 per year, and the clerk of Morrow county at \$2400 per year. Now, the county court of Morrow county justly concluded that the salary of \$2400 would justify the clerk in employing his own help, and the county court of Gilliam county simply did as the representatives of this county expected it to do—and employed a necessary deputy for the clerk, fixing the salaries of clerk and deputy combined at \$2400 per year, being the same as Morrow county pays for its clerk alone.

Some have asserted that the clerk of Morrow county does all of his work alone, which is not the case. He has one regular deputy and a special deputy also much of the time. There is little difference in the amount of work required in said counties. Most persons, without much experience about that office, have a very faint idea of the amount and variety of work to be done, in fact no one without experience in the office knows of anything like the amount required. Many overlook the item of correspondence, (which is "thank you work") and it requires on an average 2 1/2 of one man's time to search the records and make the necessary replies.

Without boasting, I will say that at this time I can do more work in the office than any person in the county, and I know by practical experience that I can't do much more than half of the required work. The county court has a fair idea of the necessity for the employment of a deputy and they have been heard from. Official figures show that this county gained money under the present salary system in the clerk's office, over the corresponding 6 months of the previous year. I compiled from official records the figures on which the present salary was fixed by the legislature, and by fixing it at \$1500, it was thought to be right and very reasonable. Surely no responsible man will give a bond of \$10,000 and assume the responsibilities of the office for less.

Now, as to the "perquisites" and "outside fees," etc., that you hear of. They will not reach \$250 per annum for this current year—hardly enough to pay the discount I have to lose on my county warrants, that I receive for my pay. Besides, outside fees are divided with the county anyway, and do not all go into the pocket of the clerk.

Whenever any man says he can run this office without a deputy, "except what little time he would need one during circuit court," he knows nothing whatever of what he is talking about. What would he do from September to March when there is always more work than 2 men can do?

If some people would take the trouble to inform themselves first and then talk, so many would not be misled by mis-statements. Very truly, JAY P. LUCAS, County Clerk.

Death of Mrs. Ed. F. Horn.

CONDON, OR., Feb. 27, 1895.

Mrs. Elizabeth Horn, beloved wife of Edward F. Horn of Condon, died on Saturday evening, Feb. 23, 1895, at about 8 o'clock, after a short illness. She was well and in excellent spirits on Thursday previous, and seemed lively and gay as usual on that day when Miss Frankie Parsons visited her at her home. We learn that she was troubled with Bright's disease, which with other complications brought on her illness suddenly, and that there was almost no hope when Dr. Howard got there. Dr. Houck of Mitchell was also summoned to consult in the case, and in spite of all that medical aid could do, she lived but two days after taking sick.

The body, followed by numerous relatives and sorrowing friends, was borne to Fossil, a distance of 20 miles, arriving Sunday evening late. It was placed in the Methodist church under the constant vigil of members of the Masonic lodge of Fossil, of which order the bereaved husband is an honored member, till 11 a. m. on Monday. At this hour a large crowd of people than the M. E. church would hold gathered to pay their last sad rites to the memory of the deceased, who was loved and respected most by those who knew her best. The ceremonies in the church were conducted by Rev. Zellers, and his address was a very beautiful and affecting one. Taking as a text the words of Paul, "To die is gain," he depicted beautifully the Christian's hope that takes away the sting of death, and personalized the bereft husband and three brothers of the deceased present that the dear wife and sister was not in spirit dead but only gone before to that spirit world where all is joy and peace.

"And from heaven of heavens above God speaketh with lateness breath: My angel of perfect love Is the angel men call death."

After the ceremony the body was followed to the grave in the Masonic cemetery by a large funeral procession as ever assembled in this vicinity. After the Masonic pall bearers, next came the Odd Fellows in a body, that order also testifying their esteem and sympathy for the bereaved husband and their brother Odd Fellow.

Lizzie Horn, the deceased, first saw the light of day in the beautiful valley of Looking Glass, Douglas county, on April 20, 1865. She was married to Ed. Horn, on November 10, 1892, at her old home in Douglas county. Besides her very devoted husband, she leaves her aged father, three sisters and seven brothers to mourn her untimely loss. Her sisters are Sarah J. Spangh, Mary Churchill and Julia Spaur, of Douglas county, and her brothers are, James, David and Ulysses Morgan of Douglas county; Ed, Thos. and Will Morgan of Gilliam county, and Harve Morgan of San Francisco.

A very tender chord of sympathy has been touched in this community by the death of Lizzie Horn, who was a very affectionate and dutiful wife, and whose amiableness had won her many endearing friends wherever she lived, who will ever cherish a fond memory of her. To all these relatives and friends now in their severe hours of affliction, we extend our heart-felt sympathy, and admonish them that while the body of their departed one is dead, the spirit lives:

"For there is no death; the stars go down To shine on a fairer shore, And bright in heaven's jeweled crown They shine forever more."
