T. R. Lyons, the popular attorney of Heppner, made a flying business trip to Condon the first of this week, returning today. He expects to return here in about ten days and remain until after circuit court, which convenes here on April 8th.

The worst storm experienced here for several years blew nearly all day yesterday. It is hoped the result will be some rain, as the country is needing it badly. Snow began falling about noon and this morning the earth is covered with about three inches of "the beautiful."

Frank Clark began this week to learn the harnessmaking business with Gene Smith, taking the place of Geo. Caven, who has given up the job. Frank is very quick to learn and will pick up the business very rapidly. Gene has just received a large stock of new saddlery, harness, etc. Call and see it.

Albert Smith, the young man who has been carrying the mail between Condon and Lone Rock all winter, has quit that job and is now learning the blacksmithing business under the instruction of our first-class and leading blacksmith, G. S. Clark. Albert is a willing hand and will make a good mechanic.

Up in Spokane county the farmers kill ground-squirrels with giant powder. They do not use it to blow them up, but soak a little of the powder in kerosene, wrap it in paper, put it in the holes and set fire to it. The gases generated penetrate to the utmost limits of the recesses and scoop everything they reach.

Since the last issue, the Globe man visited relatives at Fossil and Antelope, leaving here Thursday of last week and returning home Tuesday of this week. Our mother-in-law, Mrs. E. Meek, accompanied us as far as Fossil on the way, where she visited her daughter, J. H. Putnam, several days.

Mr. and Mrs. Henry Panning's little son, Karl Emmet Panning, aged ten weeks, died at their home at Home Park, Montana, on Feb. 2d. It seems that many have been congratulating themselves too soon upon the passage of the Ellis bill by congress. The railroad lands are still in the same condition they were before that bill passed, and actual residence will, as heretofore, be required on the forfeited railroad lands. The reason of this is that President Cleveland did not sign the bill, though it passed both houses.

Nearly 300 people attended the auction sale of the personal property of the late J. A. Spaulding Saturday. The "old reliable" C. D. Sennett of Rock creek was auctioneer and everything sold at remarkably good figures. The gross receipts of the sale amounted to \$725. Mr. Sennett understands his business so well that often he had a bidder bidding against himself.

We are sorry to announce that Mr. Henry Billing, who resides with his aged wife three miles south of town, has been very poorly for several weeks with heart trouble. It is very unfortunate for them both, as they are very poor and no one to wait on him but his faithful old wife, who has also all of the other work to look after. Verily it is a merciless and unsympathetic world generally when help is most needed.

Died—At the farm home of his mother, in Polk county, Monday evening, March 19, 1895, of quick consumption, Otis Putnam, aged 24 years. Deceased was a brother of State Librarian Jas. B. Putnam. He was injured internally last fall and had been in poor health ever since. The funeral was held at the family home, 2½ miles west of Salem, on Wednesday afternoon at 2 o'clock and the interment took place at the neighboring cemetery.—Salem Journal.

Rev. Curran, Congregational minister from Condon, has agreed to preach at the Lone school house once a month. Last Sunday being the regular Sunday of his appointment, he preached an excellent sermon after Sunday school at about 3 o'clock. The school house, as usual, was well filled. Rev. Curran though comparatively a young man, is about as enthusiastic a young minister as we have ever met, and his discourse was well received.—Heppner Gazette.

The revival meetings conducted here this week by Revs. Zellers and Curran are largely attended each evening and much interest is being taken in them. Both these gentlemen are earnest and energetic in their cause and are doing much good wherever they preach. Mr. Zellers will preach here every evening this week and also next Sunday, morning and evening. He requests us to announce that he is obliged to withdraw his announcement for holding services at Mayville next Sunday, but will preach there the Sunday following, on March 31st. Mr. Curran will preach at Fossil next Sunday, morning and evening.

The Hotel de Wilcox (county jail) has two guests again, the first occupants of that institution since the last term of circuit court. As will be seen in the Arlington correspondence, "Wild Bill" Radzom of Olex was arrested and bound over to the grand jury on a charge of larceny; also he and Mrs. Wilkins were arrested and bound over on a charge of lewd cohabitation (living together as man and wife without marriage). There are other cases of a similar nature not a thousand miles from here that might be investigated. It will be remembered that Mr. Radzom 18 months ago recovered \$800 damages in circuit court from A. Liebl for malicious prosecution.

C. I. Winnek, a merchant, formerly of Antelope but for the last four years of Moscow, Idaho, arrived here the first of the week on rather extraordinary business. It appears that Atty. Geo. W. Goode, formerly of Condon, but for the last 18 months a resident of Moscow, has been practicing his usual and old-time trickery and crookedness upon his clients at Moscow. His conduct becoming so unprofessional and unbearable that "patience ceased to be a virtue," the attorneys and business men of that place are making an effort to disbar him from practicing law any longer in that state. Having learned that Mr. Goode's reputation as an attorney while at Condon was not of the best, they employed Mr. Winnek to come down here for the purpose of securing additional information in the way of affidavits from parties who had dealings with him professionally that would aid in his disbarment. Mr. Winnek informs us that he is getting plenty of just the kind of information he is after, and it is very probable that we will soon learn that George Washington Goode can no longer practice law in Idaho. Before leaving Oregon Mr. Winnek will visit Arlington, Blackfoot, The Dalles and Heppner on the same mission.

Several thousand head of sheep added their voices to the music of the town last Friday and Saturday.

We are pleased to report that J. W. Smith, who is sojourning in California for his health, is improving and expects to return home soon.

There was a social at the residence of Rev. Strong last Wednesday evening, the occasion being the presentation of a nice new dress by the ladies to Mrs. Strong.

Ross Beardsley is intending to start this week on a visit to his relatives in Michigan. He expects to be gone but a short time. We hope he may have a pleasant trip and a safe return.

E. W. Hatch and family have moved into the house owned by John Cunningham, near the stable and has taken charge of the Cunningham barn. Frank Munkers will move out to his ranch.

Spoiled Children.

D. W. Aldridge, formerly editor of the Pineville Review, has the following letter in a recent issue of the Review, which contains much sound sense:

Most people dislike to see a really spoiled child. And such progeny are usually viewed with pity as with disgust—pity for the offspring's very uncertain future, and disgust at its actions in public, the cause of which is only a lack of the proper exercise of parental authority. We have all seen a naturally persistent child onto a naturally indulgent parent, and in the presence of select company, too; and we knew well enough at the time where the fault lay. We knew that the over-indulgence was practiced in the family circle, and that the child, being not a respecter of persons, would naturally insist upon making public the privileges allowed it in the private sanctuary called home.

Is it not frequently the case that the mature man or woman is only a grown-up child? And a badly spoiled one, too? I am inclined to think so. I believe this to be especially true in a political sense. The reader is well aware of the fact that the office actually seeks the man; that is to say, the people, who are sole owners of the office, will place its care and keeping into the hands of one of their number who has never asked for it—perhaps who never expected it, or thought of asking for it. No sooner does the term of the incumbent thus chosen expire than he begins to devise methods and lay plans for re-election, or, it may be, for an official position a little higher and with better pay than the one he has occupied. And does not his action in this respect plainly indicate that he begins to feel his importance—that he is already partially spoiled? At his own earnest solicitation this time he is re-elected to the same office, or perhaps to a higher one, only to repeat himself at the close of this, his second official term; and so on without thought of settled limitation. Then, not unlike the spoiled child, if the people, whose servant he is, see fit to relegate him to private life—to the old position he once occupied so contentedly—he at once becomes filled with uncomplimentary epithets, to which he does not hesitate to give utterance, and, in vulgar parlance, gets "mad as thunder." And little wonder. He has been, as it were, petted, flattered, given what he wanted, allowed to have his own way and to be his own dictator so long that, like an indulged child, he only submits under the londest of protests.

Now, there are, of course, exceptions to this rule—enough, perhaps, to prove its correctness. As the reader evidently knows, Crook county, like every other county in the state, can furnish its proportional share of men who have been spoiled in the manner given. And this fact is mentioned without any thought of being personal. I do not know of one Crook county officer who is not my personal friend. But I believe that it is wrong to spoil children of immature and mature and I cannot, meantime, see a clear way to blame the child from the parent. We are creatures of education. If the associating tendencies of a good and wholesome education be good and wholesome, it may be said that the time will come when a man will become a candidate for office only when he answers an unusual demand from his constituents.
